Dear Governor Haley,

We are deeply disappointed by your action in signing the voter suppression law today. This new law is a giant step backwards for voters' rights. By requiring eligible citizens to present government-issued, current and valid photo identification at the polling place in order to exercise their constitutional right to vote.

This new government program is a prime example of wasteful use of taxpayers' money on a new program that will cost citizens of South Carolina millions of dollars to implement a new bureaucracy – all in an effort to "fix" a problem that doesn't exist.

In addition to the costs of supplying free IDs to voters there are other significant costs that need to be addressed such as additional poll worker training, public education campaigns, defending against lawsuits, printing and mailing additional absentee ballots. County and local governments will need more funds in order to stay open longer and accommodate voters who need to secure a photo ID. When you take all of these factors into consideration the fiscal impact quickly increases.

Besides the extraordinary cost, this new government program could disenfranchise tens of thousands of registered voters without a valid photo ID due to disability, age, illness, transportation, or financial issues. Our state government should be in the business of making it easier for citizens to vote, not adding costly restrictions and hassles that will negatively impact voters. The League of Women Voters of South Carolina and their voter rights partners will continue to explore all options at their disposal to ensure that all eligible voters can vote and have their votes counted.
