The LWVCC hosted a forum for state legislative candidates on Sunday, October 29, 2006 at the new Thoreau School auditorium. The speakers were State Senator Susan Fargo, her challenger Sandi Martinez, and State Representative Cory Atkins, who is running unopposed. JoAnn Berry from the Acton LWV moderated.

All of the candidates made statements of their choosing. Senator Fargo and Ms. Martinez answered questions posed by the moderator, some from the League and some from the audience.

CARLISLE REPORT

A Special Town Meeting was held in Carlisle on Monday October 30, 2006 at 7:00 PM in the Corey Auditorium at the Carlisle Public School. Over 300 Carlisle voters were in attendance. Some minor zoning and site plan bylaw changes were passed by voice votes.

The Recreation Commission presented a revised phase 2 plan for ball field expansion on the Banta Davis Land. The plan was a modification of the plan that passed at Annual Town Meeting but failed as one article at the polls by 11 votes in the spring of 2006. The new plan was divided into two articles. Article 1 (estimated to cost \$1.2 million) included three new ball fields (2 little league fields and 1 all-purpose field), four tennis courts, conversion of two old tennis courts to 2 outdoor basket ball courts. a second parking lot, improved traffic flow, paved ADA compliant pathways throughout the complex, a 2.5 mile cross country running course connecting the School to Spalding Field and on and around the Banta Davis land, a covered picnic pavilion and site drainage and irrigation infrastructure. Article 2 consisted of a plan to install artificial field turf on the new all-purpose field at an estimated cost of \$500,000. Article 1 failed by 2 votes. Article 2 was not moved due to the failure of Article 1.

The Benfield Land committee presented a revised plan for the placement of 26 units of affordable housing to the front of the Benfield property which was purchased using CPA funds. The relocation of the buildings was necessary due to the sighting of an endangered blue spotted salamander on the property and the subsequent results of a study showing their habitat to be in the middle of the parcel of land that had been designated for the affordable housing project. After much discussion the Benfield article passed decisively.

In addition to the State Election there is a local election on November 7, 2006 in Carlisle. The local election consists of

Question 1 to override proposition 2 1/2 for the ball field expansion project on the Banta Davis land and Question 2 to override proposition 2 1/2 for artificial field turf installation on the all purpose field in the ball field expansion project. If Question 1 passes affirmatively by a majority vote at the polls it is possible that another special town meeting could be called by the Board of Selectmen or by citizen petition to try and get the 2/3 town meeting approval necessary to move the Recreation project forward to the bid and build phases.
