## **ADVOCACY CORPS REPORT (pages 3-6)**

### **CITIZEN ADVOCACY**

**Linda Barnett, Advocacy Corps Chairperson**

The League's Advocacy Corps (AC) provides an opportunity for League members to closely monitor the actions of our General Assembly. However, understandably, participating actively in the AC requires a level of commitment and time that is not available to all members of the League.

Fortunately, there is another avenue for involvement in public policy – namely, making the commitment to be a **citizen advocate**. Indeed, the hope is that all League members will regard themselves as citizen advocates and take part in influencing public policy.

This is in accordance with one of the key missions of the League: to encourage informed and active participation in government.

We are guided by words of Supreme Court Justice Louis Brandies, who served in the early 20<sup>th</sup> Century:

**"The only title in our democracy superior to that of President is the title of citizen."**

One key way members can serve as citizen advocates is to watch for Action Alerts and use them as the basis to contact their State Senator and/or Representative. These alerts will contain a description of the particular policy matter being addressed and often include a suggested message/email draft to use as the basis when contacting one's legislator.

However, the alerts sometimes will call upon League members to craft their own message, which can typically make a greater impact on legislators than if they receive essentially the same message from every League member who contacts them.

In addition, the AC is in the process of developing a series of videos that will provide background information about Delaware's government and include tips on how to participate in public policy making. The videos already available can be found on the League's You Tube channel at this link:

## **Top Priority Pending Legislation in the 151<sup>st</sup> General Assembly**

The following bills are among those being tracked by the League’s Advocacy Corps (AC). There are additional bills that the AC either supports or opposes, but the ones below, all of which we support, are of particular significance.

- **HB 75** - would eliminate from the Delaware Constitution the limitations as to when an individual may vote by absentee ballot. It shifts to the General Assembly responsibility for enacting laws to specify the circumstances, rules, and procedures for absentee voting.
- **HB 140** - would permit a terminally ill adult to request and self-administer medication to end the individual's life in a humane and dignified manner if both the individual's attending physician or attending advanced practice registered nurse (APRN) and a consulting physician or consulting APRN agree on the individual's diagnosis and prognosis and believe (1) the individual has decision-making capacity, (2) is making an informed decision, and (3) is acting voluntarily.
- **HB 205** - would establish the *Delaware Expanding Access for Retirement and Necessary Saving (“EARNs”)* program, a voluntary State-facilitated retirement savings program. It targets small businesses unable to offer retirement plans to employees due to the cost and administrative burden.
- **HB 300** – would establish mental health services units in middle schools which would be staffed by a school counselor, school social worker, or licensed clinical social worker. Additionally schools with sufficient students would also have a full-time school psychologist.
- **SS 2 for SB 1** - would establish a statewide paid family and medical leave insurance program whereby employees can access up to 12 weeks of paid family and medical leave for one of the following: (1) To address a worker's own serious health condition. (2) To care for a family member with a serious health condition. (3) To bond and care for a new child. (4) To address the impact of a family member's military deployment. The wage tax mechanism would be used for employees and employers to pay into the fund at each pay cycle.
- **SS 1 for SB 149** – would ensure that the public has access to all serious and substantiated records of law-enforcement misconduct; affirms that such records are public records; specifies that the only materials released will relate to disciplinary issues, not personal information. Enables the creation and operation of community review boards at the State, county, and municipal level.
- **SS 1 for SB 187** - would make it easier and more convenient to own an electric vehicle by requiring municipalities with a population of 30,000 or more to develop a procedure to obtain permission for the installation of an electric vehicle charging station on real property zoned for residential use that abuts a residential street.
- **SB 231** - would prohibit the use of gender, gender identity, or sex as a rating factor in personal automobile insurance policies.

## CLIMATE CHANGE/ ENERGY

Charlie Garlow and Peggy Schultz

Governor Carney agreed in March to adopt the California Zero Emission Vehicle (ZEV) program in DE. This means that DE will get more electric vehicles sold in our state. Our own Peggy Schultz was invited to the signing, showing the clout that the League has on this topic.

This is also a terrific Environmental victory.



## NATURAL RESOURCES/ENVIRONMENT

- The biggest news/victory on the environmental front was the passage and signature by the Governor of the Clean Water Act (HB200) in July 2021.
- A second victory for the environment was the passage of HB212, which was signed in September 2021. It expands the ban on flimsy plastic bags to all stores.
- A third victory was passage of SB 24 which was signed by the Governor, which makes releasing helium balloons a littering offense. No more balloon releases.
- SB 22 was signed into law in 2021 and will take effect in July 2022. It forbids the sale or installation of non native invasive plants, trees or shrubs.
- A campaign for the future is the passage of SB140, Senator Paradee's bill to ban Styrofoam and plastic single use containers, cups, utensils.

## GOVERNMENT, FINANCE AND TAXES

The GFT Portfolio continues to monitor bills before the General Assembly, to work with the University of Delaware on developing a model independent redistricting commission (IRC), and to study proposals for government reform...

Bills of Interest: H.B 109 proposes the first leg of a Constitutional Amendment reflecting the recommendations of the Advisory Panel to the Delaware Economic and Financial Advisory Council (DEFAC) to move the Budget Reserve Account into a newly defined Budget Stabilization Fund; HB 205, as amended, initiated by the State Treasurer proposes the creation of state sponsored employee retirement saving plans ( EARNs Act); HB 293, as amended, providing for public comment periods during all public hearings (The General Assembly has its own rules), and ; HB 312 allowing a personal income tax credit of up to \$500 for interest paid on student loans.

Redistricting: The goal of the UD/LWVDE project is to study the ten states with redistricting commissions and then to propose the creation of Delaware's own independent redistricting commission for the 2031 elections, following the 2030 decennial census. The creation of a Delaware commission would require an amendment to Article II, § 2A of the Delaware Constitution.

**GOVERNMENT REFORM:** We are monitoring two proposed government reforms involving:

- 1) The creation of a Public Advocate Office (Maryland and New York are among states with a PA office), and
- 2) The creation of an Independent Inspector General (33 states and D.C. have independent IGs).

This is an excellent opportunity for young Americans to learn about the League and our position on climate change and environmental justice. I am pleased to inform you that Climate Committee members Peggy Schultz and/or Charlie Garlow have agreed to work on this project.

**Powering Democracy Awards.** *And the award goes to...*

Leagues will be recognized with the **Powering Democracy Award** for exemplary work over the past biennium during the 2022 Convention.

What's new? The 2022 Awards will offer **separate subcategories for state and local Leagues**. LWVUS staff will select finalists, and the public will choose winners via polls. All winners will receive a cash prize from LWVUS in recognition of their work. *I say let's go for it. You can't win if you don't try.*

There are three categories open for submissions:

❖ **Powering Democracy Award**

- This category showcases how Leagues activated their grassroots network to empower voters and advocate change around critical issues, such as protecting voting rights or increasing voter registration and turnout.

❖ **Increasing Power Through Partnerships Award**

- This category showcases the work Leagues did in partnership with others and how those partnerships empowered our League work and supported our communities. This can include work in which the League was a lead partner, supporting partner, worked with one partner, or worked in coalition with several partners.

❖ **Innovating Our Power Award**

- This category showcases the way Leagues have had to innovate their work over the past biennium. The catalyst for innovation could be anything from the pandemic to severe voter disenfranchisement to natural disaster or something else that required your League to develop a new way of performing parts or all of your work.

Submissions to each category can be made by members of both state and/or local Leagues. To tell our stories, we need excellent essayists from LWVDE, LWVSC, LWVKC, and LWVNCC. ***Stand Against Racism Challenge.*** League of Women Voters of Delaware has partnered with YWCA Delaware to participate in *The Stand Against Racism Challenge* beginning April 4. The YWCA Delaware, in partnership with YWCA National, developed a virtual learning tool designed to create dedicated time and space to build more effective social justice habits, particularly those dealing with issues of race, power, privilege, and leadership.

League members will download the Stand Against Racism app for their phone or tablet or log on to the challenge website where they are presented with 21 days of impactful challenges such as reading an article, listening to a podcast, reflecting on personal experiences, and more. Participation in an activity such as this helps us to discover how racial and social injustices impact our community, connect with one another, and identify ways to dismantle racism and other forms of discrimination.

**Martin Luther King, Jr. Day and Black History Month.** Black History Month has come to a close, and I want to thank Lori Yadin, Denise Davis, Kathleen Baker, Letty Diswood, and Kim Wells for arranging and organizing the following events for Martin Luther King, Jr. Day and Black History Month.
