★ VOTING REQUIREMENTS ★

Registration – Where and When

1. Board of Elections, 3661 Eisenhower Pkwy., Suite MB101, Macon, GA 31206, Weekdays 8:30 a.m. – 5:30 p.m.
2. All public libraries, Driver's License Bureau, Department of Family and Children Services, Military Recruitment Offices, during hours of operation
3. Online registration at Georgia Secretary of State My Voter Page at www.mvp.sos.ga.gov

Registration is permanent if you:

1. Notify the Board of Elections of a change of address within your county of residency.
2. Notify the Board of Elections if you change your name.

Registration Deadlines

30 days before the date of a Primary and a General Election

Date varies for Special Elections

Qualifications for Registering and Voting

1. A citizen of the United States
2. At least 18 years of age on date of election; 17½ at registration
3. A resident of Georgia and vote in the county where registered
4. No felony conviction — unless rights have been restored
5. Mentally sound

(NOTE: False information on a registration is considered a felony.)

ABSENTEE BALLOTS AND QUALIFICATIONS

Any citizen entitled to cast a ballot who will be:

1. Physically unable to go to the polls.
2. Military personnel outside county/state/country
3. 65 years of age or older

4. There is absolutely “NO” reason required.

You can submit your request for an absentee ballot as much as 78 days before the election. Your request must be made at least 11 days before the election. (Hospital patients have an extra day to apply.) If you miss that deadline, you can still vote in person during early voting or on Election Day.

Some of the above information is subject to change due to pending legislation currently being reviewed by the Georgia General Assembly.

All requests for absentee ballots must include the following:

1. Which election ballot required (if a primary election, request must choose Democrat or Republican ballot in County, State and Federal elections)
2. Name and address as registered
3. Birthdate
4. Address for delivery of ballot
5. Signature of applicant

Any elector who is unexpectedly hospitalized on the day of an election may call the Board of Elections at (478) 621-6622 by noon, and an absentee ballot will be delivered to the elector. This applies only to local hospitals in Macon-Bibb County.

**** EXCEPTION** – Any voter may cast an absentee ballot at the Board of Elections (Monday through Friday) 21 days prior to the election for no reason. **No ballot may be cast on the Monday preceding any election or on Election Day.**

PLEASE NOTE THAT PROOF ACCEPTABLE PHOTO (IDENTIFICATION) IS REQUIRED WHEN VOTING AT GEORGIA PRECINCTS.
