Candidates

US President—Additional information on presidential candidates is available at www.VOTE411.org and is provided by the League of Women Voters Education Fund (LWVEF).

All qualified presidential candidates were invited to provide biographical information and responses to specific questions. Candidates were qualified if they met the following criteria during the primary season:

- 1. The candidate must have made a public announcement of their intention to run for their Party's nomination for President; and,
- 2. The candidate must meet the Presidential Election Campaign Fund Act's minimum contribution threshold requirements for qualifying for matching funds, based on the most recent data publicly available on the FEC website.

US Senator, US Representative to Congress, State Representative, State Central Committee (Republican)— Candidates were invited to participate in the voter guide on VOTE411 by the League of Women Voters of Ohio Education Fund.

Judicial races in Ohio—Judicial Votes Count (www.judicialvotescount.org) contacted the candidates. Their responses are included on VOTE411.

Portage County races—Candidates who filed their intent to run for office with the Board of Elections were sent questions relating to the office they were seeking by the LWV of Kent, as well as instructions on how to complete the candidate questionnaire.

County Central Committee (Republican)—candidates with opposition were invited to participate in the voter guide. The candidates invited by the LWV of Kent were asked to enter their responses on the VOTE411 website in accordance with the following guidelines.

The League of Women Voters of Kent reserves the right not to publish any material determined to be libelous, damaging to a person or group, or offensive in accordance with the League's values and as outlined in its publishing policy. It reserves the right to offer alternative wording to the candidate. The League will not correct spelling, grammar or punctuation. What are your top priorities and how will you address them?

Our natural resources in Ohio, especially our water, drive much-needed revenue, economic growth, tourism, and job creation. As a state legislator, I authored the Great Lakes Compact to protect Ohio's fresh water from being drained away by diversion or wasted by misuse. I also funded the H2Ohio program to improve water quality and infrastructure statewide. In the U.S. Senate, I will continue my work to preserve, protect and promote our environment for future generations, and make sure all Ohioans have access to clean air and clean water. I will also continue my record of protecting the economic value of Ohio's greatest natural asset, water. <u>State your position on voting and elections policy.</u>

The Constitution is clear that the responsibility for managing elections rests with the states. My opponents want to empower the federal government to overturn elections. By contrast, I support states' rights and I have a record of enhancing election integrity and security in Ohio. I support state-initiated Voter ID and upholding the maintenance of accurate voter rolls. I oppose federal laws that loosen or undermine the integrity and strength of state's rights to hold elections.

State your position on immigration policy.

The Biden Administration neglects its duty to keep Americans safe; addressing immigration starts with robust border enforcement. According to Ohio law enforcement, reckless open border policies directly contribute to increased drug and human trafficking in Ohio, with nearly 80% of overdose deaths linked to China-sourced fentanyl. Securing the Southern Border through physical and surveillance barriers and increased Border Patrol personnel is vital. This approach safeguards America's sovereignty and enhances community safety in Ohio.

Congress should follow my lead as a state legislator who designated drug cartels as foreign terrorist organizations and increased efforts against drugs and human trafficking for a safer, more secure nation. State your priorities on foreign policy and national security.

The most important responsibility a US Senator has is to keep the nation and its citizens safe and secure. Unlike my opponents, I have been crystal clear from day one that there should be no daylight between the United States and Israel. My greatest priority is increasing investment in public education and eliminating tax dollars funding private schools. I am also very concerned with attacks on marginalized populations and government involvement in decisions that should be made by individuals and their doctors. The general assembly has continued siphon public dollars to fund private, unaccountable schools when 90% of students in Ohio attend public schools. I will work to end this unconstitutional practice and instead focus on ensuring our public schools have the resources needed to deliver quality education to the vast majority of our students. I will also work to draft policy that protects our most vulnerable students from discrimination.

What changes do you support or oppose to voting and elections policy?

I support expanding access to voting by increasing the number of ballot drop boxes statewide as well as allowing same day voter registration. I oppose the current arbitrary practice of purging voters from the rolls. Ohio has some of the most stringent rules for voting which disenfranchises many and discourages them from voting. Voting is a fundamental constitutional right and laws should make it easier, not more difficult to participate. As a African-American, my ancestors fought and died for the right to vote. It is sad that this continues in the 21st century, however, I intend to continue this fight.

How should government bring economic and job opportunities to Ohio?

Government must first ensure that public education is designed to obtain the necessary skills needed to compete in a global society. This requires more focus on instruction and skill building instead of constant standardized tests that do not measure what students know and are able to do. Government can provide economic incentives to companies who work with public schools to create articulation agreements that provide a pathway to internships and apprenticeships upon graduation. Not all students go to college. It is important

that they know what skills and competencies companies need that will allow a seamless transition into the workforce.

CURTIS:

What are your aspirations for K-12 and higher education?

I would work to ensure the General Assembly honors their commitment to fully fund the Fair School Funding model that is currently being phased in. This is currently the closest Ohio has ever been in addressing funding disparities in public K-12 education. I hope to increase state aide to public and private institutions of high learning. As tuition costs continue to increase, we must work to lessen reliance on student loans.

<u>Under what circumstances should the state support or check local government?</u>

I believe the state has an obligation to honor home rule and allow local control whenever possible. When the rights of it's citizens in infringed upon, I believe government also has a responsibility to act to protect those rights. I believe it was wrong for the government to diminish the role of the State Board of Education and take place control of our Ohio Department of Education under the Governor. This act took away the ability of those who were duly elected to perform their duties. As such, it represents a gross overreach and abuse by the Government.

State your position on healthcare policy.

I believe decisions involving personal healthcare should be made by the individual and their healthcare provider. I believe the Government has no business dictating what anyone does with their body. Voters resounding defeated Issue 1 in the spring and overwhelming supported the measure in the fall. Our elected officials in the statehouse should respect the will of the people, however this is currently not the case. Overriding the Governors veto of HB 68 is just another example of government taking healthcare decisions out of the hands of parents and into the hands of politicians. This is wrong, plain and simple.

State your position on environmental policy and natural resource management?

We must do more to become less reliant on fossil fuels and continue to invest more in renewal energy if we are to survive. Global warming is real and we are seeing the effects everyday. Communities must also continue to recycle to further reduce our carbon footprint. I believe government can and should provide economic incentives to companies who work to transition away from practices that harm the environment. Government should do more to provide tax incentives to those who purchase solar panels or buy electric vehicles. These commitments will extend our life expectancy as well as provide a better life for our children.

What role, if any, should government take to ensure no person is discriminated against?

Government must ensure all institutions foster an environment of inclusion. Currently, there are policies being drafted to discourage and penalize institutions that embrace the practice of diversity, equity, and inclusion. Government has a responsibility to protect ALL of it's citizens from discrimination. When elected officials fail to uphold this responsibility, they must be removed. Gerrymandering has unfortunately allowed discriminatory laws to be passed with little to no accountability. Voters must act to rectify this problem and restore integrity and protect our most vulnerable marginalized populations.

An additional tax for the benefit of the Mogadore Local School District for the purpose of current expenses that the county fiscal officer estimates will collect \$743,000 annually, at a rate not exceeding 5.9 mills for each \$1 of taxable value, which amounts to \$207 for each \$100,000 of the county fiscal officer's appraised value, for 5 years, commencing in 2024, first due in calendar year 2025.

15 Proposed Tax Levy (Replacement) Mantua Shalersville Fire District

A majority affirmative vote is necessary for passage.

A replacement of a tax for the benefit of the Mantua Shalersville Fire District for the purpose of providing and maintaining fire apparatus, mechanical resuscitators, underwater rescue and recovery equipment, or other fire equipment and appliances, buildings and sites therefore, or sources of water supply and materials therefore, for the establishment and maintenance of lines of fire alarm communications, for the payment of firefighting companies or permanent, part time, or volunteer firefighting, emergency medical services, administrative, or communications personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.34 of the Revised Code, for the purchase of ambulance equipment, for the provision of ambulance, paramedic, or other emergency medical services operated by a fire department or firefighting company, or the payment of other related costs that the county auditor estimates will collect \$285,000 annually, at a rate not exceeding 0.9 mill for each \$1 of taxable value, which amounts to \$32 for each \$100,000 of the county auditor's appraised value, for 5 years, commencing in 2024, first due in calendar year 2025.
