Operations Manager Report:

Elizabeth - Redistricting commission has held hearings, the democrats have submitted their Ohio Senate and Ohio Legislature. Once the republicans and commission submit theirs, they will be public and open for feedback. Jane Henderson has been doing a lot of work on it. Encourage people to read the emails, show up to the meetings, enter the map drawing competition — deadline sept 15th.

Committee Reports:

Voter Services: Elizabeth

- Voter guide is going well. Deadline to respond is Friday. About 300 candidates being surveyed. Sept 30th online version will be up. Dispatch version in early Oct. We have a new contact at the Dispatch.
- Have a letter stuffing event to stuff envelops for Franklin County jails. Had 125 people vote last year, up from 0.
- Sept 28th national voter registration day. We are mostly working with other non-profits that serve underserved populations. Have some work with schools.

- Election Day phone bank is on this year. Virtual again. Thinks the phone connection will be better this year.
- Sept 21 fair maps day rally at the state house anyone who can be there should attend.

Development/Democracy in Action: Kitty

• Want to honor Lee Leonard with lifetime achievement award. Also want to honor a factual news organization Gongwer. Please don't share names yet since none of this is confirmed. Still deciding on official coordinator.

Voter Services: Ellen

- Trying to get additional info on the Energy issue. No one knows much about it. Meeting again Sept 13th.
- Volunteer sign up for candidate forums in e-voter. They are masked, in-person events and also live streamed.
- State- wide voter rights groups are paying attention to things happening in places like Texas. There are some sitting in Ohio, but no current action. Trying to make some plans if they do pass and get the word out about them.

Education and Advocacy: Bridget

- Broken into some sub groups- exploring how to work with food advocacy groups in Ohio.
- Jackie spearheading 21 day challenge, it is different from last year, so if you did it last year you will still learn this year.
- Franklin County Public Health reached out to see if we can get involved in vaccine outreach. Thinks it's good to at least see what they're asking us to do.
- Columbus City Council site has sample maps for City of Columbus and you can give feedback.

Membership: Elizabeth

- Nov 9th new member orientation virtually. Committee chairs will all be asked to attend.
- Have been getting fairly steady stream of new members, a lot from redistricting efforts.
- Want to use the data collected from new members in a more useful way instead of just sitting in survey monkey. Have some members in mind that could help with the project.

Communications:

• Have volunteer consultant to give initial feedback on social media. Working with Ohio league on joint budget.

By Laws:
