## Wednesday, October 9th, 2024 California State Ballot Proposition Pros & Cons

t this in-person Lunch & Learn meeting, Marilyn Maxner and Marianne Gawain (both past presidents of our League) will present arguments for and against the ten California State Ballot Propositions for the upcoming November 2024 election. They will provide names of endorsers and major money contributors for each proposition. Local county or city measures will not be discussed.



#### LWVMC MEMBER PROFILE: KATE DANIELS KURZ

ate Daniels Kurz joined our League of Women Voters chapter in 2015, when she was working on Mary Adams' campaign for Monterey County District 5 Supervisor. Now, Kate Daniels, the name she uses professionally, has been elected to replace Mary Adams beginning next January.

Over the years, Kate's schedule has been increasingly busy. When our interview took place, she was working

as **Policy Advisor** to **Senator John Laird** (a position that she has now ended), as well as **Monterey County Planning Commissioner**.

As for her activities with LWVMC, Kate reports, "I've been to some of the committee meetings when they had to do with land use and water, but I've not officially served on any committees." She adds that she tries to attend the League's luncheons whenever she can.

Born on the Monterey Peninsula, Kate grew up in Carmel Highlands—her parents still live in the same house there—and she moved east for college. She



earned her **bachelor's degree** at **Sarah Lawrence College**, where her feminist studies began, and then moved into New York City to

attend graduate school at **Columbia** 

**University**. *"My major was applied linguistics and my graduate thesis was on sexism in language,"* she says.

After graduation, Kate lived in Mexico, New York City and Los Angeles, teaching English as a second language and Spanish. Then, in 2005, she moved back to the Monterey Peninsula, where she worked in international journalism as **Executive Editor** of "*The Women's International Perspective"* and taught in the gender and women's studies program



at **Monterey Peninsula College**. "It was there that I had the opportunity to really engage with students sometimes for the very first time in their lives—about issues concerning women, feminism and gender," she reports. "Politics plays a big part in that course work. It was important for me to be able to participate in that educational experience."

Well before she ran for public office, Kate became active with

the **Democratic Women of Monterey County**. *"Through that, I've been engaged in voter* 

registration activities, campaign work, candidate training, education around critical issues impacting Monterey County residents, as well as state and national



politics. I'm in my second term as a delegate to the **California Democratic Party**. I sit on the rural caucus and there, in particular, I've been working on the housing subcommittee. We've been tackling housing constraints for rural California. It's all about affordable housing. When you're trying to address our lack of affordable housing, there are specific realities that are different from other areas—our lack of infrastructure, wildland urban interface, fire danger, water supply constraints. Our houses are at high risk."

Kate's currently frantic schedule also includes taking time to be with her family. She's married to **Daniel Kurz**, an engineer and the CEO of **Kurz Instruments, Inc.**, who grew up in Carmel Valley. *"We started dating in high school,"* Kate says, *"and then reconnected at our fifteenth high school reunion. We got married and now live in Carmel Valley with our sons."* They're **Daniel Kurz, Jr.**, 14, and **Nicolas Kurz**, 11.

Kate also has an identical twin sister, **Alexandra Edwards**, who still lives locally. *"Many people go* 

up to her and start asking her questions, thinking she's me," Kate says with a chuckle.

Currently, Kate is trying to let go of some of her responsibilities in preparation for taking office as



Supervisor, which is why she left her work for Senator Laird at the end of the summer. However, she says, *"I'll still be* on the Planning

Commission, specifically to complete the **Big Sur** Land Use Plan Update."

When she can find any free time, she says she's "reconnected with some of her childhood friends, trying to see each other with some regularity." When asked what she'd like to see the League of Women Voters do in the future, she replied, "You do a lot of things I really appreciate—the work on water supply, housing, the educational program is really first rate. What I would love is being able to share with you the things that come before the Board of Supervisors. Maybe the smaller issues the biggies are the ones you already cover."

Kate Daniel's major concerns include homelessness, particularly as it affects senior women and children. *"I won't feel like I'm successful if we don't start to move the needle,"* she says. *"And we need a sustainable water supply to increase housing."* 

Certainly, these are issues that concern many of our members.

## LWVMC AND CSUMB DISCUSS STUDENT VOTING & VOTER REGISTRATION

WVMC has welcomed invitations from local colleges to participate in voter information and

registration events this fall. On **September 17th, National Voter Registration Day,** League member **Jane Meade-Roberts** was once again on campus registering students at **Hartnell College**. Thanks to Jane for her long service to Hartnell and Salinas as a registration volunteer!



Also on September 17th, **Monterey Peninsula College** held its *"Lobo Day,"* where students had the opportunity to learn about a wide array of services, resources, and clubs offered by the college

and to connect with community non-profit and civic organizations including the League. I had the pleasure of staffing LWVMC's Lobo Day table with League member **An MacDowell**, a frequent LWVMC youth Outreach volunteer.

As many junior college students are young people eligible to cast their first vote a presidential election this year, they are a terrific audience for our message. We register them, or show them



how to register themselves online, check their own registration status, and reregister at a new address as necessary. We inform them about League information tools, including **Vote411.org** and **"Easy Voter Guide**," and encourage them to decide on a specific plan for how and when they will cast their ballots. Just as importantly, we share our excitement about voting as the cornerstone of democracy, and emphasize the importance of each

person's vote by using examples of narrowly-decided elections.

The League was also invited to the Student Engagement Fair Middlebury Institute of at the Middlebury Institute of International Studies at Monterey



**HARTNELL** International Studies (MIIS), held on September 19. The MIIS student body has a different composition from that of our local junior colleges, with many foreign students and US-citizen students who come from other states. Out-of-state students generally have the option to vote in their home state or reregister in California. For them, Vote411 is a useful resource as it includes a *"Vote in My State"* tab with information about voting rules in all 50 states, Washington, DC, and US territories.

> Although some of the information presented in the Easy Voter Guide is very basic, the guide includes a compact distillation of the ballot



propositions; this summary is handy for any busy California voter and was appreciated by students at MIIS as well as MPC.

Clearly our main goal is engaging with potential US voters, but even conversations with foreign students can go in an interesting direction. At MIIS I met a young man from Kyrgyzstan and commented that given his country's turbulent political history perhaps he had an opinion about the importance of voting. He readily agreed and said that he would share the *Vote411.org* link with his friends who are US citizens!

CSUMB enjoys vigorous student engagement in voting-related matters through their Civic Engagement Club, mentored by Nicole Hollingsworth, Director of Governmental and External Affairs. While our League did not

have the person-power to table at CSUMB on National Voter Registration Day, we plan to meet with CSUMB students in early October.

#### NATURAL RESOURCES COMMITTEE SEPTEMBER UPDATE


argaret Robbins reported on a "builder's remedy" project of 74 units at the end of Val Verde Drive in the floodplain near Rio Road on a one-lane dirt road, in which buyers will have to get flood insurance and pay for flood improvements. Questions were raised as to whether County Planners will enforce requirements for building in the floodplain, and whether an application has been filed including a PLN number? On the same subject, does the Rancho Canada project have flood control requirements, and are they being enforced?

George Riley reported that CalAm said extraction pumps are in place for the coming rainy season to implement ASR to the fullest. **MPWMD** lost a lawsuit on fees to the Taxpayers Association and will have to determine a procedure to reimburse property owners and legal fees for the Association.

Beverly Bean reported that the Pacific Grove Roundabout Project at Sunset and Congress Avenues has been approved by the PG City Council

and funded by transit agencies, but that some candidates for Mayor and City Councilmember are opposed and want to stop the project. Protect Monterey County (sponsor of the successful "Measure Z" against fracking, new oil wells, and requiring wastewater clean-up, but lost in the CA Supreme Court due to an outdated portion of the CA Code) urged Governor Newsom to sign AB 3233 (sponsor Rep. Dawn Addis and passed by the Legislature), to allow local control of oil operations posing threats. Additional bills requiring oil well clean-up (AB 1866) and low-producing well accountability (AB 2716), went to Governor **Newsom** who signed all the bills.

Richard Rosenthal reported that the Abalone Creek Project on Corral de Cielo was unanimously approved by the County Planning Commission, despite opposition. He said Supervisor Kate Daniels was critical of the opposition. A suggestion was made that the Civil Grand Jury should look into the County's dysfunctional Planning Department. Beverly Bean and George Riley
