## Consensus Meeting to Update the League's Regional Transportation Position

Much has changed since the League's regional position on transportation was last updated in 1989-90.

In a joint effort between the San Diego League's public policy committee and representatives from the North County League our regional transportation positions have been studied for the past year:

- Assessed our current position and looked for alignment with LWV's State and National positions.
- Heard presentations by the San Diego Association of Governments (SANDAG) on their emerging view of transportation in our region for the year 2050, being proposed in their initiative San Diego Forward – *5 Big Moves*. <https://www.sdfoward.com/mobility-planning/5-big-moves>
- Considered the entwined relationship between transportation and housing and goals embodied in the County's General Plan.

The result of this joint effort is a call for consensus to consider questions that will shape our regional transportation position if accepted by the members and boards of both League.

**At these 3-hour sessions**, LWV panelists will brief members on the elements covered, facilitate a discussion on each question and seek consensus.

San Diego League members will also deliberate on questions that will shape their Housing and Housing & Transportation positions. North County League members will be deliberating only on the regional transportation consensus questions.

The Transportation questions include topics and goals such as:

- Use of underutilized publicly-owned land
- Prioritization of standards such as safety, adequate funding, available transit service, favorable environmental qualities.
- Coordination with land use plans.
- Role of regional planning organization.
- Comprehensive and affordable transportation system available to all San Diegans.
- Prioritize public transit over highways and road improvements.
- Should goals maximize public transit ridership or minimize costs.
- Support greenhouse gas reduction in transportation plan as outlined in climate action plan.

## Climate Solutions Corner for March 2020

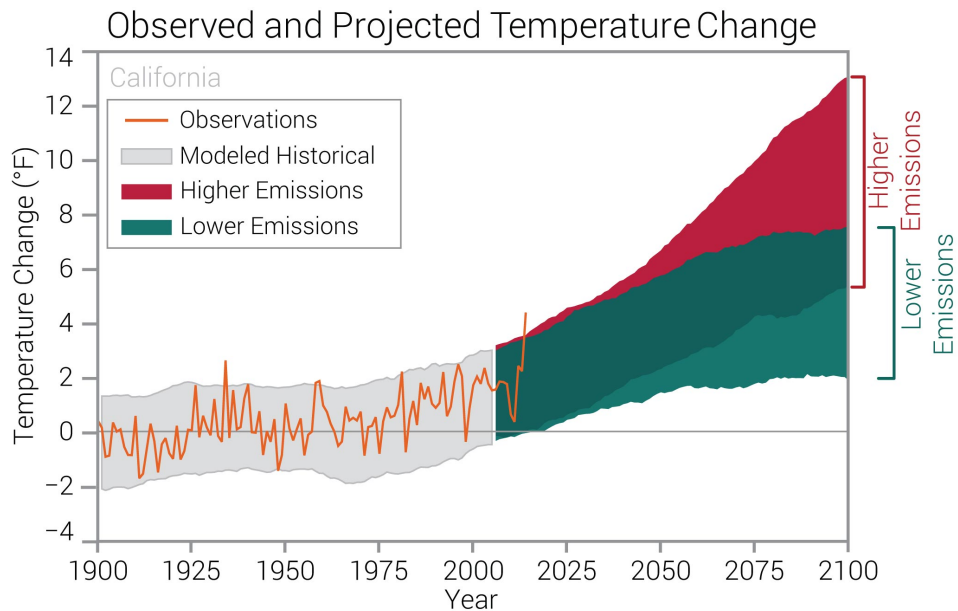

### Emergency in Climate

LWVUS, as well as LWVC and many other state and local leagues have declared that we are in a climate emergency. We have heard from Greta Thunberg, who is restating scientists, that we are in a climate crisis. BP Oil just announced that it commits to net zero carbon emissions by 2050. Clearly there is something that is changing about our climate. But what is the emergency?

The NCA (National Climate Assessment), a group of scientists put together by the US government, has this to say about our future: “how much the climate changes will depend primarily on global emissions of greenhouse gases... With significant reductions in emissions, global temperature increase could be limited to 3.6°F (2°C) or less compared to preindustrial temperatures. Without significant reductions, annual average global temperatures could increase by 9°F (5°C) or more by the end of this century.”

NOAA has prepared this graph of projected temperature:



The LWVC Climate Change Task Force put it best:

Heat records are being broken, glaciers are melting, and the seas are rising. We have reached a point where no matter what we do, we cannot avoid a very different climate future. We must act now to prevent truly catastrophic consequences. But what can we do? The most powerful action is our knowledgeable vote. For more info. visit - <https://lwvc.org/issues/climate-change>

Hats off to all who gave their time and talents to making these forums possible. The League was able to help around 250 voting citizens of North County make informed decisions. Way to go!

On January 29, 2020, the U.S. House passed H.J. Res. 79, the legislation removing the ratification deadline on the Equal Rights Amendment (ERA). This legislation is needed to remove the ambiguity around the deadline and bring it closed to taking effect. Now we focus on the Senate as legislators go home for recess. LWVUS is also partnering with select state leagues on Targeted advocacy campaigns to have their Senators cosponsor H.J. Res. 79 or S.J. Res. 6.

## This Is Why Homeless People Don't Go to Shelters

A closer look at the choice between remaining on the street in an encampment and going to a shelter shows that it's not an easy decision for many homeless people and some of them don't have any options at all. In many cities, there aren't enough shelter beds to accommodate the people living on the streets. They aren't living in tents by choice, but out of necessity.

Vista's newly-released *Draft Plan to Address Homelessness*\* makes a range of suggestions, from better outreach to hiring a full-time social worker, but it does not include temporarily housing the 120 unsheltered individuals said to be living within city boundaries. The plan proposes more than \$700,000 in additional spending, allocating up to \$200,000 to pay for no more than 10 beds for single men at "low barrier" shelters that do not turn away those struggling with addiction.



### **If ultimately approved by the council, those beds would not be in Vista.**

The city would contract with Haven House shelter in Escondido and the La Posada shelter in Carlsbad to add capacity.

Even when there are shelter beds available, there are still plenty of logical reasons that someone may decide not to enter the system, and many policies that keep them outside of it. There are other rules that are simply non-starters for other people. In North County San Diego there are only

five shelters with a total of 164 beds for over 2,000 identified homeless.

Many of these shelter beds do not serve women with children, people with pets, or any working person who has night shifts. Under this criteria, a majority of residents are totally excluded from shelters, which are often only available for one night.

### **San Dieguito - Encinitas Area Advances in Social Services**

You probably are aware that our LWVNCSD League, represented by President Anne Omsted, was one of the many groups and individuals who advocated for a proposal to provide safe parking to homeless people who have no place to live other than in their automobiles. The Encinitas City Council approved the proposal on a 4 to 1 vote

Many are not familiar with the work of the **Community Resource Center (CRC)** in Encinitas.

CRC has some remarkable numbers for 2019.

- 2,000 + Volunteers.
- Domestic Violence: 1,538 calls answered on the 24-hour domestic violence (dv) hotline; 4,223 people received dv prevention education; 1,462 counseling session provided compassionate care.
- Housing the Homeless: 2,278 case management sessions provided financial, housing, and career resources; 273 individuals found safe housing through the intervention programs and dv shelter and transitional units.
- Food: 464 pounds of rescued food distributed through 14,225 visits; 6,409 people received food, coats and gifts during the Holiday Basket program.
