"Schools and Communities First" Needs YOUR
HELP to Bring an Additional \$12 Billion in
Revenue to Local Communities



In early 2018 our League helped collect signatures to put on the Nov. 2020 ballot a state measure that would modify only the commercial part of Prop 13 to generate new revenue for schools and communities. However, after much study, the coalition of public service groups backing this initiative, including the League of Women Voters California, decided to change the initiative's language to make the initiative more effective.

Changes include: Making sure that every public school in California will receive money from the new revenues. (There were concerns that the original language would inadvertently leave some schools out of the funding loop). Implementation dates were extended to allow more time for building up revenues and accommodating a shift of the initiative from 2018 to 2020. Small business property exemptions are expanded. Phase in of the initiative was extended and expanded to accommodate the issues with Tax Assessors related to time allowed to perform reassessments, the costs of massive reassessments to counties, and refines the details related to implementation, start-up and appeals.

Therefore, supporters once again have to gather signatures to be able to present an improved initiative to the voters of California in November, 2020.

At the 11/08/19 Board meeting, the following items were discussed.

- Learned that the Executive committee had approved sending a request for a proclamation remembering Sandy Hook and all victims of gun violence to all North County cities. It also approved sending a request to members to contact the Board of Supervisors and supporting 4 satellite voting centers for the 3/3/20 Primary Election.
- Learned that a fundraising advisory group had made recommendations on how to raise money to cover budget shortfalls.
- Learned that the LWVSD now has an Observer at the Board of Supervisors and we will be able to send her reports to our members regularly.
- Had current Behavioral Health county government situation reviewed by Liz Kruidenier.
- Discussed learning how each city in North County uses its Community Development Block Grant (CDBG) money from HUD. Bill Loftus will organize this.
- •Learned that Rita Soza and Blaze Newman organized a pilot Voter Engagement event for the Business/Accounting Club at MCC which went very well.
- Learned that we were asked to monitor a faculty vote at Palomar College on 10/22/19 and it was

Who are the Observers? They are League members who attend the public meetings of local governmental agencies. The observers don't advocate or testify; they sit quietly and observe. Their mission is to educate themselves, and by extension the League, about the issues before the agency and to assess if the proceedings are conducted an open and transparent manner.

You don't need to be an expert to do this; all you need is curiosity and patience. The curiosity gets you to the meeting. Patience enables you to sit quietly and take notes as the meeting unfolds before you. Sounds simple doesn't it? And yet the observer program is a vital part of the LWV. For almost a hundred years League members have been paying attention to the issues facing their communities and observing how they're resolved. Our awareness of these matters and the timeliness of our advocacy depend on the work of the observers: "The eyes and ears of the League."

There are several openings for an observer but most of all we need observers for each of the city councils in our area. We need to know the issues before the councils and we need to know if there is a matter our League should address. And almost as importantly, the city council members need to know that the LWV is interested in their deliberations.

If you want to hear from the observers themselves, come to an Observer Reports Luncheons. Both the Carlsbad & San Dieguito units hold their end of the year luncheons in December. These events are open to all of our members. You're invited to come, share potluck, listen to the reports and learn what's happening in your area. By the end of the luncheon I think you'll find observing is something that you can do. We will provide a roster of our current observers and the governmental meetings they observe.

Climate Solutions Corner Fight Climate Change in San Diego With LWV

LWVSD and LWVNCSD cohosted the San Diego Climate Change Forum by Diz Swift and the Climate Change Task Force of LWVC November 9. The forum was a great example of the two tenets of LWV: Education and Advocacy.

Diz presented what the Climate Change Task Force (CCTF) does and how the LWV takes action against climate change. The CCTF website (https://lwvc.org/climate-change-task-force) has a wealth of information on climate change, League positions, what the League is doing, and information from the forum.

Diz emphasized that yes, we are in a climate emergency and that we need to take bold action to cut our CO2 emissions in the next decade. But more than cutting emissions, we need to drawdown the CO2 that is already in the atmosphere because it hangs around for 200 years. She said that the best way to drawdown or take up this CO2 is with plants. The food, soils and agriculture subcommittee in the CCTF advocated for better farming techniques and identifies funding sources for farmers that have been willing to try them. This was just one example of specific actions the CCTF and local leagues have taken. Other speakers urged us all to get educated on issues and candidates, advocate for strong city and county Climate Action Plans and Community Choice Energy Programs, look into county programs to finance solar panels, and use less energy.

Forum attendees broke up into working groups to brainstorm actions we can take in San Diego regarding: Sea level rise

Transportation and housing Food, soils and agriculture Education Impact on resources

LWVNCSD Community Safety and Guns, aka Gun Violence Prevention Group

The Community Safety and Guns aka Gun Violence Prevention (GVP) Interest Group last met November 13. Since it was formed, the group has held several public forums and other educational events. Other non-profit groups we associate with, local and national, such as NeverAgainCA, SD4GVP, MOMS, Brady, share a common interest in passing common sense gun laws. We have held rallies against the Gun Shows at the Del Mar Fairgrounds, protested to ban assault weapons, and taken actions to promote stronger regulations on gun accessibility, registration and safe storage of guns in homes.

There are many GVP events and actions coming up in the next month. First, there is a North County Gun Violence vigil (7th year) honoring the victims of Sandy Hook on Sunday, December 8 from 4:30 to 6:00 pm, at the San Dieguito Unitarian Universalist Fellowship in Solana Beach (uufsd.org). The League will have a table with LWV information for attendees.

Second, another vigil, an interfaith service for greater San Diego and sponsored by SD4GVP will be held Saturday, December 14, at 7:00 pm at Temple Emmanuel in the Del Cerro neighborhood.

Lastly, the most recent activity of the our GVP committee has been to distribute a letter written to officials in eight North County cities along with

a request for a proclamation to designate a day of remembrance for all victims of gun violence. The Sandy Hook tragedy was on December 14, 2012, when 20 children and six teachers were shot and killed.

There is a nationwide observance and vigils to #End Gun Violence, during December 4-14, 2019, to honor the lives and memories of those killed by gun violence. Anne Omsted, President, approved and signed the letter and proclamation and Nancy Telford, VP, sent the documents and request to city clerks and the mayors and has received responses from Oceanside, Encinitas, and Del Mar. Judy Thum and Sandra Sweet helped draft the documents used. Nancy also is contacting the San Diego League so they can do the same in their area. On the day when a City Council presents the Proclamation, a member of North County League will attend.

If you are interested in joining the GVP interest group, we meet once a month and have shifted the day we meet to the First Tuesday at noon, at Leucadia Wastewater, at the shopping center at El Camino Real and La Costa Ave. Please feel free to contact other committee members, including those below, with questions or comments.
