HAVE YOU BEEN COUNTED?



You should have received your U.S. Census 2020 letter in the mail. If not, it's on the way. It contains a website (<u>https://2020census.gov</u>) and a code unique to your address. Please Complete your Census Form today! Click here <u>https://my2020census.gov/app/intro/state</u> to complete census questionnaire **without** your code.

The 2020 Census will inform where new hospitals should be built, and it impacts funding for health and wellness programs across California. When we participate in the Census, we help our communities thrive and build a healthier California for All!

Each person not counted costs Ventura County \$2,000 per year for 10 years (\$20,000!) and can jeopardize congressional representation. Include any children living at your address on your Census form. When you do, you help ensure that our kids' schools and childcare centers get more of the funding they need for the next 10 years.

SUCCESS!

On April 2nd, the Schools & Communities First campaign announced the submission of more than 1.7 million signatures of support to **qualify for the November 2020 ballot** – the most signatures ever submitted in California for a ballot initiative. This historic benchmark was achieved weeks ahead of schedule and surpassed the original 1.6 million goal set by the campaign. A big "thank you" to all our volunteers who gathered signatures to help make this happen!



In a sign of the Schools & Communities First coalition's robust statewide infrastructure and support, a massive grassroots volunteer coalition collected more than 410,000 signatures of the total – an unprecedented number.

The Schools & Communities First initiative would direct \$12 billion every year to the most pressing needs in our communities, including critical local services and schools, while protecting homeowners, renters, and small businesses.

LWV CALIFORNIA CRIMINAL JUSTICE ACTION



The state League is co-sponsoring the legislation referred to below.

California's legal system is plagued by racial disparities and discrimination in arrest, trial and sentencing. For far too long, pervasive,

structural racism has led to unfair convictions and lengthy sentences for black, brown, indigenous and people of color. Courts only reverse convictions in the most extreme cases, when there is strong evidence of intentional discrimination. In most cases, the courts don't act, or worse yet, condemn discrimination but call it "harmless error."

Racial discrimination in our criminal legal system is not inevitable, it is not unfixable, and it is not harmless. <u>AB 2200, the California Racial Justice</u> <u>Act</u>, introduced by Assembly Member Ash Kalra, will prohibit racial

discrimination in convictions and sentences and create a process to challenge racial discrimination at trial or following conviction. You can find more information in this **fact sheet**.

As Congress works to address the COVID-19 health crisis, it's CRITICAL they include provisions to safeguard the right to vote in the upcoming November election. Contact Congress today and ask them to:

- ensure funding and legislation to safeguard elections is included in the next stimulus bill.
- adopt a National Vote-By-Mail Act, working for mail-in ballot options for all states before the November election, including removal of problematic restrictions and assurance of a paper trail for all.

This would encourage voting, assure recounts are feasible with paper ballots, and avoid polling places where health could be compromised.
