THE PRESIDENT'S MESSAGE



March was Women's History Month when the contributions of women, past and present, were recognized and honored. Our League was pleased to receive a Proclamation in honor of Women's History Month from Oxnard Mayor John Zaragoza in his office on March 6th. Several league members were present to accept the Proclamation.

Shortly thereafter, on March 14th our League was given a proclamation in honor of the US League's 103rd birthday by the Ventura County Board of Supervisors. This was presented to us following a Moment of Inspiration given by our Vice President, Susan Roth, in which she described the inspiring life of the League's founder, Carrie Chapman Catt as well as the history of the league.



Later in March several league members participated in tours of the Planned Parenthood Clinic in Oxnard. It was interesting to see the clinic, hear about the services they provide and the increasing need for their services. More tours can be arranged if others are interested in attending.

In the middle of March, we became aware of a proposal presented to the County Board of Supervisors by two supervisors to repeal the Ventura County Campaign Finance ordinance which has been in place for 20 years. The League Board held an emergency meeting to discuss what, if any, actions we should take. It was decided to send a letter to the Board of Supervisors requesting that the supervisors delay the vote until such time as an impartial study could be completed. Other actions included a Letter to the Editor of the Ventura Star and reading a statement at the Board of Supervisor meeting held on 3/28/2023. Ultimately the BOS decided to vote on the proposal instead of delaying the vote. The vote was 3:2 in favor of the repeal of the ordinance to be replaced by the State Guidelines which are less stringent. The League Board will be discussing this at our next Board Meeting to be held April 13th, in person at 11am. Please reach out to me at lwvvc.info@gmail.com if you have any comments on this issue.

Observer Report

Ventura County Board of Supervisors Tuesday, March 28, 2023 Observers Reporting: Doris Simmelink & Cheryl Collart

Dear Members,

Many of you are aware of actions by the LWVVC to speak out against an unprecedented move by the Ventura County Board

of Supervisors to repeal a decades old campaign finance ordinance that set limits on

individual contributions in our local county elections. I would like to commend the LWVVC board for its quick response and thoughtful nonpartisan statement from our President, Kathy Morgan, at the March 28th public hearing. The League requested the Board delay a vote in order to allow an independent study of the modifications. Approximately 15 league members were there as observers.

The majority of the speakers at the board meeting were opposed to this action and suggested possible amendments rather than a total repeal. Speakers noted the Board appeared rushed and these actions raise concerning questions about timing and purpose.

After two hours of public comment, Supervisor Gorell presented a PowerPoint presentation supporting repeal, and the other four supervisors made brief comments to support their positions. The final vote was 3 – 2 in favor of repeal.

The result of this repeal is that campaigns for county elected offices (Board of Supervisors, Assessor, Auditor, Clerk-Recorder, District Attorney, Sheriff, Superintendent of Schools, and Tax Collector) will now be subject to the *CA State Fair Political Practices Commission* rules and limits. This raises contribution amounts from \$750 to \$5,500. Our County Campaign Finance Ethics Commission has also been eliminated.

I encourage the League to form a study group on the effects of this action and continue observing BOS activities. As our President stated in her letter to the BOS, the League "... believes that governmental bodies must protect the citizen's right to know by giving adequate notice of proposed actions, holding open meetings and making public records accessible."

It is the practice of state assembly and senate representatives to participate in various committees that study issues of significance to seek consensus for a given topic and build support for their proposed legislation. The legislation goes

through various reviews before it is actually held to a vote.

Connie Baer was a long-time member and supporter of the LWVVC. She passed on February 18th. She leaves behind her two daughters, Kathleen Sage and Marianne Baer; her two granddaughters, Aubrey and Lindey Sage; her son-in-law Charles Michael Sage; and many dear friends who will miss her tenacity, her courage and her generosity.

Connie moved from Pasadena to the cooler climes of Ventura with her longtime partner Rita Marsh. Her love of "fighting the good fight" continued as she poured her efforts into gay rights and legalizing gay marriage (she and Rita were officially married in 2008). In addition to her law practice, she served many years on the board of the Ventura County Medical Resource Foundation, helping to raise much needed funds for the hospital and their outreach programs, and was honored for her efforts in 2015, receiving their Trailblazer Award for her commitment to social justice and health care for all residents. She also received recognition for being the Board's longest serving member. A lifelong Episcopalian, she was an active and supportive member of St. Paul's Episcopal Church in Ventura, serving on their Pastoral Care Committee. Connie had a long life devoted to service and was loved by and will be missed by many.
