### PRESIDENT'S MESSAGE

April is National Volunteer Month. We celebrate all those who give their time and resources to help others. We are especially delighted David Maron is being honored at the Ventura County Leadership Academy Journey to Leadership Awards on April 25<sup>th</sup>. Thank you, David, for all you do for the League and for our community.

Friday, March 8<sup>th</sup>, the Voter Services Committee delivered lunch to the 75-or-so members of the Ventura County Elections Office staff who make democracy work by securing, processing, curing, and counting ballots. They were most appreciative of the food *and* the positive recognition of their efforts. My thanks to the committee who made this happen.

The Supreme Court of the United States (SCOTUS) will hold oral arguments on **April 22 at 7 a.m. PDT** on the enforceability of state, county and local laws that prohibit camping on public property and whether or not those laws violate the Eighth Amendment's ban on "cruel and unusual punishment." The SCOTUS decision in *City of Grants Pass v. Johnson* will have an impact on how cities and counties can manage homeless encampments.

Several cities throughout Ventura County have recently passed ordinances which regulate how and where people experiencing homelessness can stay overnight on public property. These ordinances, which were adopted to comply with the guidance in *Grants Pass v. Johnson*, have been controversial and the subject of much public discussion. The court's ruling in this case could affect how other cities address their own epidemics of homelessness, including those throughout Ventura County. Look for the SCOTUS ruling that Monday.

I heartily encourage anyone who is interested to attend the 2024 LWV Biennial Convention being held June 27, 2024 - June 30, 2024, at the Washington D.C. Hilton. It's a chance to interact with League members from all over the country. Most, if not all of the cost will be reimbursed, so pack your bag and join the fun! More information is below.

I recently read an article about the history of the U.S. Constitution and how opinions about what it means are everchanging. There are those who wish to interpret it in light to today's cultural norms and those who want to interpret as they believe the founding fathers would have. However you think of the Constitution, the intent is and ever was to preserve the rights of *the people*. That's why we work to preserve the Constitution, defend democracy, and empower voters.

Lastly, I want to personally thank each of you for your part in the success of the LWVVC. Your participation is important. It has an impact. It makes our county a better place to live and work. Thank you, each and every one!

# **2024 LWV Biennial Convention**

The LWV National Convention is exciting and informative. There are plenary (general) sessions where the work of adopting a budget, updating the bylaws, and electing new officers takes place. There are also inspiring speakers. But the part that educates and informs us the most is the many caucuses and workshops where we learn how to do new things or how to improve things we have been doing. And we learn what leagues from all over the country are doing; what their problems are; what their successes are. And we bring back ideas to present to our members. It's a great experience! The LWVVC has budgeted \$10,000 to cover the costs for those attending. **Those attending on Zoom will have their cost of convention paid**. The remaining money will be divided between those attending in person up to the full amount spent, excluding food and beverages.

Convention costs are \$775.00 per person and include:

**League Rate for Hotel Room** is \$239.00 + room taxes & fees. Total for two people sharing a room is approximately \$1,000, or **\$500** per person.

**Airfares** vary depending on the airline, class, and time of day. The approximate cost is **\$750** for round trip. The closest Airport to the hotel is Ronald Reagan Airport.

Based on total membership, the LWVVC is permitted to have **three voting delegates** at the convention. If you plan to attend and would like to be a delegate, please let <u>Pat Butler</u> know. Thank you.

#### DEI Committee, Laura Hernandez, Chair

- 1. The LWVUS has adopted a new DEI Policy. The final policy is as follows: "Discrimination or harassment of any kind will not be accepted within the League, including but not limited to race, socio-economic status, age, ability status, religion, sexual orientation, national origin, gender identity, or marital status. The League is committed to fostering, cultivating, and preserving a culture of diversity, equity, inclusion, access, and belonging for all people. The League is an organization that respects and values the richness of our community and our members. The collective sum of our individual differences and life experiences represents not only our culture but our reputation and the organization's mission and achievements as well."
- 2. What was the process for making changes to the policy?

A subcommittee of the LWVUS DEI committee researched DEI policies and practices of comparable organizations in addition to looking across disciplines to develop a draft policy. The subcommittee also made sure to consider LWVUS issues as input to help shape the League we want for the future. The draft policy was shared with the LWVUS DEI Committee and then the

LWVUS Board for feedback and eventually, approval. The DEI committee and then the LWVUS Board for feedback and eventually, approval. The DEI committee is co-chaired by two national Board members and is comprised of a few additional national board members as well as League members from a variety of positions and capacities across the nation. A DEI sub-committee is focused on a project to understand which states currently have DEI committees or representatives. As we collect data on which Leagues have formal DEI committees or chairs, the goal will be to establish a DEI network and engage with them to fully develop and implement our continuing DEI work at the National level.

- 3. Meanwhile at the State Level, the LWVC DEI Committee will be focused on their 2024 Work plan, updating DEI Policies and Procedures, and scheduling "People First Language" seminars for staff and local Leagues. The seminars will be conducted by Dr. Taggert a member of the State DEI Committee.
