PRESIDENTS' MESSAGE

Last month the LWVUS National Convention was held in Washington, DC from June 27-30th. It welcomed 1,754 attendees from all 50 states, D.C., and the Virgin Islands, both in-person and online. Pat

Butler, Matty Park, and Susan Roth attended as LWVVC delegates to the Convention. Delegates discussed and voted on policy and business items, and elected Dianna Wynn to serve as the 22nd President of the organization on June 28th. Prior to the Convention, we met with our CA Senators and Representatives in Congress who supported the John L. Lewis Voting Rights Advancement Act. We enjoyed meeting with them and let them know that the League appreciates their support for this important legislation.

This is a busy time for members of the LWVVC. Meetings have been organized to invite and train volunteers who wish to participate in voter registration activities across the county, thanks to Betsy Patterson. Volunteers are also being trained to provide nonpartisan presentations about the Pros & Cons of State propositions appearing on the November ballot. Other activities related to Community Engagement and DEI events will be taking place. The LWVVC Board approved a new Housing and Homelessness Committee, chaired by Sharon Crane. Other reports and upcoming events are included in this newsletter.

We welcome all new members and encourage everyone to engage with the League's important agenda to educate voters, support our Ventura County elections office, counteract disinformation about elections, and defend democracy in what could be a historic Presidential election. LWVC Among Most Effective Advocacy Organizations in CA

A June <u>CalMatters analysis</u> (<u>https://calmatters.org/politics/2024/06/california-lobby-ing-rankings/</u>) identified the League of Women Voters of California as the third most effective advocacy organization in the state, achieving 85% of our desired policy outcomes during this legislative session so far. The League rises to the top in effective-ness because we are grassroots, and we stand firmly in advancing equity for all people. Each day, we fight for equity across voting rights, government transparency, affordable housing, racial justice, climate, environmental justice, and criminal justice reform (and much more!</u>). In total, the LWVC has taken a position on 101 bills this legislative session.

Women's Equality Day – August 26th



During the July 15th Board of Harbor Commissioners, the Oxnard Harbor District honored Women's Equality Day and presented this framed resolution to the League of Women Voters Ventura County.

Women's Equality Day is celebrated in the United States on August 26th to commemorate the struggles of women to be heard, as fierce advocates who gained the statutory right to vote in 1920 through the adoption of the Nineteenth Amendment to the

United States Constitution, which explicitly prohibits the states and the federal government from denying the right to vote to citizens of the United States on the basis of gender.

Report - Board of Supervisors Meeting - Tuesday, July 23, 2024

On Tuesday, July 23rd, several League members attended the Board of Supervisors meeting to support of the Voter's Choice Act and our Ventura County Elections office. Susan Roth, co-president of our League, spoke in support of the CA Voter's Choice Act which our county adopted to increase accessibility to voting by registered voters.

LWVVC fully supports the Voter's Choice Act as it makes voting possible for the largest number of citizens over several days, and hand counting ballots has repeatedly been shown to be inaccurate.
