The year 2024 will be a good year for climate action; IRA rebates will become available! Residents can take advantage of rebates when replacing appliances with efficient ones, like a heat pump water heater that uses about three times less energy than conventional gas or electric water heaters. And now, there are 120V heat pump water heaters that can plug into a standard electrical outlet, so consider a hybrid water heater when your old gas water heater needs replacing. Fun fact: Did you know that water heaters consume the most energy of home appliances in Ventura County?

Observer Report

Observer Report: Ventura County Board of Supervisors Meeting, 12/19/2023 Submitted by Karen Savitt.

Water rates: A rate increase of 6% was factored in to include cost increases of labor, electric and demand. When we have a wet year, the water revenue decreases. Without the rate increase the capital reserve would be compromised effecting repairs. Moved and approved for a 7.5% commodity and meter rate increase.

Coordinated agendas: The county has implemented a coordinated agenda for the county, state, and federal agendas. *Passed.*

Received and file a presentation from LeSar Development to prevent and end homelessness. Areas of prioritization reported. Some data included the issue of student homelessness. Coordinating agencies – county, cities, and services. *Passed.*

Microenterprise Home Kitchen Operations (AB 626, 377, 1325 SB 972): Food facility that is operated from home to serve consumers. Addressing low income and marginalized community. Striving for access to healthy foods. There are restrictions and standards that are applied. No catering is allowed. There is a limit on the number of meals that can be served and the amount of income. Must pass food accreditation testing zones and land use exemptions. Must comply with restaurant standards. Facility to be run by only family members plus one employee. Currently the County cities do not wish to adopt this concept. The Board chose to follow the recommendations of the cities. *Report was received and filed.*

Voter Services Committee Report

This year the Presidential Primary Election in California is on March 5th and the Voter Services team is getting ready for it. We are starting to organize **Candidate Forums** that we will be putting on prior to the Primary. If you are interested in helping with candidate forums,

What is the Voter's Choice Act, and how is it Working for Ventura County? Ventura County applied for the Voter's Choice Act in 2018 to make voting more flexible and accessible for voters. Ventura County's 4-year Election Administration Plan to adopt the Voter's Choice Act was reviewed and approved by the California Secretary of State's office in September of 2023.

All California active registered voters will receive a vote-by-mail ballot in the mail about 28 days before Election Day, March 5, 2024. In Voter's Choice Act counties, voters have **3 ways to return** their completed ballot:

- 1. Mail it in the postage-paid envelope included with the ballot; vote-by-mail ballots must be postmarked on or before Election Day and received by March 12, 2024.
- 2. Use a county Dropbox starting 28 days before Election Day.
- 3. Visit a Vote Center, beginning 10 days before Election Day. More Vote Centers will open three days before Election Day.

Most old neighborhood polling places will no longer be open. Instead, voters can **vote in person** at any Vote Center in the county.

At any Vote Center, voters can vote in person, drop off a completed ballot, get a replacement ballot, vote using an accessible voting machine, and get help and materials in other languages.

However, in Ventura County, some people are unhappy with changes that occurred with voting when it became a VCA county. They would like to go back to previous ways of voting, expressing concerns about fraud. Some proposed actions include eliminating voting machines, ballot drop boxes, vote-by-mail ballots, and regional Vote Centers. They would like to bring back neighborhood precinct polling places,

paper ballots, hand counting, and voter residential identification. They have been actively speaking at Board of Supervisor Meetings and plan to continue doing so. We would like to mobilize volunteers to speak out in favor of the VCA and provide factual information about the VCA, either by writing Letters to the Editor, writing to our supervisors, or making public comments at Board of Supervisor meetings.
