

Letter from the President

The 2022-2023 year was a busy one for the LWV Wellesley. While still offering a robust schedule of virtual offerings, our members transitioned back to many "in-person" events. In fact, even on the coldest day of the year we had a great turnout at the library to hear from Representative Alice Peisch. Our board members have worked hard and enthusiastically on a wide range of projects, the highlights of which appear throughout this report. This years' activities included:

Supreme Court and our Health: Our fall kickoff event featured Wendy Parmet's talk about the decisions of the Supreme Court and the consequences to our health at a time when we see how the Court is shaping the future of American life.

Voter Service: Our voter service team enthusiastically resumed in-person voter registration drives this year, cosponsored candidate forums, organized sessions for "How to Run for Public Office", "Meet the Candidates Night", and Town Meeting Prep Sessions. We continued to update and produce our publications such as the *Election Guide Handbook* and the *Town Government Handbook*. An online candidate guide, a printable candidates list by district and a postcard mailed to all households in Wellesley provided voters with much needed information about elections.

Coffees/Brown Bag Lunches: With a mix of in-person and virtual meetings, we shared our coffee or lunch with various local officials, league members, and employees of the town. Michael Reidy, the Social Studies Department Chair, gave us some insight on the High School Civics Education Curriculum. We also got to meet Deborah Brown from the *Swellesley Report* over Zoom and hear her strategies for capturing and disseminating the local news in Wellesley.

Community Book Event: Meeting in person to hear from the author Ari Berman discuss *Give Us the Ballot: The Modern Struggle for Voting Rights in America* gave us the opportunity to discuss why the right to vote is still under debate and the importance of civic engagement at all levels.

Collaboration with Other Town Groups: We partnered with the Town's DEI Taskforce to promote a workshop led by Bird Guess: "Bigger Than Racism: Understanding Racialization and Structural Advantage in Wellesley and Beyond". We also advocated for passage of the anti-bias resolution and equity audit proposed to Annual Town Meeting. The Book Event mentioned above gave us the chance to partner on an event with World of Wellesley. We continue to seek opportunities to work with local groups on a wide range of issues.

This year the LWV Wellesley Board instituted some changes to our board meetings and our board worth noting here. Board members each month open our meetings with a Land Acknowledgement, meant to keep us aware of our local history and those who have come before us, and also to keep us accountable to continue learning and to take action on what we learn. The statements come from a variety of sources (religious organizations, colleges, theatre productions, and books). We now have planned to hold our meetings in a public space (Wellesley Recreation Building) in order to be more inclusive. As always, all meetings are open to all members. Finally, as a board, we voted to add a position to our Elected Directors: DEI Initiatives.

As the new Board takes office, I urge all of our members to become involved as time and interest permits. Remember that we depend partially on word-of-mouth to add new members. We continue to be grateful for the support we receive from our local cable network, Wellesley Public Media, making it possible to record and occasionally live-stream our public meetings.

Thank you to this year's Board members for your energy and hard work during the past year.

2023-2024 Budget Notes

Income:

- **Dues** reflects an increase in membership by three full paying Individuals and three Individual members provided with scholarships based on the membership total of 97 Individuals (out of a total of 139 total members) provided to LWVUS on January 31, 2023.
- **Grants** We anticipate applying for a grant from the Daniel Scharfman Citizen Education Grant program administered by the LWVMA Citizen Education Fund. This grant is awarded for citizen education and voter service events and programs.
- **Non-Member Donations** donations from non-dues paying supporters
- **Phonathon** percentage of funds raised during winter fundraising drive (Phonathon) for LWVMA




- Bank CDs interest accrued from our two MutualOne Bank CDs. We will earn interest at 4.25% for 3.5 months and project earning 3.5% for the remaining 7.5 months of the year on this \$5,500 CD when it matures in October and we reinvest in a new CD. We also project earnings of 4.0% on a second MutualOne CD (\$10,534.78) when we roll it over in July.
- Sponsorship/Donations Vote411/MTCN/Postcard contributions from Roche Bros. and other local businesses to help pay for: Vote411.org software and the Election Guide; Meet the Candidates Night (MTCN); and a town-wide postcard mailing with a reminder of the March town election, details of MTCN and Vote411.org and voter registration information.

Expenses:

- Meeting Expenses, Annual paper goods and rental space fee for meeting if we are unable to find a member willing to host at their home
- **Board Meeting Rental Space** rental space for monthly board meetings at public locations such as the library should the Recreation Center not have meeting rooms available
- Meeting Expenses, Nat'l/State to cover registration expenses for LWVUS Convention
- **Meeting Expenses, Program** to cover room rental expenses for our programs/to help sponsor programs with other organizations
- **Board** includes funds for Zoom, if needed, to hold meetings/events virtually
- **Contributions/Honoraria** for speakers as well as a donation to State League (typically from Phonathon proceeds)
- PMP (Per Member Payment), National/State based on membership as of January 31, 2023. National PMP rate remains at \$32 per individual and the State PMP rate remains at \$23 per individual.
- **Publicity/Outreach** cost of Constant Contact (for notifications sent to members via email); publicity for events and outreach efforts to attract new members
- **Special/Civic Projects, Other** funds for a town-wide postcard mailing to make residents aware of Vote411.org as a source for information on candidates running for town office. The postcard would also provide information about MTCN and voter registration. These funds could also be used for unforseen needs the League would like to address.
- Election Guide/Vote411 to cover purchase of Vote411.org software as well as expenses to layout/print a one sheet Election Guide printout for the polls.
- Handbooks/Election Resources production of Town Government Handbook provided to new Town Meeting Members and town elected officials as well as an Election Resources guide available for those running for local public office in 2024; voter registration materials.
- Vote Signs cost of new sign stakes or duct tape to attach dates on VOTE yard signs
- Website, LWV Wellesley includes annual cost (\$400) of MyLO, the platform for our League website, as well as annual fee for .org and .com domain names

Diversity, Equity, and Inclusion



At the March 14, 2023 board meeting, the LWVW board added a new directorship position dedicated to promoting diversity, equity, and inclusion in all League activities, to begin immediately. They voted to welcome Rama K. Ramaswamy to the board as the director responsible for helping all committees integrate principles of DEI in their activities. They also voted to instruct the Nominating Committee to include the DEI position on next year's slate.

LWVW Program Report

Opening Meeting: Professor Wendy Parmet

Our Fall Opening Meeting took place on Wednesday evening, **November 7th**, on Zoom. Our speaker was Professor Wendy Parmet, co-director of the Center for Health Policy and Law at Northeastern University and a leading expert on health, disability, and public health law. The title of her talk was "Constitutional Contagion: How the Supreme Court is Making Us Unhealthy." She discussed research for her new book on how the recent decisions of the Supreme Court are impacting healthcare, voter participation, and the environment.



Co-Sponsored Workshop: Bigger Than Racism

On **Tuesday**, **March 14**, we co-sponsored (with the Town of Wellesley and Babson College) a Zoom workshop titled "Bigger Than Racism: Understanding Racialization and Structural Advantage in Wellesley and Beyond." Over 130 people joined the Zoom. The program, which featured Bird Guess of the Racial Equity Group, was also broadcast live on Wellesley Media. Mr. Guess shared the history of racialization and how historic segregation in housing has had lasting impacts on society through disparities in education, job opportunities, and exposure to the criminal justice system. A recording of the workshop has been posted on the Town of Wellesley DEI Task Force webpage.



Co-Sponsored Book Discussion: Give Us The Ballot

On **Tuesday**, **March 21**, we co-sponsored (with World of Wellesley, Wellesley Books, and Wellesley College) an evening with the author of *Give Us The Ballot: The Modern Struggle for Voting Rights in America*, Ari Berman. The program took place at Wellesley College. After a brief presentation by the author, LWVW member and World of Wellesley President, Rama Ramaswamy, moderated a lively discussion with the intimate audience of 36, that included students from Wellesley High School and Wellesley College, as well as LWVW members and others.


LWVW Program Report, continued


We had a very full year of activities for both our members and the wider community, at least twelve events. With so much to relate, we split the report into two sections.





LWVW Voter Service Report

ACTIVITIES AND PROGRAMS




<u>Voter Registration</u>: To encourage voting in FY23's three elections — state primary, state midterm and the Annual Town Election in March 2023 - LWVW held in-person voter registration events at Wellesley Housing Authority sites. Waterstone. and most



Elections: The VOTES Act of June 2022 made vote-by-mail without an excuse permanent. Of Wellesley's 17,505 active voters, 26% voted in the September state primary, 69% voted in the November state election, and 25% voted in the 2023 Annual Town Election. Half of ballots were cast by mail in each election. The LWVW cosponsored three

candidate forums for Norfolk county and Governor's Council primaries and midterm elections. With the availability of Vote by Mail and improved access to public transportation, few voters took advantage of the League's Free Rides to the Polls, organized by Marguerite Chatelier. Lucy Costa organized lawn sign displays with the League logo and reminder to vote.

How to Run for Local Public Office: December 7, 2022 (virtual): featured Mark Kaplan, Moderator (how Wellesley's Town government works) and KC Kato, Town Clerk (nuts and bolts of running for office). The program was recorded and broadcast by Wellesley Media. LWVW publicized a single sheet LWV Candidate Resources 2023 with links to Town of Wellesley 2023 Election Candidate Handbook, Roadmap to Running for Office, Vote411.org and other election-related materials.

Vote411.org Election Guide: Organized by Ann Swanson, Marguerite Chatelier and Mary Crown. Town wide and TMM candidates were profiled in Vote411.org 2023 Election Guide. The online-only Election Guide site went live just before Meet the Candidates Night.

The Election Guide, Meet the Candidates Night election information general

publicized via an all-households postcard mailing, timed to coincide with the arrival of mail-in ballots. Funds for printing and mailing to 9500 Wellesley households were in part covered by generous corporate sponsorships from Jarvis Appliance and Roche Bros. The postcard images were posted on social media, circulated to LWVW publicity contacts and to all TMMs.



LWVW Voter Service Report, continued

Town Meeting Prep Sessions: The LWVW's Town Meeting prep session on March 25, 2023, was organized by Barbara McMahon with technical support from Brian Dupont, Wellesley's Director of IT, and publicized to TMMs by the Town Clerk. Town Meeting prep sessions are intended to be informal and conversational with no formal presentations, allowing for extended Q & A periods. The League coordinator, with input from the Advisory Committee and Town Hall, will:



- Set the agenda, identifying Town Warrant articles of greatest interest;
- Invite proponents of those articles to participate in the prep session;
- Establish a time schedule;
- Moderate the session, fielding questions and keeping time.

Town Meeting prep sessions are well attended. Not only do they help TMMs understand the issues coming before them, but the sessions are also an important tool for the proponents of articles to help understand what questions might come to them on the floor of Town Meeting.

LWVW-authored PUBLICATIONS and Voter Education Projects:

Town Government Handbook 2023: A comprehensive resource for Town Meeting Members, edited by Marjorie Freiman and Gig Babson with input from Town Departments (Fiscal Services, Human Resources, Town Clerk, Moderator) and the Select Board. The LWV sent a PDF of the Handbook to all Town Meeting Members in advance of the 2023 Annual Town Meeting. The Guide's sections cover Town organization and function, Boards and Committees, Town Meeting and the role of Advisory, the financial structure of the Town, personnel motions, how to become a public official, guidelines for committees and guidelines for conduct at Town Meeting. It is posted on the LWVW website and the Town website.

Town of Wellesley 2023 Election Candidate Handbook and Plans for FY 2024: Edited by Erry Johnson, Ellie Perkins and Jenny Zannetos with input from Town Boards, Committees and the Town Clerk. The handbook is designed to encourage participation in town government. Posted on the LWVW's website and the Town Clerk's website.

Voter Education: LWVW Video Project on Town Government: The LWV Video Project group (Lucy Costa, Erry Johnson and Ellen Gibbs, Chair) has partnered with Wellesley Media's Rama K. Ramaswamy and Paul Falcone to produce and film a new video series designed to foster a better understanding and appreciation of the role of our local Town government in the lives of Wellesley residents. Through this video series, we hope to encourage more active participation in Wellesley's town government and engagement on issues we face as a community. The first video provides a great introduction for our League's efforts: "Town Government: Why We Care." The second video, "A look back at Fuller Brook Park," focuses on the Town's Fuller Brook Park restoration project as an example of the collaborative work and results achieved by many Town entities and residents together. In the coming months, the project group expects to identify the topic of the third video, and complete production by year's end. Planning is also underway for the promotion and distribution of the series.

As of April 4, 2023, the League's income year-to-date was \$11,304.60 and expenses totaled \$9,723.20 resulting in a surplus of \$1,581.39. Page 12 shows the actual income and expenses for the current fiscal year as of April 4 as well as this year's budgeted amounts.

- **Interest**, **Bank CD's** interest earned from 1) a \$10,404.72 CD invested for 12 months earning 1.25% and 2) one \$5,234.66 CD invested for 8 months of this fiscal year at 0.65% and, upon maturity, invested in a \$5,500 CD currently earning 4.25%
- **Sponsorship/Donations Vote 411/MTCN/Postcard** sponsorships from Jarvis Appliance and Roche Bros. which helped cover the cost of 1) Vote411.org software, 2) an Election Guide printout available at the polls, 3) Meet the Candidates Night (MTCN) and,4) a town-wide postcard mailing with information about the March 7, 2023 town election and related election information

Expense

- **Meeting Expenses**, **Nat'l /State** these funds are available for the June 10 LWVMA Convention registrations
- **Meeting Expenses, Various Other** expenses associated with the September Social and the *Give Us the Ballot* Community Book Read Event
- **Annual Meeting Workbook** as Workbooks will be emailed, few, if any, expenses will be incurred
- **Board** Zoom expenses. Currently reflects costs through mid-May
- **Contributions/Honoraria** Donation to Northeastern University in honor of Opening Meeting speaker, Professor Wendy Parmet. Board will discuss our annual contribution to the State League at a spring board meeting.
- **Membership/Directory** costs for dues notice mailed in fall. Membership Guide and Directory printing and mailing will likely take place and be billed in June.
- **PMP-National & State** fourth quarter payments of \$812.00 and \$570.68 respectively will be paid this spring.
- Publicity/Outreach reflects annual fee to iContact for monthly newsletter
- **Special/Civic Projects Other** Cost to print and mail a postcard to all Wellesley households notifying them about the town election, MTCN and Vote411.org. Cost was partially covered by sponsorships from Jarvis Appliance and Roche Bros.
- WHS Book Awards book awards for two WHS juniors and two seniors
- **Election Guide/Vote411** cost for 1) Vote411 software and 2) a one sheet Election Guide printed and available at the polls (still awaiting bill for layout work)
- **Handbooks/Election Resources** cost for 1) handouts/publicity for voter registration event at WHS and 2) printing of Town Government Handbooks
- **Meet the Candidates Night** most costs associated with this event were eliminated since event took place virtually
- **Naturalization Ceremonies** ceremonies were not held in Lowell which is where we have supported past events by providing pens and flags so we will not use these funds this fiscal year
- Website cost for MyLo, our website platform, as well as .com and .org domain name fees

Legislative Envoy Report

Legislative Envoys serve as liaisons between their local League and the state's Legislative Action Committee (LAC). We inform local League members about League-supported state legislation and do advocacy outreach to legislators. Highlights of the League's advocacy work in the 2022-2023 legislative session ending are its support of: The VOTES Act that expanded voting access. The permanent improvements include voting by mail without an excuse, addition of early voting options, assurance that eligible incarcerated voters can request a mail ballot, the requirement that the Commonwealth join the <u>Electronic Registration Information Center (ERIC)</u> with 30 other states to keep voter registration rolls up-to-date, and reduction of the voter registration deadline from twenty days to ten.

- The final climate bill which has placed Massachusetts at the forefront of states working for an equitable clean energy future.
- Following the U.S. Supreme Court's overturning of Roe v. Wade in June 2022, the legislature's swift codification of protection for Massachusetts abortion providers, access to a full spectrum of pregnancy care, and making medication abortion available at public universities.
- The bill providing drivers' licenses for undocumented immigrants, which passed over the Governor's veto.
- Several basic human-needs bills that became law, including protection against students being denied hot lunches or having action taken against them due to meal debt, increased assistance to the poorest families, and establishment of a secure common application portal for all state-administered needs-based benefits and services.
- Provisions ending child marriage in the state passed as a budget amendment.

As of March 2023, the League is supporting the following bills in the 2023-2024 session: the Common Start bill to increase funding and support for childcare and early education—this bill passed in the Senate but stalled in the House last session; a bill to require public meetings which are subject to the open meeting law to include remote access and participation, as adopted during the pandemic; a bill to provide same-day voter registration that was dropped from the VOTES Act in 2022-23.



LWVW Newsletter. Our iContact newsletter is emailed approximately once per month, usually in the week following a board meeting. Currently, 207 contacts consisting of 138 Wellesley League members/students, 69 League Friends and 7 media and/or town organizations (e.g., *Swellesley Report*, *Townsman*, Wellesley Media, Executive Director's Office) are receiving the newsletter. About 60% of the newsletter recipients open it each month. This is more than double the industry average for email newsletters. We also use iContact (and/or Evite) to publicize specific Wellesley League events, such as Opening Meeting, "Meet the Candidates Night" and our Zoom Coffees and Book Club events.

- Our Instagram is updated with Facebook once every few weeks, usually for our League or League-sponsored events.
- Instagram stories (temporary 24 hour posts) are a great tool for reminders and provide convenient access to links for sign ups or websites.
- The Instagram account has gained traction among the Wellesley High School community. High school teachers and students repost our graphics, especially ones about the Town Election.
- Steady monthly increase of accounts reached (people who see the posts) and accounts engaged (people who react to the posts such as liking, commenting, or sharing).
- Average of 2-5 likes per post to average of 12-15 likes per post in the span of 8 months.
- Followers increased from 102 to 120 in the span of 8 months, 7 of them are Wellesley High School students or faculty.
- Average post engages 30 followers and 30 non-followers.

Treasurer Jenny Zannetos affirmed that there was a quorum in attendance.

1. Welcome and Meet Overview

Co-President Laura Brown-MacKinnon called the LWVW Annual Meeting to order at 7:03 P.M. She acknowledged the tragedy of gun violence and reminded attendees that the LWV has worked for decades with law enforcement and state officials to educate the public regarding the dangers of gun violence and to provide comprehensive recommendations for legislative reform, and that the work continues She also listed the LWVMA programming priorities of:

- Fostering and promoting civic engagement,
- Improving voting access for elections,
- Addressing the climate emergency,
- Advocating for equitable access to basic human services.

Laura next explained that in order to continue advocating for justice, the LWVW Board of Directors voted in October 2021 to begin each meeting with a Land Acknowledgement. The following is the Wellesley College Land Acknowledgement as found on their website:

We acknowledge that Wellesley is built on ancestral and traditional land of the Massachusett people. We also recognize that the United States' removal, termination, and assimilation policies and practices resulted in the forced settlement of Indigenous lands and the attempted erasure of Indigenous cultures and languages. We further acknowledge the oppression, injustice, and discrimination that Indigenous people have endured and that there is much work to be done on the important journey to reconciliation. We commit to strengthen our understanding of the history and contemporary lives of Indigenous peoples and to steward this land.

We further recognize the many Indigenous peoples living here today—including the Massachusett, Wampanoag, and Nipmuc nations—who have rich ancestral histories in Wellesley and its surrounding communities. Today, their descendants remind us that they are still here, where they maintain a vital and visible presence. We honor and respect the enduring relationship between these peoples and this land, as well as the strength of Indigenous culture and knowledge, the continued existence of tribal sovereignty, and the principle of tribal self-determination.

Co-President Wendy Garber offered an overview of the Annual Meeting agenda, noting that Roberts' Rules of Order will be followed per the LWVW by-laws, with Ellen Hallet acting as the meeting parliamentarian. Wendy listed four action items that will be addressed at this annual meeting:

- 1. Formation of the Committee of Three to review the annual meeting minutes,
- 2. Election of FY 2023 LWVW Officers, Directors, and Nominating Committee Members with amendments,
- 3. Adoption of the Proposed FY 2023 Budget,
- 4. Adoption of the Local Program with amendments.

2. Formation of the Committee of Three to review the Annual Meeting Minutes

Per tradition, a committee of three members will review the Annual Meeting minutes, taken by secretary Bonny Nothern. Virginia Ferko, Erry Johnson, and Jenny Zannetos volunteered to review the minutes.

3. Election of FY 2023 LWVW Officers, Directors and Nominating Committee Members LWV Wellesley Board 2022-2023 (proposed, see next page)

VOTED: to accept the slate proposed by the Nominating Committee and the current LWVW Board of Directors, with the addition of Ivy Wang as Director of Social Media.

A request was made to the membership to step forward to fill the open positions of Co-President, Event Publicity, Voter Services—Candidates Guide Editor, and Legislative Envoy.

- Projected income: \$14,895.75 from dues, donation, fundraising, investment income, and Phonathon proceeds.
- Projected expenses: \$XXXX including Per Member Payments (PMP) to national and state Leagues, operating costs such as venue fees and other program costs, Voter Services costs such as outlays for participation in naturalization ceremonies, website fees and other publicity costs.

A brief explanation of the purpose and importance of the Local Program was offered.

VOTED: To adopt the LŴVŴ Local Program, as amended.

6. Highlights from Annual Reports

<u>Voter Service</u>: Erry Johnson offered thanks to the following:

- the Vote411 Team of Ann Swanson, Marguerite Chatelier, Ann-Mara Alanza, and Mary Crowne.
- Barbara McMahon for organizing the Town Meeting Prep sessions and managing the lawn signs
- Gig Babson, editor-in-chief of the Town Government Handbook
- Marjorie Freiman for writing a new section of the Town Government Handbook
- Jenny Zannetos and Wendy Garber for editing the Candidates' Handbook
- Irene Flint for providing historical information about the League of Women Voters and the LWVW.

Erry further acknowledged that FY 2023 will be challenging due to the mid-term elections in November 2022. She reminded the membership that LWVW will co-sponsor candidate events in down-ballot races with other local Leagues. She reported that LWVUS will consider a by-law change at the up-coming national conference in Colorado which would eliminate the age restrictions around being a voting member of the League. They will discuss prioritization of a position that was adopted 52 years ago supporting the abolishment of the electoral college. She also outlined the FY 2023 Voter Services calendar. Wendy highlighted the recent consolidation of the Voter Services Steering Committee.

Programs: Marguerite Chatelier and Ann-Mara Lanza reviewed the following FY 2022 events:

- Opening Meeting featuring speaker Cathy Bueker, professor at Emmanuel College speaking on her research on immigration and citizen involvement.
- Three coffees addressing education, environment, and social issues including the debt exclusion vote for the elementary school building projects, the town water issues regarding PFAS and ground water run-off, and the role of land acknowledgements in recognizing the injustices done to Native Americans.

<u>Video Project:</u> Ellen Gibbs described the video series project which is part of voter education under Voter Services. The first video, "Why Town Government Matters", is in production. It is being produced by Rama Ramaswamy, and filmed and edited by Wellesley Media. The goals of the project include:

- improving voter literacy regarding Wellesley town government,
- increasing civic connection, empowerment, and engagement,
- and promoting more active participation in town government and elections.

7. Directions to the Board

There was a discussion of what responsibility LWVW has for fact checking candidates' self-reported credentials. The LWVW candidate events are not debates but are rather opportunities for the public to hear the candidates speak and to become educated about the information the candidates provide about themselves. The consensus was that no fact checking is planned at this time but a disclaimer will be emphasized regarding the role of the LWVW in providing a platform. Appreciation was expressed for LWVW's support for the recent successful Accessory Dwelling Unit by-law initiative.

8. Closing Remarks

Wendy Garber offered a memorial tribute to recently deceased LWVW member Catherine Johnson. Catherine was described as a beloved member of the League community who acted as a one-person Observers Corps providing updates on the activities of the Wellesley Planning Board, as well as providing much-valued counsel to the LWVW.

9. Adjournment

Wendy expressed her thanks to outgoing Co-President Laura for a wonderful year. The next Board Meeting will be in-person and virtual on June 14, 2022 12:30—2:30 p.m. at the home of Wendy Garber.
