7:00 pm -- Potluck Dinner

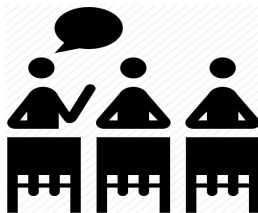
7:45 pm -- Call to Order for Annual Meeting

League of Women Voters of Massachusetts 2017 Convention The Future of Democracy: Facing the Challenges

LWWV Delegates President Susan Clapham, Vice-president Anne Rippy Turtle and incoming Secretary Ellen Hallett attended the Convention on April 28 and 29 at the Sheraton-Framingham Hotel.

Distinguished speakers were

Brian McGrory, Editor, *The Boston Globe*, discussing the media's role in the face of criticism and fake news

Wylecia Wiggs Harris, Ph.D., LWWUS Chief Executive Officer discussing the League's "Impact, Engagement, Sustainability" and

Rachel F. Cobb, Ph.D., Chair and Associate Professor of Government at Suffolk University discussing how grassroots organizations can respond to threats to democracy.

State Study: A new state study of the ballot question process in Massachusetts will be conducted over the next two years. It is anticipated that local League consensus meetings will likely take place in the fall of 2018 through early 2019 leading to a position presented to convention in 2019.

New Co-presidents elected: Mary Ann Ashton, Acton Area League, and Linda O'Connell Springfield unit of the Northampton League, will serve as LWWMA co-presidents for 2017-2019.

Other League business included electing officers and a new board, setting priorities and action items for the next two years, and approving a new position on charter schools.
