Public Forum: MBTA Communities Requirements 11/30/23

In response to our state's housing crisis, the State passed legislation in 2021 that requires each community with access to mass transit, to create zones where multifamily housing can be built. Why is this an important State initiative? How is Wellesley responding to this new requirement? Where will these multifamily zones be located? What changes will we need to make to our current zoning? Wellesley is facing the 2024 deadline to comply. Meghan and Eric will share their draft plan, answer questions, and solicit comments from the community. The Town goal is to submit the plan for approval at the March 2024 Annual Town Meeting.

Legislative Progress

As of mid-November, most of the 173 bills that are being followed by the LWVMA legislative specialists had hearings before the relevant committees. We are now expecting a major uptick in action in January, especially before the February 7 reporting deadline (though committees may request and are often granted additional time). As we are asked by the state league to contact our state legislators (Rep. Alice Peisch and Sen. Cynthia Creem) to support specific bills starting in January, we will reach out to our Wellesley chapter members who have expressed interest in those areas of legislation to do the same. It is important that we reach out to our legislators as soon as we are asked; and that we personalize our communication to our legislators as much as possible, though any communication is better than none. We look forward to a flurry of advocacy activity continuing through the spring and summer of 2024 with a rush to the finish line by the end of the formal session on July 31, 2024.
