This year, you can exercise your right to vote several times.

- --The Presidential Primaries (in NY State) take place Tuesday, April 28, with early voting available April 18-26.
- --The White Plains School District Vote and School Board Election is Tuesday, May 19, noon-9 p.m. (no early voting).
- -- The Congressional Primaries are scheduled for Tuesday, June 23, with early voting June 13-21.
- --The General Election is Tuesday, November 3, with early voting Oct. 24-Nov. 1.

# Vote 18 Underway

Vote 18 is one of the most popular activities of our League and plans are well underway for this year's high school registration initiative. League members will visit classes at Stepinac High School and Woodlands High School in early November to inform students about voting rights history and contemporary issues and to register them to vote. (White Plains HS handles voter registration through the social studies department.) Our Vote 18 program is earlier than usual this year because we wanted to make sure that students who will be 18 by the April presidential primary will be eligible to vote and then also to be able to vote in upcoming school board budget votes and in the Congressional primaries in June. New NYS legislation also allows for the registration of 16 and 17 year olds in an effort to expand those eligible to vote as they come of age. So we have lots to talk about with students.

We have 16 members signed up to do this important work and will report back to our membership about our experience and results.

#### HIGHLIGHTS OF THE JANUARY 2020 COMMON COUNCIL MEETING

The White Plains Common Council held its regular monthly meeting on January 6, 2020. The new councilmembers were sworn in, and Nadine Hunt-Robinson was chosen as council president.

At this meeting, the council postponed a public hearing on a cabaret permit for Z Steakhouse to February 3, and set one for that date for Sunset Restaurant as well. It also took the following actions: Approved about \$84,900 in tax refunds due to reduced property assessments and accepted grants of \$189,000 for youth programs and \$190,000 for substance abuse prevention services.

- Decided to use a profit of \$42,000 from the sale of a foreclosed apartment for debt service.
- Lowered the speed limit to 20 MPH on a section of South Lexington Avenue.
- Approved the WP Hospital's walkway over Longview Avenue and extended several site plan approvals.

The council also held a special meeting on December 23, 2019, to approve eliminating the retiree's share of the cost of health benefits for retired firefighters who are over the age of 70, or can demonstrate financial hardship.

At the Citizens to be Heard session before the meeting, a citizen spoke about damage to her oil tank potentially caused

by city trucks.

#### **FUND BALANCES, DEBT UP IN WHITE PLAINS**

The City of White Plains's comprehensive annual financial report (CAFR) covering the fiscal year July 1, 2018, to June 30, 2019, has good news. The city's total fund balances as of June 30, 2019, were \$44.2 million, an increase of \$7.0 million from June 30, 2018. \$33.1 million of the total was committed or restricted for particular purposes, leaving an unassigned fund balance of \$11.1 million, up \$6.3 million from a year earlier. This despite debt increasing to \$161.9 million from \$151.9 million. An additional \$43.1 million of borrowing had been approved by year-end. Excluded from the debt total is \$667 million of post-retirement benefits accrued as a liability.

While that is plenty of long-term debt, in the short term things are much more manageable. Cash and cash equivalents of \$101 million as of June 30, 2019, was more than adequate to pay current liabilities of about \$38 million.

Revenue was up \$9.5 million from the prior year. Grants accounted for about \$1.7 million of that increase. Charges for services increased almost \$4 million, most of that being due to building permit fees, and taxes produced an additional \$2 million compared with 2017/18. Investment earnings increased \$1.1 million while sales tax revenue increased \$39,000. In comparison to the budget, General Fund revenues were about \$3,000,000 higher (excluding restricted sales tax). Again, that was largely due to building permits and interest income. At the same time, General Fund expenditures were \$9.1M below budget. They increased \$1.4 million from 2017/18.
