# Girls Expert Addresses the LWVCA at February Meeting

"Although girls represent a small proportion of detained youth, more girls are entering detention and they are entering with needs that are significantly different than those of boys," said Susan Alford, the director of The Girls Center at Clemson University. Alford spoke to the League of Women Voters of the Clemson Area at their monthly meeting on Tuesday, February 17, 2009.

The former deputy director for policy and planning at the South Carolina Department of Juvenile Justice (DJJ), Alford described a system that was ill-suited to addressing the complex needs of girls before recent reforms at DJJ. "Boys still far outnumber girls in the juvenile justice system so it is not surprising that services – community-based and institutional -- are geared to the needs of boys," noted Alford. The recognition that serious issues of gender inequity existed for girls in custody at DJJ led Judge William Byars and his staff to implement reforms aimed at providing girls with a safe, secure and responsive

environment. Girls Circles, where girls can talk about their issues with other girls, and a transition center, where girls can live for up to six months before their release and learn everyday tasks associated with living independently, were among the gender responsive services that were implemented to better serve girls in the DJJ system.

Alford urged League members to consider ways in which they can become involved in strengthening policies and programs for girls across society. Such actions might include raising awareness, helping girls to access job training, comprehensive health care and better educational opportunities, and serving as role models for young women.

The semi-annual LWVSC book group met on Saturday, February 21st for a potluck lunch and a discussion of Harriet Keyserling's *Against the Tide*. The seven members present enjoyed the trip down memory lane with a recounting of tales of the General Assembly and state politics from 1976 to 1992 when she served in the legislature. Harriet Keyserling, a founding member of the Beaufort League, left a lasting impact on state policy in many areas, including education, the arts, and restrictions on the use of filibusters that enabled bills to more forward more quickly.

The book selection for this next fall is George Lakoff's *don't think of an elephant*, which draws on linguistics and family systems to explain how public issues are framed and how people perceive and respond to issues through their particular conceptual framework. For those of you who find this short book just an appetizer, feel free to go on to his longer book, *Moral Politics*.

### A Report on the Meeting with the Oconee County Legislative Delegation

The Oconee County Legislative Delegation met on February 5<sup>th</sup> in Walhalla. A number of individuals attended the session to voice their concerns on a variety of issues. George Blanchard, from the Oconee County Council asked the delegation to be more conservative in its estimates of County Aid. He noted that the counties depend on the Local Government Fund which makes up to 4.5% of the State Budget. For Oconee County, state funding amounted to \$3.6M in last year's budget. However, Oconee County had received mid-year cuts amounting to almost \$270K. Blanchard said "When cuts come after the fact, it is difficult. It is easier if you give us a conservative figure with which to build the budget."

Several citizens, including Blanchard, urged the lawmakers to raise the tax on cigarettes as a way of funding health care costs and Blanchard urged \$.05/gallon increase in the state gasoline tax to be used to upgrade roads and bridges. He also suggested taxing the full price of automobiles instead of the current \$300 cap. Representative Sandifer said a current proposal would designate a revenue stream for this infrastructure without a tax increase. Both Sandifer and Senator Alexander said that current proposals under consideration would also look at curtailing some exemptions from the state sales tax as a means of raising revenue. Representative Sandifer said that in 2010, we will be back to where we were in 2005.

Reggie Turetzky, representing LWVCA, urged the legislators to "rethink the tax system" and make it more stable and to distribute the burden more evenly. Act 388, in particular, which tied school funding to the volatile sale tax revenue, needs to be reconsidered. Revenue shortfalls from initial projections have led lawmakers to cut nearly \$250M from the state budget for education over the past few months.

Ben Turetzky, representing FOLKS, urged that the state enact a Comprehensive Water Policy as soon as possible and noted that it is necessary to put South Carolina on an equal footing with Georgia where such legislation is already in place. He also recommended passage of the "Fare Share Water Bill" currently before the Senate as a start on a Comprehensive Water Law. Representative Bowen said that current plans include passing such legislation and also merging DHEC and DNR so that water issues are under one agency, as in Georgia. The objective is to prevent South Carolina water from being transferred to Atlanta.

Gerry Allen, representing the Oconee Guardian Ad Litem (GAL) program said that in Oconee County, 60 GALs represent 556 children. Approximately 1,500 GALs in South Carolina devote at least 70,000 hours per year, thereby saving the state upwards of \$1.0M compared to using private GALs. She urged the delegation to fund the program so it can remain because in the long run, the program saves the state so much and helps so many abused and neglected children.

# An Announcement of the Consensus on the National Popular Vote Compact

The National Popular Vote Compact (NPV) is an agreement among states where the member states give their electoral votes to the candidate with the greatest "national popular vote total." Reform of the Electoral College in order to elect the president by popular vote requires an amendment to the Constitution. The NPV accomplishes direct popular election without changing the Constitution. The compact specifies that it shall take effect only if it is law in states controlling a majority of electoral votes on July 20 of a presidential election year.
