The League and the Progressive Women of Anderson County are cosponsoring a candidate forum at 6 p.m. at the main Library in Anderson. If you would like to help, let me know. If you live in that district, be sure to attend and invite your friends and neighbors.

We also have an opportunity to do voter registration at Jazz on the Alley in Seneca. It's on Thursdays t 6:30 starting April  $6^{th}$ . If you would like to help with that, just let Holley or Eleanor or Cheryl Lee know.

But we also need to be informed, to discuss issues and advocate on well thought out positions. Come to one of our two daytime groups, the environmental group on the first Tuesday at 10 or the good government group on the second Tuesday at 11:45. We have our regular meetings at OLLI on March 21<sup>st</sup> (child welfare challenges) and April 18<sup>th</sup> (small towns in the Upstate and their achievements and challenges).

And if that's not filling up your calendar, there's the wine tasting on April 1<sup>st</sup> and a bunch of us going to state convention in Columbia April 29<sup>th</sup> and 30<sup>th</sup> and our annual meeting at Occasions on May 9<sup>th</sup>. So we expect to see a lot of each other in the next two months!

## March General Meeting

Few things move us more than the issue of child welfare and what we can do to keep our children safe. However, that issue often is less prominent in our news than tax cuts, health care, and roads. Even nationally, we do not seem to prioritize child welfare issues.

Our program this month focuses on child welfare priorities for SC Department of Social Services. After speaking with Directors from Anderson and Oconee Counties, I had a great conversation with Karen Wingo, State Director of Communications and Legislative Affairs. Members of the State DSS team will be joining us to discuss how we can advocate for, and be more aware of, issues facing our state's children. Jim Casserly, the statewide Foster Care Recruitment Coordinator, will be part of the presentation team to tell us how we can help with the 4,000 SC children in foster care.

I have asked DSS also to discuss some of the challenges facing elder care, the standards, and the reporting criteria. We need to be aware of our other most vulnerable population and how we can help prevent and report any elder abuse or neglect we may witness.

The League platform has long included advocating for our next generations. March's meeting will focus on DSS's priorities for our children and how the League can become more active in our advocacy. There will be plenty of time for discussion and questions.

## Issues Groups - Good Government

Our monthly meeting of the good government group is Tuesday, March 14th at 11:45 in the small room at Western Sizzlin'. We have four issues on the agenda that offer opportunities to act.

1. There is a local election in Anderson County, including the Pendleton Area, in early April with eight Republican candidates vying for the Senate seat vacated by Kevin Bryant. We are helping with a candidate forum on March 14th. There is also a school district bond referendum in May for Anderson 4.

2. There is legislation introduced to change the way we redistrict.

3. There is legal challenge in the matter of the Richland County Recreation Commission on which the League was asked to file an amicus brief based on our home rule position.

4. Frances Rundlett has alerted me to the opportunity to get involved in boards and commissions. She just got appointed in Oconee County! For counties, some appointments are made by the county council and some by the legislative delegation. For cities, appointments are made by county council. We need volunteers to inquire about openings (I know there is one on the election commission in Oconee) and how one applies or seeks consideration. Think about whether you would be interested in an appointment or if you are just willing to inquire about the process in one or more of our three counties. I think municipalities generally do it in December and January, but it would be good if we could arrange to be notified of vacancies.

## Tour of Clemson University SCG&E Energy Innovation Center Thursday, April 6th

Our League of Women Voters of the Clemson Area and the Foothills Sierra Club are cosponsoring a tour of the **Clemson University SCG&E Energy Innovation Center** in North Charleston on Thursday, April 6th from 1 p.m.- 4 p.m. The Center was introduced to our LWV members last May at our annual meeting by Dr. Imtiaz Haque.

The Energy Innovation Center (<u>http://clemsonenergy.com/about/</u>) houses the world's mostadvanced wind-turbine drive-train testing facility capable of full-scale highly accelerated mechanical and electrical testing of advanced drive-train systems for wind-turbines. The Duke Energy eGRID — Electrical Grid Research Innovation and Development — Center is housed in the SCE&G Energy Innovation Center. The 15-megawatt hardware-in-the-loop grid simulator supports education, research and economic development to speed new electrical technologies to market. The eGRID can simulate the electrical grid of any country in the world.

Jim Tuten, Facilities Director, will begin the program at 1 p.m. in Room 201 of the new Zucker Family Graduate Education Center. Mr. Tuten will present an overview of the development and work being done at the Center. A tour of research facilities will follow.

The tour is limited to the first 50 people who sign up prior to March 24th. Attendees do not need to be a LWV or Sierra Club member, so guests and spouses are welcome. #### Youth Voter Registration Project

The League of Women Voters of the Clemson Area has received a grant from the League of Women Voters Education Fund to support Youth Voter Registration. This is aimed at high schools, colleges, and vocational schools for the purpose of engaging young people in our electoral process. There will be particular emphasis on minority students, the poor, and new citizens coming to the United States. This must be done in a nonpartisan fashion.

Our goal is to register students in our local high schools in the Tri-County Area, Clemson and Anderson University students, Tri-County Technical students, and several community events. We will offer registrations to new citizens, clients at Clemson Community Care, the elderly at local facilities, Jazz on the Alley in Seneca, and other venues.

There will be follow-up educational programs and efforts made to keep records on our newly registered potential voters. There will also be support from the LWV Education Fund in the way of webinars and training manuals.

We are looking forward to a successful spring registration effort and we will need all members to pitch in for this to be implemented.
