## LWVCA March General Meeting Tuesday, March 23

The March meeting is a week later than usual (March 23, the 4<sup>th</sup> Tuesday, instead of the 3<sup>rd</sup> Tuesday) because of Clemson University's spring break. We are going to talk about South Carolina's broken tax system and the further injuries it may be suffering in this year's legislative session. Point of sale was stopped, barely; proposed further property tax relief is probably on hold; and we hope that the proposed elimination of the corporate income tax will not go anywhere, at least for now. By the 23rd we may know if they are going to finally increase the cigarette tax. The Tax Realignment Commission is asking good questions, so there is hope!

I know that taxes aren't your favorite topic, but they are the way we pay for the things you care abouteducation, roads, corrections, children's services and programs. So please come listen, learn, ask questions, and be prepared to talk to your legislators (and later in the year) candidates. They need to hear from people whose top priority is not their personal pet tax break, but who care instead about public services in South Carolina.

# **LWVCA Candidate Forum** for the Clemson City Council

A standing-room-only crowd attended our candidate forum for the Clemson City Council special election at the Central-Clemson Library. May "Crossie" Cox, Pamela June Hay and Jessica E. Robinson answered questions about rental housing ordinances, preserving neighborhoods, recycling, development, sidewalks and other concerns. The winner of this election will fill the Clemson City Council seat vacated by the resignation of Elouise James. This term runs through 2012.

Janie Shipley welcomed the crowd in the name of the League and explained the League's non-partisan support of an informed electorate. Dianne Haselton moderated with assistance from Alice Flower (timekeeper), Bill Hare, Aleta Robinson, Frances Plotnik, Carol Ward and Eleanor Hare.

**The Election**: In the election on February 9, Cox received 377 votes, Hay 362 votes and Robinson 133 votes. Since no candidate received a majority of the votes cast, a runoff was scheduled for two weeks later. Only 872 of the 6564 registered voters in the City of Clemson turned out to vote. The turnout was approximately 13.3%.

**The Runoff**: In the runoff on February 23, Cox received 530 votes and Hay received 399 votes. Although the turnout for the runoff was higher than for the election, the turnout was still only slightly higher than 14%.

State council is held between state conventions in even numbered years. It's a good chance to meet people from other Leagues and learn more about important statewide issues.

# LWVCA February General Meeting The ABC's of Advocacy

The ABC's of Advocacy was the topic of the February LWVCA Meeting. The presenters, Janie Shipley, Eleanor Hare and Paula Appling talked about how to become a voter, the importance of getting the facts pertaining to issues of interest, and how to advocate effectively. Shipley reported on recent voter issues tracked by LWVCA, including the recent US Supreme Court decision on financing of elections, the Voter ID Bill in the SC Senate, and registration by party. Handouts listed useful websites.

Below are some tips for being an effective advocate. Before forming an opinion about any legislation, learn the "who", "what" and "why" of it. Realize that there is almost always more than one side to a story, and try to determine how each interested party views the legislation.

- Establish a rapport with legislators. Keep up with how they vote. Express your reaction to those votes on issues in which you are interested.
- Attend political functions and fundraisers in the district.
- Get personally involved in your legislator's election campaign.
- Consider hosting a fundraiser in your home or local meeting place.
- Get to know the legislator's families and about their life outside of politics.
- After developing a personal relationship, invite your legislator to social functions.

When preparing a visit with a legislator:

- The best time to contact and work with your legislator about a new proposal, request, or a change in an existing law is July through mid-December, when the legislature is out of session.
- Most Effective: Personal visit and take a friend or two, more if available
- Next Most Effective: Personal phone calls and/or well written one-page letters
- Least Effective: E-mails, unless the legislator says they prefer e-mail.
- Write or call before you visit. You most often must take the initiative with additional communications

# The 2010 Oconee County Legislative Delegation

The Oconee County Legislative Delegation met on February 8, 2010 at the Depot in Westminster. The entire delegation was present: Senator Alexander, Representative Whitmire, Representative Sandifer and Representative Bowen. The room was packed and some citizens had to stand.

The first to speak was Polly Nicolay, who ran against Senator Alexander in the last Republican primary. She wants the delegation to reform Home Rule or end it. She believes that public education has failed because the system must get back to biblical values and there has been a moral decline since prayer has been taken out of the schools.

Next, Ed Rumsey, the former Republican Chairman of Oconee County, urged the delegation to consider voting for S.520, the "Education Opportunity Act."

A citizen reminded the delegation that SC cigarette tax of seven cents a pack is the lowest in the nation and must be corrected and increased. Senator Alexander said that a special order will bring the issue to the legislative forefront this session.

The next speaker was Reggie Turetzky, who spoke on behalf of the LWVCA. She reported that the LWVCA supports H.3748, which would retain the current index of taxpaying ability used to distribute EFA funds to school districts, but recommended that an expert group be convened to suggest adjustment in light of the impact of Act 388 on school district revenue. LWVCA is opposed to H.3272, the pending Point of Sale legislation and is strongly opposed to H.3418 which requires a photo ID for voting. LWVCA supports S.452, Water Withdrawal Permitting. This is a critical element which will start leveling the playing field between neighboring states with which we must come to agreement over the important water issues facing us.

Ben Turetzky, Executive Director of Friends of Lake Keowee Society (FOLKS), asked the delegation to push for a state water management plan to put SC on an equal footing with neighboring states with whom we have to deal, particularly involving withdrawal of surface water.

Representative Bowen said that getting a state management plan in place was a priority this session, especially in view of the Lake Lanier Federal Court decision last year that will block Atlanta from using Lake Lanier as a water supply. "We need to get a plan in place before Atlanta comes knocking on our door," Bowen said. Representative Bowen is working with the Brigadier General to get 12 legislators from South Carolina and 12 legislators from Georgia to work together with the US Army Corps of Engineers as a water commission.

George Cleveland asked the delegation to request the Unemployment Commission to shift help to employees and not the employers. Representative Sandifer said there is pending legislation to restructure the State Employment Security Commission (ESC), eliminating the role of the Commissioners and shifting more of their functions to the administrative law courts. The restructuring will also change the manner in which the employment taxes that fund the agency are collected and used. Sandifer also noted that the legislature faces the challenge in preparing the state to begin paying back the \$700 million loan to the federal government that enabled the ESC to continue paying benefits after its own funds were exhausted. "Every state, except for three, has that challenge," he said.

# The 2010 LWVCA Annual Meeting

We are delighted to announce that Dr. Esin Gulari, Dean of Clemson University's College of Engineering and Science, will be the keynote speaker at our Annual Meeting. She will speak about her trip to Antarctica.

Dr. Gulari is the first and only South Carolinian to sit on the National Science Board (NSB), the governing board of the National Science Foundation (NSF) and policy advisors to the President and Congress. As a member of the NSB, she was invited on a site visit to Antarctica to observe the research projects that NSF is supporting and to learn about the logistics associated with these projects.

Dean Gulari was impressed with the harshness of the Antarctic environment and the need for scientists to collaborate. She visited the Crary Science and Engineering Laboratory at McMurdo Station and the new Amundsen-Scott South Pole Station. She took a helicopter tour of the dry valleys on Ross Island and visited some remote research sites.

To get to her destination, Dean Gulari was on commercial flights to Christ Church, New Zealand and on military flights to McMurdo and South Pole Stations. In summer at McMurdo Station, the temperature may be only 15 or 20 degrees Fahrenheit but at the South Pole, three and a half hours away by plane, at an altitude of 10,000 ft, temperatures drop to -20 degrees. Hercules aircraft landing at the South Pole keep their engines running while the planes are reloaded for return to McMurdo. The planes have skis for landing on ice and snow at the South Pole.

A Few Research Projects: Dean Gulari made special mention of three NSF-sponsored projects: Project IceCube, the South Pole Telescope, and exploring the underside of the Ross Ice Shelf.

Many scientists in Antarctica are searching for neutrinos (high-energy subatomic particles created by galactic collisions), cosmic rays, and a host of exotic particles. NSF-sponsored Project IceCube, a cosmic neutrino observatory located far below Antarctica's ice, consists of strings of light-sensing modules frozen deep in crystal clear Antarctica ice. Neutrino research helps scientists understand the origins of matter.

The NSF-funded South Pole Telescope is 10 meters in diameter. Its primary scientific goal is to find clusters of galaxies and research dark energy. (Dark energy is the most popular way to explain recent observations that the universe appears to be expanding at an accelerating rate.)

Near McMurdo, a project exploring the world under the Ross Ice Shelf hopes to discover more about how the West Antarctic Ice Shelf has responded to past climate changes. Researchers know that old ice (the ice shelves) has been decreasing in size, but more data is needed in order to determine the cause(s) of this loss.

Research at the South Pole is unique. This area is isolated from the rest of the world and not contaminated by interference from electromagnetic signals, atmospheric pollutants, and, even, noise.

More of Dean Gulari's Blog: Dean Gulari's blog from her trip includes photos of wildlife (Adèlie penguins, a red starfish attacking a scallop, a giant isopod, skuas) and a seismometer recording volcanic activity at Mount Erebus (near McMurdo). She also included notes and photos related to the exploration of Antarctica by the British Royal Navy's Captain Robert Falcon Scott (1902) and Ernest Shackleton (1907). In Clemson tradition, there is a picture of Dean Gulari standing in front of a sign at the South Pole and displaying a "tiger rag." #### **Proposed By-Law Changes**

(Members are asked to read and be ready to vote on proposed changes during the Annual Meeting on May 10, 2010)

#### Current wording:

**Article II. Purposes and Policy** 

**Section 2. Policy.** The LWVCA shall not support or oppose any political party or any candidate.

#### Proposed Addition:

**Add to Article II. Section 2. Policy.** LWVCA shall be a 501(c) (4) nonprofit entity. This

designation allows LWVCA to lobby and donations are not tax-deductible. The League of Women Voters Education Fund (LWVEF) is a 501(c) (3) non-profit entity. Donations to the LWVEF are tax-deductible. (Justification: Denotes tax status).

#### Current wording:

**Article VI. Meetings. Section 2. Annual meeting.** The annual meeting of the membership shall be held between March 31 and April 30, the exact date to be determined by the board of directors.

#### Proposed change:

Change Article VI. Meetings. Section 2. Annual meeting. to read: The annual meeting of the membership shall be held in the second quarter of the year, the exact date to be determined by the board of directors. (Justification: Allows more flexibility for the annual meeting date)

#### Current wording:

Article VIII. Program. Section 3. Action by the annual meeting. The annual meeting shall act upon the program using the following procedures.

a. The board of directors shall consider the recommendations sent in by the voting members two months prior to the annual meeting and shall formulate a proposed program.

#### Proposed Change:

**Change Article VIII. Program. Section 3.** a. to read: The annual meeting shall act upon the program using the following procedures.

a. The board of directors shall consider the recommendations for the local program proposed by the Program and Action Committee, after receiving recommendations from voting members during the January program planning meeting. The board of directors shall receive recommend-dations two months prior to the annual meeting and shall formulate a proposed program.
