Have a wonderful summer, and be ready to start another good League year in the fall.



CANDIDATES FORUMS

The League of Women Voters of the Clemson Area will hold a series of candidate forums for citizens to hear from individuals running for the General Assembly and for sheriff in the June 12th primary. The first forum for Pickens County is on Monday, May 21st at 7 p.m. at the Clemson Central Library. This forum will feature House District 3, where incumbent B.R. Skelton will face challenger Ed Harris. Senator Thomas Alexander, who is running unopposed, has been invited to make a brief presentation. The second forum on Tuesday, March 29th from 6:30 to 8:30 p.m. at the Easley Public Library will present the five Republican candidates and one Democratic candidate for Pickens County Sheriff. The final forum for SC Senate Seat 2 and House District 4 will be held on Monday, June 4th from 6:30 to 8:30 p.m. at the Easley Public Library. Senator Larry Martin and his challenger Rex Rice, and Representative David Hiott and his challenger Vicki Wynn will speak and answer questions. Representative Philip Owens, who is running unopposed for the 5th House District, will also make a brief presentation.

Other forums will be held for Oconee County candidates (see schedule above). The public is encouraged to attend and to submit written questions for the candidates.

Youth Voter Registration Project

The youth voter registration project is close to completion with 459 high school students registered so far by our intrepid team of Eleanor Hare, Paula Appling, Linda Gahan, Cheryl Lee, Frances Plotnik, Cheryl Stevens, Aleta Robinson, Mary Ann McKenzie, and Carol Kozma. Students were registered at West-Oak, Tamassee-Salem, Easley, Daniel, Seneca and Walhalla High Schools as well as the Hamilton Career Center. Pickens High had already conducted its own voter registration, and Liberty High will be a joint effort of the League and the Pickens County Election Commission. Students who registered received "Registered Voter" stickers, and other students received "Ready, Set, Vote" stickers. They also received business-sized cards with primary and general election information and web sites. We are also conducting a voter registration at Clemson Community Care on May 5th in conjunction with the Manna truck. The youth voter registration is a part of a national League effort to register young and especially minority voters. We received a grant of \$300 that was spent on the stickers and cards. Thanks to everyone who was a part of this important effort!

On April 19th, the LWVCA cosponsored a forum for the Oconee County Sheriff with the Seneca Journal, Anderson Independent Mail, WGOG and the City of Seneca. It was held at the Gignilliat Center in Seneca. The forum opened with statements from each candidate, then a question period from the press, followed by written questions from the floor and finally, a closing statement. Paula Appling served as moderator. The candidates participating were: James Bartee, Mike Crenshaw, Donnie Fricks and Terry Wilson. Reggie Turetzky organized the event, welcomed everyone and presented the forum ground rules. Sandra Gray was the timer. Lyn Norton, Pam Fjeld, and

Janie Shipley passed out candidate sheets with their bios and responses to questions posed in advance by the LWVCA. They also collected questions from the floor. Eleanor Hare was the League photographer. The press asked specific questions of some of the candidates. The League made sure that all the candidates answered each question from the floor. There were 370 people in the audience. Highlights of "Funding Higher Education"



The April 10th general meeting of the Clemson League addressed Funding Higher Education in SC. Lower state support, higher tuition, and greater student debt are a problem nationwide, not just in South Carolina. However, state support has declined much more steeply in South Carolina than in most other states, reflected in very large increases in tuition. The state does offer scholarships, but for the four-year institutions, most of the lottery-funded scholarships are based on merit rather than need, so that many students do not have access to that kind of help with tuition. For a summary of the funding picture, go to the Strom Thurmond Institute website and check out the PowerPoint presentation on higher education funding as well as the publication, Citizen's Guide to Higher Education Funding in South Carolina. The program was presented by Catherine Watt, Ellen Saltzman, and Holley Ulbrich of the Strom Thurmond Institute and generated considerable discussion from the audience. State Representative B.R. Skelton was in attendance and responded to questions about the current budget for higher education. ~Submitted by Holley Ulbrich

ACTION TUESDAYS

April 24 Report

Our last Action Tuesday of the year was held at the OLLI building at Patrick Square on April 24th with eight people in attendance. We talked about the post-election audit bill (League supports), the proposal to have party registration and closed primaries (League opposes), the bill introduced by Senator Leventis (S. 1454) to eliminate a number of sales tax exemptions in order to fully fund the Education Finance Act, the Local Government Fund, and Act 388 property tax relief. Action Tuesday will resume after the elections in the fall. We generated a lot of ideas for action and some phone calls, letters and emails. Our Board made a commitment to being more involved in action at the Board retreat last fall, and Action Tuesday (formerly Friday) has gone a long way to fulfilling that goal. Thanks to everyone who participated, and if you haven't tried it, watch for it in 2012-13!

APRIL 14 LWVSC STATE COUNCIL REPORT

Protecting South Carolinians Against Human Trafficking – A Fast Growing Industry in Our State:

Catherine Burton from the Citadel gave an overview of human trafficking (HT). Major forms include sex trafficking, forced labor, child labor, child soldiers and child sex trafficking. 161 countries throughout the world engage in forced labor and sexual exploitation that affects 2.5 million people. One in 800 are prosecuted and less than half of these are convicted. The greatest challenge to combating human trafficking is lack of public awareness and knowledge of the issue. Jeff Bruning with the FBI described how difficult it is to get victims of HT to come forward because they do not trust law enforcement, they lack identification, they are ashamed, and they fear for their family members. Susan Dunn, legal director of ACLU, commented on Russian women working in Charleston hotels with no money and Eastern Europeans working in Myrtle beach. Sex education is needed to prevent the breeding of HT. Martha Hurley, LWVSC Criminal Justice Director, outlined H3757, a bill before the SC House that will significantly reduce the impact of human labor and sex trafficking in SC.

Working on Growing the League and Our Leaders in South Carolina:

Shayna Howell, LWVSC Membership and Leadership Development Project, and her panel spoke of three aspects of membership: recruitment, retention and Leadership development. Their suggestions - have a enthusiastic membership chair; be visible in the community through voter registration at festivals, candidates' forums, partnerships, and advocacy; publicize events: engage members in activities; make members feel welcome and important to the organization, serve as a resource to the press; have a diversity of issues and programs; and make the LWV fun and interesting.

Political Environment in SC:

Andy Brack of The Statehouse Report, LLC humored us with his view of the political realities in SC. Our state government has 3 strong legislators, a weak governor and a bunch of lemmings. Forestry, agriculture and tourism make out 25% of the economy but receive less than 1% from the state budget. The General Assembly is made up of white older males, fewer lawyers and more retired people. There is a deficit of SC leadership. Mr. Brack referred to the expression "When in Doubt, Do Nothing. Stay in Doubt all the Time" to illustrate his point. Most of the candidates running in the 2012 elections for the SC House and Senate are Republicans. Therefore the people of SC will have to force accountability, be squeaky wheels and practice effective advocacy through direct contact with legislators.

The Future of Energy in SC:

Nicholas Rigas, Director of Renewable Energy Programs at CU spoke of the important of energy and the facility being built in Charleston. Through many partnerships, this project will provide various industries a place to test equipment and will serve to educate students at Clemson University. Dr. Rigas updated us on the progress of the construction of the plant.

The League in Action: Reports from LWVSC Policy Specialists:

Updates on Education, Natural Resources, Transportation, Child Welfare/Early Education, Voter Issues, Electronic Voting Audits, and Human Trafficking Legislation were presented. See pages 5 & 6 of May 2012 *VOTER* for SC legislation dealing with these issues.

Power of the VOTE–Update on League Voter Outreach Efforts:

Leagues across the state are participating in the Youth Voter Registration Project with great success.

Re: Cosponsor the DISCLOSE Act of 2012, S. 2219

The League of Women Voters urges you to cosponsor S. 2219, the DISCLOSE Act of 2012, which would restore transparency to U.S. elections by requiring complete disclosure of spending on big-money advertising in candidate elections.

In its ruling in *Citizens United v. Federal Election Commission*, the Supreme Court opened the floodgates for big-money special interests in our elections. Corporations and unions can now make unlimited secret expenditures seeking to elect or defeat candidates. And they can make unlimited secret contributions to other entities that seek to elect or defeat candidates. This is unacceptable in a democracy.

We must preserve the integrity of our electoral process by increasing transparency and letting the sunlight shine in. Disclosure of corporate, union, and individual spending in elections is vital to allowing voters make informed decisions. S. 2219 accomplishes that fundamental purpose.

The DISCLOSE Act of 2012 is carefully crafted to require disclosure by outside groups of large campaign contributions and expenditures – those over \$10,000 – and includes a valuable "stand-by-your ad" provision for ads run by such groups. It requires outside groups to certify that their spending is not coordinated with candidates and, very importantly, covers transfers of money among groups so that the actual sources of funds being spent to influence federal elections will be known.

S. 2219 builds on requirements already approved by the Supreme Court. In fact, the Court pointed in the direction of enhanced disclosure when it said that disclosure is important to "providing the electorate with information." It also supported disclaimer requirements "so that the people will be able to evaluate the arguments to which they are being subjected." We couldn't agree more.

S. 2219 focuses only on disclosure and does not contain elements from previous legislation such as barring campaign spending by government contractors.

Voters deserve to know the sources of funding for election advertising. The League of Women Voters strongly urges you to cosponsor and support quick action by the Senate to enact the DISCLOSE Act of 2012.
