Annual Meeting

The League of Women Voters was most fortunate to welcome former Anderson District 5 Superintendent and current Pickens County School Board Trustee Betty Bagley as keynote speaker for its annual dinner meeting. Betty, whose work on behalf of and inside of schools has spanned a lengthy and notable career, challenged League members and their guests to seek out and live a life of purpose. She shared the story of her educational journey—as student, teacher, parent, administrator, state department of education employee, and then shared with attendees how all of those experiences now inform her work as an elected official.

Her charge, she explained, is setting the vision for the School District of Pickens County, not to administer. And after many years of serving in an administrative role, watching and competing with neighboring school districts (and we learned she does have a competitive streak!), she said she knew that Pickens County deserved better than what it was getting. And that is why now, as a resident of Patrick Square, she sought out the Clemson-area school board seat.

Ms. Bagley knew teachers deserved more than they were receiving in the way of support and encouragement from their trustees. But she also talked about the challenges ahead for all public school children in Pickens County and across the state—notably those who attend schools in the corridor of shame. She brought to light students like her own daughters whose names were placed on a lawsuit two decades ago, demanding that the mandate for an adequate public education be met in the corridor—demands that have been legitimized but have been far from met, even though her girls are now grown professionals.

State League Convention May 2017

LWVCA Members Help Determine Direction for Next Two Years of LWVSC

Several members of LWVCA were among the sixty-five attendees at the biennial convention of the League of Women Voters of South Carolina, held in April in Columbia. The two-day convention was kicked off with a presentation by the President of LWV of Florida who described the 2007 – 2015 fight for redistricting in Florida. Early decisions in the process, led Floridians to think that the issue had been settled with appropriate boundaries for new districts. Then partisan politics kicked in and it took several years and multiple rulings by the Florida Supreme Court for the new boundaries to be honored.

Another special presentation came from South Carolina native Wycleia Harris, Executive Director of LWV of the United States. She discussed the process being undertaken by the LWVUS Board of Directors leading the effort to define the League's direction as the organization approaches its one-hundredth birthday.

Delegates determined the action priorities for the next two years. Redistricting will receive primary attention, in anticipation of the results of the upcoming census. Other concerns will be voter access, ethics reform, regulatory reform and judicial reform. LWVCA members in attendance were Dianne Haselton, Joanne Shalaby, Ansley Fraser, Eleanor Hare, Elaine Laiewski, Patty Warner, Holley Ulbrich, Cheryl Lee, Elizabeth Adams, Catherine Watt, Janie Shipley and Bill Hare. For the first time in the history of the Clemson Area League, a local member was chosen to lead the state League. Holley Ulbrich was elected Co-President of LWVSC and will serve with Co-President Julie Hussey of Charleston. Eleanor Hare will continue to serve on the Board of Directors of LWVSC.

They share their enjoyment of hobbies: automobiles and auto racing (BMW race car), water sports, downhill skiing, and good food and good wine.



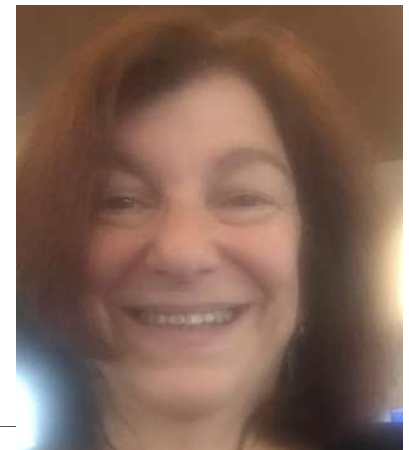

Ms. Bagley’s record as superintendent of Anderson’s largest school district included bringing six new schools online, updating k-8 curriculum to be more technology based, and implementing a sweeping school choice program that introduced magnet schools throughout the district. It became clear during the keynote that—both through her elected role in Pickens County and via her job--working as field director with Transform SC—Ms. Bagley’s goal is to effect the same brand of innovative changes here in Pickens County and statewide. Handouts that Ms. Bagley shared with audience members explained that TransformSC promotes “world-class knowledge” and “world-class skills” for all children in South Carolina, by “championing efforts to bring innovation, critical-thinking skills, collaboration, and access to cutting-edge media, technology, and communication platforms into every public school classroom.”

“When our students are skipping to the bus and our teachers are dragging to the car,” something is not right, Betty charged toward the end of her speech. Simply put: investing in students means investing in teachers and in our public schools, so that these long-revered institutions of learning might prepare our children for a technology-driven and ever-changing world, one in which they can find their purpose and live it out to the fullest.

Observer Corps Reports

Oconee County Council Notes 4/17/17

The main issue at this meeting was discussion of the suggestion by some farmers for a county-wide agricultural zoning district. There was one public comment against such a district. While such zoning is voluntary, the main sticking point was that once a farmer enters into zoning, he/she cannot return to a “control free” designation. In other words, the type of zoning can be changed to another type, but the farmer cannot return to no zoning. The agricultural zoning request was killed 3 – 2 but the chair noted it may come up again.

In other matters, the chair noted that the county is out of money to distribute to any applicants, including the current request for gravel. Also, the council noted that one appointment is filled and there are two applicants waiting for the remaining committee appointments.
