#### Interview with California Assemblymember Kevin Mullin

On March 1, 2019 **LWVSSMC President**, Shirley Des Marais and a number of LWV SSMC & NCSMC members met with **California Assemblymember Kevin Mullin**. Following is a recap of that interview.

#### Question: Water Resources

What ideas to you have for addressing the needs of your own constituency while advancing water management planning that benefits all Californians?

#### Answer:

The water problem is multifaceted. He said, "I generally support Governor Newsom's plan to shrink the plan from two to one tunnel." The governor is taking a new approach. While the transfer of water from north to south is regarded with suspicion, we know that the water conveyance system needs updating. We also know that climate change requires us to be smarter about water policy. What **ASM Mullin** sees is a new water bond, possibly as high as \$9 billion, with state and federal regulatory agencies and the governor working together to define the bond terms. This will probably occur within the next four years.

• Bruce Hartford: The Fight for Voting Rights in America, Yesterday and Today

**Mr. Hartford** will provide an overview of the historical context and present-day efforts to restrict and deny the right to vote. Mr. Hartford was a civil rights worker during the early and mid-1960s with the Congress of Racial Equality (CORE) and Dr. King's organization, the Southern Christian Leadership Conference (SCLC), in Alabama and Mississippi. He is author of *The March on Washington for Jobs and Freedom* (2012), *The Selma Voting Rights Struggle & the March to Montgomery* (2014), *Voting Rights in America -- Two Centuries of Struggle* (2018), and 'Troublemaker' Memories of the Freedom Movement (forthcoming).

The Housing Leadership Council of San Mateo County (HLC) is hosting an **Endorsement Committee meeting** for our members to discuss the Menlo Uptown (Greystar) proposal on **Monday**, **May 13th from 6:00 PM to 8:00 PM**.

The proposal includes **483 homes, 72 of which will be affordable** (even distribution at 50%, 80%, and 120% AMI), an outdoor courtyard, open public space, 799 bike parking spaces, and more.
