## **Our Voter Outreach Results**

More than 50 **Voter Outreach** volunteers, with help from San Francisco People Power Peninsula & Friends of LWVSSMC, provided over **500 people** with general voter information, **LWV California** recommendations on State Propositions, and voter registration forms. We were at the Menlo Park Farmers' Market, Facebook events, Fair Oaks Community Center, Second Harvest, and other various locations in the communities we serve. More than 30 LWVSSMC volunteers facilitated **6 Candidate Forums:** East Palo Alto; Menlo Park Districts 1, 2 & 4; Redwood City; and Woodside. A total of **over 300 people** attended these informative forums.

A total of **over 250 people** attended **10 Pro & Con Presentations** at Menlo Park's Main Library and its Belle Haven branch, St. Bede's Episcopal Church, Woodside Road United Methodist Church, St. Matthias Catholic Church, The Sequoias, Little House, & the Ladera Community Center. Our volunteers also gave a special Pro & Con presentation to **almost 200 students** at Menlo Atherton High School.

#### HIGHLIGHTS from the October 18th BOARD Meeting: Your Board

#### Decided

• To move the annual planning session from its habitual early December time frame to mid-January; Joyce Shefren and Lisa Conrad to explore venues.

#### Discussed

- The State League's request for donations to Voter's Edge, for which they 'recommend' \$1,000 per League. Decided to mention Voter's Edge specifically in our fundraising letter.
- That we have a fiscal-year deficit, partly from new technology implementation; and have therefore set a fundraising target of \$10,000.
- Various PayPal, website, and GSuite procedures, problems and successes.

#### Learned

- The State League has obtained the required number of signatures to place on the 2020 ballot the "California Schools and Local Communities Funding Act" intended to amend the corporate property tax portion of Prop. 13.
- Joyce Shefren, Local Action, needs volunteers to help determine how to interact with Stanford joint land use.
- Total membership is 162, with 13 new members, and 18 who have not renewed.

#### **Recent News from National**

This week a judge ruled in favor of LWVNH, <u>blocking the state's voter ID</u> <u>law</u> and stating that an injunction is the only way to prevent the threat of disenfranchisement.

In a huge win for LWVFL, the Florida Supreme Court issued the order that Governor Scott is <u>not permitted to appoint three new Florida Supreme Court</u> <u>justices</u> on his last day in office.

Arnold Schwarzenegger joined LWVCO and their Fair Maps coalition at <u>Denver's Terminate Gerrymandering Rally</u> in support of the two redistricting initiatives on Colorado's ballot.

#### Advocacy Review, State Bills followed by LWVC

#### **Child Care**

AB 60 would have guaranteed continued child care coverage for working parents under CALWORKS. It was vetoed because "it would have the potential to cost the state \$50 million a year and is more properly considered part of the budget process."

#### Gun Safety, Crime Prevention

AB 2222 extends the required reporting of lost or stolen guns to all law enforcement agencies in the state. Reports must be made to the Department of Justice within seven days.

#### **Initiative and Referendum Process**

AB 1947 vetoed, would have banned compensation for signatures on initiatives, referendums or recall petitions. LWVC urged a veto of this bill because persignature payment is often the most cost-effective method for collecting the hundreds of thousands of signatures needed to qualify a ballot measure. The bill would have favored the wealthiest interests able to self-fund ballot initiatives.

#### **Affordable Housing**

AB 1505 allows cities and counties to require, as a development condition of residential rental units, that a certain percentage be affordable to and occupied by moderate and low, very low, and extremely low-income households.

#### **Open Government**

SB 1421 requires personnel records relating to incidents, complaints and investigations involving peace officers to be made available for public inspection.

#### LWV Book Group



On October 30, Tracy Clark and Geoff Ryder led a successful workshop for New Voices students about the propositions that are on the ballot this year. They focused on Propositions #7 (year-round Daylight Saving Time) and #10 (Allow communities to develop local rent control rules). To Tracy and Geoff's surprise, students thought going to school in the dark would be just fine! And, since many of these students have already demonstrated against the rising rents in Redwood City, it was not a surprise that they thought increasing opportunities for rent control was a good idea. Students drew pictures describing each initiative and, then, described their pictures to the other students. Nimsi, the NV teacher, hopes to schedule a follow-up session.
