## **Development Committee:**

• Kitty reported on the Development Committee's selection of honoring local journalism for the 2022 Democracy In Action. Both Lee Leonard and Gongwer News Service have accepted the honoree position. Grace Hunter is on board to be the DIA coordinator.

- Lucy Buzzee has agreed to succeed Kitty as one of two Development Committee Chairs. Lucy will focus on DIA. The other Development Chair will focus on ongoing donor relationships, Endowment fund, etc..
- The Holiday brunch is scheduled for December 5. Invitations will be sent out this week. This is a fundraiser, but we expect to make less than the budgeted \$1500.
- The Development Committee will explore getting funding for a fundraising consultant.
- Giving Tuesday and the Friends Letter are also moving forward for end of year giving.

### **Voter Service**

- Ellen and Elizabeth reported on what the Voter Service committee worked on this election season. Candidate forums are taking more of Elizabeth's time than usual due to the dissolution of the Franklin County Consortium. Candidate forums provided an important nonpartisan platform for local candidates this year especially contentious school board races.
- Election Day Phone Bank will be held with WBNS tomorrow from 6:30am 7:00pm. Beth Taggart is organizing.

## **Education and Advocacy**

- E&A has many activities coming up: Source of Income Forum, Nov. 4; 21 Day Challenge in progress; Phone Banks for COIVD Vaccines in partnership with Franklin County Public Health on Nov. 15 and Dec. 7; volunteering at Mid Ohio Foodbank on Dec. 9.
- E&A is also working on a food insecurity subgroup and expect additional volunteer opportunities to come out of this group

## **Membership Committee**

- The membership committee is planning a virtual New Member Orientation for Nov. 9.
- Membership renewals are coming in at about the same rate as usual
