#### Reproductive Health

Constitutional Amendment

Access to comprehensive reproductive health care, including: IVF, contraception, abortion, pregnancy and childbirth.

Improved health outcomes for mothers and infants and decrease in maternal and infant mortality and morbidity rates, especially for Black women.

Legal protections for health care providers and patients who provide/receive abortions or other reproductive care from other states (thus, no extradition)

Prohibition on tracking or disclosing of personal reproductive health data, including menstrual cycles, by anyone other than the individual whose data is at issue.

No ascribing personhood to unborn fetuses, and embryos

# Governor Removes Voters from the Polls; LWV and partners Sue and Win Twice - Until a Disappointing SCOTUS Decision.....But We Will Persist.

In early October, the Virginia Coalition for Immigrant Rights, African Communities Together and the League of Women Voters of Virginia filed a lawsuit in federal court to challenge the state's policy of illegally and systematically removing voters from the rolls within the 90 day "Quiet Period" mandated by the *National Voter Registration Act* before a Federal election. The plaintiffs are represented by Campaign Legal Center, the Protect Democracy Project, Lawyers' Committee for Civil Rights Under Law, and The Advancement Project.

The lawsuit alleges that these systematic purges of Virginia's voter rolls violate the *National Voter Registration Act* and risk improper removal of eligible voters, particularly those who are naturalized US citizens.

The challenged policy is a result of Executive Order 35, which was signed by Governor Glenn Youngkin in August and requires state and local election officials to remove individuals from the state voter registration list if Department of Motor Vehicles (DMV) records do not indicate US citizenship. However, as the complaint explains, Virginia driver's licenses are available to non-citizens and can remain valid for up to eight years, meaning people who obtained driver's licenses as non-citizens, subsequently became US citizens, and lawfully registered to vote are being unlawfully purged from the voter rolls based on outdated DMV information.

The question has arisen, why did we "only" sue on 1600 people - not the more than 6000 purged before. That is because the National Voter Registration Act does not allow systematic purges of voters 90 days before a Federal Election. Those 1600 names we received because a judge on Oct 23 required the Commonwealth to give our attorney's those names during the discovery process.

Our attorney's have found many people who are citizens and have been caught up in this unlawful purge.

On October 25, a Federal District Court Judge ruled in our favor and granted an injunction requiring that the people purged must be put back on the rolls and registrars notified that they are eligible to vote. The Commonwealth then went to the 4th

On October 27, the Court of Appeals for the 4th Circuit also ruled in our favor and refused to grant the defendants a stay. They had wanted the Court of Appeals to vacate the injunction of October 25.

Sadly, on October 30, the Supreme Court of the US, granted the stay of the injunction requested by the Commonwealth.

However, we will persist - nothing ends here. This is not over.

This is what you can do!

- 1. Remind everyone to check their registration on vote411.org and use same day registration on Nov 2 and Nov 5 if they are not on the rolls any longer.
- 2. Tell anyone who feels they are being denied the right to vote to call or text the nonpartisan election protection hotlines:

After discover revealed 1600 more people purged during the "quiet period" where such things are forbidden by the National Voting Rights Act - we got to work again. Thank you also to Goodwin House, Falls Church and Goodwin House, Alexandria and to the Falls Church members who came to the Arlington/Alexandria "postcard palooza." Well done, Leaguers!

## **Should Virginia Allow Citizen Initiatives on the Ballot?**

November 17 - 2:00 - 3:30 PM

Virginia voters currently have no option for enacting statutes or constitutional amendments without General Assembly approval. By contrast, the citizens of 24 states, mainly in the West and Midwest, can petition to bring proposed laws and/or constitutional amendments up for popular vote. Citizen initiatives can be an effective tool when a state's General Assembly fails to enact legislation that aligns with the opinion of the majority of voters. However, the citizen initiative process also can be used in ways that are undeniably detrimental to the common good.

College student options went to the librarians in higher education. The curbside voting change for all disabled people gave us an opening for a conversation.

Local Leagues: Captain's Vote Day at Christopher Newport University October 8, 2024



The Wason Center is an educational research center at CNU where students work side-by-side with faculty to produce survey research and non-partisan political analysis that informs decisions by citizens and lawmakers in Virginia, and increasingly around the country.

The Wason Center Scholars organized the first annual Captains Vote Day on 10/8/24 to energize students to vote by providing a bipartisan platform for organizations to amplify their respective messages. LWV Southampton Roads (SHR) and LWV-Williamsburg Area (WA) assisted students with voter registration and provided information about early voting, mail-in ballots, deadlines, etc. LWV partner, REV UP Virginia (Register, Educate, Vote, Use your Power!) shared an adjacent table with the Virginia Interfaith Center for Public Policy (VICPP) and the CNU Disabled Student Union to educate students and the public about the power of the disability vote. Other participating organizations included Alpha Phi Alpha Fraternity, Inc., VA BLOC, The National Council of Negro Women, and the Democratic and Republican Committees. CNU President William Kelly welcomed attendees and introduced Newport News Mayor Philip Jones as well as

several state legislators who congratulated students on their civic involvement and encouraged them to vote. We had a steady flow of students who appeared excited and eager to vote in the upcoming election. LWV-SHR engaged students with a 5-question history of voting quiz and REV UP attracted students with a chance to win prizes in a spinthe-wheel game. LWV-SHR and LWV-WA enjoyed their first voter registration collaboration and look forward to teaming up for Captains Vote Day 2025!

#### **Election Night Is Not Always Results Night. That's Okay.**

On Election Day, millions of Americans fulfill their civic duty to vote, and millions will have already cast their ballots before Election Day. It may take a while – from a few days to a few weeks – to count every ballot, but we need to be patient for our democracy to work for us all. While it would be nice to know the election results on election night, we probably won't have the final results. Bad actors and self-interested politicians may try to claim victory early, before all votes have been counted, and then cry foul when their lead dwindles as more votes are counted. It's normal for election results to take days or weeks to be finalized. In fact, the official results have never come out on election night. In every election, election workers keep working well past election day to canvass and certify the results. As Americans, we have a duty to ensure that every vote is counted, and that requires patience while election workers count every ballot and double check their work. Above all, we have a duty to accept the results, regardless of the outcome.
