Healthcare Privatization Educational Forum

Virtual via Zoom 6-7pm

At the LWV US Convention in June 2024, there was a LWV VT proposed update for the LWV US Privatization Position. The proposal was for LWV US to oppose the privatization of healthcare. The proposal did not pass.

LWV New York has revised the proposal presented in 2024, to be voted on at the 2026 Convention and is requesting state and local Leagues to support the following revised position:

"The League believes that healthcare, like other programs that provide and protect basic human needs, should be considered a public good. The League favors a system where fiduciary responsibility (for such programs) is to patients and the public. Because private for-profit corporations have a fiduciary responsibility to their shareholders rather than to patients or public health, the League believes the for-profit business model for healthcare is inappropriate for the common good or to meet the basic needs of the most vulnerable members of society. In sum, the League opposes further privatization of needed healthcare. Where private entities fail to deliver programs that provide and protect basic human needs, the League supports de-privatizing them"

To learn more about the proposal, please join fellow Virginia League members on **Thursday**, **November 13th from 6 to 7pm** via zoom for a presentation and discussion regarding the proposed concurrence to update the national Privatization position that will be introduced at the 2026 National Convention. **Presenters are Judith Esterguest of LWV-NY and Barbara Pearson**, **LWV-MA**. The Update would add healthcare to its enumeration of "public goods" and "human needs," and make explicit that, under certain circumstances, the League may advocate for de-privatization.

Natural Resources Committee by Peggy Gilges City of Charlottesville Joins Biophilic Cities Network

On October 17, the City of Charlottesville announced its acceptance into the **Biophilic Cities Network**, joining communities worldwide in recognizing the vital connection between people and nature.

"A Biophilic City is one that intentionally integrates green space into its urban environment, conserves natural areas, and fosters stronger connections to nature for all residents."

Albemarle County is also considering joining the network — a move that would make Charlottesville and Albemarle the first Biophilic Region in the world.

Tenaska Energy Proposes New Gas-Fired Power Plant in Fluvanna County Tenaska Energy has proposed building a 1.5-gigawatt natural gas plant—the Expedition Generation Station—on 50 acres adjacent to its existing facility in Fluvanna County. The \$2.2 billion project could begin operations in 2031, pending approvals.

In October, the Fluvanna County Planning Commission deferred a decision on whether the project aligns with the Comprehensive Plan until November. A public hearing is expected in January 2026.

So far, <u>Fluvanna has been resistant to data centers</u>, while neighboring counties, such as Louisa, have committed to several.

The regional grid operator, PJM Interconnection, supports fast-tracking the project to meet the growing energy demand driven by data center expansion. However, residents have raised concerns about potential climate impacts, air pollution, and noise a gas power electrical generating plant could bring.

Albemarle County Supervisors Approve AC44 Comprehensive Plan After years of development, the Albemarle County Board of Supervisors adopted the updated AC44 Comprehensive Plan on October 15.

Some controversial elements of AC44 include:

- The proposal of potentially swapping land in the Development Areas with land in the Rural Area, and
- Creating a way for property owners to request changes to the Comp Plan designations for their properties outside of the usual Comprehensive Plan Amendment process intiatated by the Board of Supervisors or county staff.

International Relations and Foreign Government by Gerry Kruger On October 16, 2025, the International Relations/Federal Government

committee met at Linden House to discuss the present US foreign policy. Attending were Lois Sandy, our host, Rosalie Simari, Kerin Yates, Miriam Fleitman, Diane Skalak, Gerry, Kruger, and Anita Pilling.

Anita opened our discussion of US foreign policy by mentioning the Truman doctrine, which came from a speech President Truman gave to Congress in 1947:

"It must be the policy of the United States to support free peoples who are resisting attempted subjugation by armed minorities or by outside pressure."

We believe the US should continue to support this policy but could amend it to say we could support vulnerable nations without directly participating in a war. World institutions such as the UN, NATO, the World Bank, and the International Money Fund strengthen the United States as the world's leading superpower by providing soft power such as financial aid, and multilateral support.

The Trump administration has accomplished some of its objectives by working with multicultural nations. The return of the hostages by Hamas to Israel was the result of this. However, other countries have pushed back against some policies of this administration, such as high tariffs and have retaliated against them. If the United States abandons its role as a global public goods provider, such as with USAID, the result will be the spread of many diseases, large populations of illiterate people, abuse of women, and fewer foreign students coming to study here. Global chaos caused by economic and political instability would follow.

There needs to be more consistency in economic policies if we are to bring down inflation and address global problems. In addressing illegal immigration, more attention must be paid to following the law and allowing due process. People of all races, nationalities, and creeds deserve civil rights in a true democracy.

We think business deals made with large companies and foreign leaders that expect to profit from the President's decisions should be thoroughly investigated.

The next meeting of the International Relations Federal Government committee will take place again at Linden House on November 20, 1:00-2:45 pm. Join us as we continue to examine the practices and policies of our government.
