Community Chats with Sheriff Tanner

Various council members present for informal sessions held in Sheriff's Department Headquarters, Bay Street and Bluffton Library

Audience Size: in excess of 100 both meetings, standing room only

Proceedings: Informal sessions organized by council members to allow Tanner to speak on issues of ICE (U.S. Immigration and Custom Enforcement) and U.S. 287 (g) program.

Relevant to LWV: (Sorry Sam and Susan... Can't get rid of blue background) Suzanne) Sheriff Tanner, who was first elected in 1998 and has been re-elected seven times, outlined his reasons for seeking an agreement with the federal government to participate in the ICE program. The department the 287(g) program from 2008-12, operating one of 18 ICE task forces in the country with five deputies assigned to the unit. Tanner has said he expects to continue the program, once an agreement is signed, with only two deputies who will receive special training.

The task force associated with 287(g) was cancelled during the Obama administration following charges of racial profiling and civil rights violations.

Tanner said he expected to have an agreement with the federal agency by the end of the month.

Council members stressed they have no input in Sheriff's decision to pursue ICE agreement. Several critics of the proposal pointed out the Council does have control through the annual operating budget process.

At request of the Chamber of Commerce, second and final reading was delayed for further discussion. City Planning Commission and staff had multiple meetings to discuss proposed changes. Chamber, which had no representatives participating in those meetings, asked for delay weekend before meeting took place.

Item 2X A and B: First reading of ordinance to name road Clayton Cooler Loop (In Southside Park, in honor of former long-time Public Works Director) and Airport Road extension on Lady's Island, Donnie Beer Drive (in honor of the long-time former City Councilwoman Donnie Beer.

City Manager's report: Update on city's decision to close part of the Henry C. Chambers Waterfront Park, prior to Water Festival, because of concerns about structural safety. The city's Waterfront Advisory Committee is in place. Contract engineers are working to draft plans on how to proceed.

<u>Closed Session</u>. The "Caucus," replacing Executive Session, ran past the allotted time; when that occurred on July 14, the chair proceeded with the caucus, even though the public could hear its votes. Nothing appeared controversial.

Issues Relevant to LWV (numbered items identified from agenda):

Significant retirement: Although the agenda stated simply that the County Administrator would provide a report, as he routinely does, Mr. Moore's big news was the retirement of Marie Smalls, the Director of the Beaufort County Office of Elections and Voter Registration. Many attendees were there for the sole purpose of celebrating Ms. Smalls and letting the county know how valuable she was to the county—and to the League

Interaction with other government bodies:

Item 9: The Council agreed to work with Jasper County for a one-year period (which could be extended) on <u>animal control and intake</u>. The agenda provided a "fiscal impact" summary as part of the agenda. Jasper County officials were present to respond to questions and to thank Beaufort County.

Item 14: An amendment to the Beaufort County Code of Ordinances settled many years of confusion throughout the county regarding the definition and implementation of <u>storm</u> <u>management</u> throughout the county including all the county cities and townships.

Item 20: A resolution to <u>prioritize projects</u> within the three categories of the 2018 one cent sales tax program. This resolution replaces an earlier decision to use the "left-over money" for the replacement of the bridge to Hilton Head Funds for the bridge will come, hopefully, for a federal grant listed below.

Item 21: A resolution to support the 278 Bridge project and authorization to apply for <u>a large Bridge Project Grant</u> through the Federal Highway Administration Bridge Investment program. A long discussion followed the proposed resolution; chances of success for the application appeared to be around 10%. A fiscal impact statement following the resolution reiterated the prior agreement for the state to share any cost overruns with the county on a 30/70 basis—with the county paying 70%.

Item 22: A resolution authorizing the county to provide funds (from the county's Green Space Program) to purchase the Chelsea Tracts, as a conservation easement; money from the Green Space Program will be reimbursed by the Open Land Trust. Those supporting included officials from Jasper County where Chelsea Tracts is located next the Gregorie land previously acquired jointly from the counties, and a representative from the Nature Conservancy.

Item 2 from the Consent Agenda: A Memorandum of Understanding between the county and the College of Charleston to complete a Federally sponsored "Living Shoreline Mapping and Matrix Activities."

BEAUFORT COUNTY COUNCIL APRIL 28, 2025

Observer Report

Note: This report is short. The plan as voted upon by the County Council early in 2025 was that Council meetings would be held in a variety of locations so that citizens would have an opportunity to attend. The subject meeting of April 28 was held at the St. Helena Island Branch of the Beaufort County Library. The size of the room and St. Helena Library's proximity to a parcel of land that is the subject of great controversy led to an excess of participants; there was no room for seating or for hearing. Accordingly, readers of this report would be better served to read the attached agenda, and follow-up agendas for information and voting on/about the meeting.

Attendees: Three Council members attended the meeting on line: Passiment, Brown, and Cunningham; the rest of the Council attended the meeting.

The early part of the meeting was devoted to recognition of individual Beaufort County employees; to "Military Children" who are part of military families stationed in Beaufort County; to a recipient of an award who worked with women associated with the military; and to county employees working at the detention center. The sheer volume of traffic required by the awards added to the time needed for the meeting.

Many attendees signed up to speak at the Public Comment portion of the meeting.

(Note: Council President Alice Howard cautioned that one person signing up on behalf of many speakers was NOT the process desired and would not be allowed in the future:

The comment portion took much more than 30 minutes; further, several speakers were admonished for inappropriate language or name-calling. (Another note: nothing was decided regarding the Cultural Protection Overlay, the subject of the controversy; this topic was not on the agenda since it rightly belonged to the Planning Commission.) The meeting ended close to 8:00 p.m.

Issues Relevant to LWV:

Public Comment: William Smith, Natasha Robinson both spoke about the decrease in Gullah/Geechee programs held at the St. Helena Library; both stressed the need for these programs to teach youngsters about their heritage.

(unknown name): in response to the Chair's call for other comments, one person spoke to the coming Earth Day on April 25 and the urgent need for comments related to plastic bags, Styrofoam, and plastic straws. The Chair announced that the deadline for comments had been extended to April 1, 2025.

Two issues, 2025/13 and 2025/06 on the agenda, referred to the maintenance of animals on property not otherwise zoned for the maintenance of animals. The presence of animals has a direct effect on the water supply in the county. Zoning allowing for such maintenance was denied in both instances, although York Glover recommended that the country consult with Clemson University about measures that would place parameters on animal farming in the county.

Of special note was the presentation by a representative of the Community Block Grant from Lowcountry Council of Governments: the speaker stressed commitment to housing for those of low to moderate income; the program, begun in 1982, receives funds from the state (although the speaker referred briefly to the current national situation as possibly affecting funding). The Community Infrastructure, Local Priorities program, and Community Enrichment project funding, Business Development and Regional Planning were also briefly listed.
