Voter Services Report

September: Voter Registration
We started the month of September with
Flossmoor Fest on Saturday,
September 7, registering seven new
voters, six of them youths, and assisting
another with a change of
address.

National Voter Registration Day was Tuesday, September 24, 2019, and the League demonstrated its commitment to strengthening our community by registering voters at multiple sites. We had previously met and collaborated with our League Partners in Park Forest to ensure that all of our suburban schools were covered. We are so excited about the opportunity to empower our young people to "Rock the Vote" for the 2020 election.

We hosted voter registrations in the South Suburban School Districts including District 233, Homewood -Flossmoor High School in Flossmoor; District 205, Thornwood High School in South Holland, Thornton Township High School in Harvey and Thornridge High School in Dolton; District 228, Hillcrest High School in Country Club Hills, and Marian Catholic High School in Chicago Heights. The senior living facility, Sunrise of Flossmoor, the Lansing Public Library, and Governor's State University were also included in our outreach to provide voter registration services at those sites. Our efforts paid off and as a result of our hard work, 130 new voters are now registered! Our work is so important, providing opportunity for everyone to vote, but it is also fun! A BIG THANK YOU!! to all the Deputy Registrars and members who volunteered their time and effort to help

businesses, and plans for their respective communities. We were honored to have them in attendance and thanked them for their participation. Please look for pictures of the event in this bulletin.

League members make a difference throughout the community in many ways. Among other things, our monthly program meetings provide information on current topics affecting the population, e.g., Immigration and Climate Change. We provide a service to the community by conducting voter registration drives and candidate forums; we actively promote environmental sustainability; and, we are involved in community-sponsored activities. Our October 9, 2019 program meeting will feature the 2020 Census. On November 6, 2019, the topic will be the Legalization of Recreational Marijuana in Illinois. 
October - Deputy Registrar Training



Homewood Public Schools School District 153 Board of Education Public Hearing and Regular Board Meeting September 16, 2019

All members of the Board of Education were present at the Public Hearing to discuss the FY 2020 Budget. Dr. Gibson gave an overview of the FY 2020 Budget and how it compared to last year's budget. He explained the factors that drive the budget, e.g., property values, expenses and spending levels.

There were a few clarifications given by Board members. Member Deb Havighorst complimented Dr. Mitchell, the Board, and Staff for developing the budget.

Environmental/Climate Change

Solar Power Hour

The Chicago Southland Green Committee hosted a Solar Power Hour on August 29 at the Flossmoor Library. Solar Power Hours are offered by the Citizens Utility Board (CUB) in partnership with the Midwest Renewable Energy Association (MREA). Both organizations are advocates for cheaper, more efficient and renewable energy, and they have partnered to help Solarize Chicagoland communities. The program combines education and information about solar discount opportunities. League member, Deborah Hampton, and others in attendance learned the basics of solar power and its financial implications for households. Participants also learned about the concept of *Net Metering* which means any excess electricity produced by your solar system is exported to the Utility grid and you receive credits towards your electric bill. They also learned how solar panels are installed and about incentives offered by both state and federal governments. Collaborating for Sustainable Communities

Established by the Metropolitan Mayors Caucus

The Greenest Region Compact is an agreement through the Metropolitan Mayors Caucus that aims to promote sustainability in Chicagoland through 49 goals designed to "guide municipal action, support mayors in their role as environmental leaders and foster collaboration that will have positive impacts on the region," according to MMC. (HF Chronicle March 28, 2019)

The member municipalities of the Metropolitan Mayors Caucus seek a vibrant, sustainable future for their communities and the greater Chicago region. By consensus, the members formulated goals that focus on enhanced quality of life for residents, protection and stewardship of the environment, and sustainable economic vitality.

The members of the compact therefore, pledge to support the goals of the GR2 in their own communities, and through collaboration, throughout the entire region in the following areas:
