Report on Official Board Actions at the September 9, 2025 Meeting

The Board took the following “official actions” at our September 9, 2025, meeting:

Use of Humboldt Area Foundation (HAF) funds for Educational Effort

It was moved / seconded and passed by a unanimous vote that we use HAF funding for LWVHC’s booth equipment and supplies used for our educational tabling at fairs throughout the year.

It was moved / seconded and passed by a unanimous vote that we use HAF funding for the LWVHC Membership Brunch which includes educational presentations.

Donation for Board Meeting Room use:

It was moved / seconded and passed by a unanimous vote that we give a donation of \$200 to the United Congregational Christian Church for use of their building for our LWVHC Board Meetings this year.

Donation to KEET and Access Humboldt:

It was moved / seconded and passed by a unanimous vote that we give a donation of \$600 to KEET-TV in support of their production and airing of our candidate and election forums and that we give a donation of \$200 to Access Humboldt for re-running the forums at no charge (to us).

CA Proposition 50:

It was moved / seconded and passed by a unanimous vote that we approve issuing a statement for LWVHC, aligning with LWVC’s position related to the League’s neutral stance on CA Proposition 50 and clarifying misinformation that has been published related to this, to be used for information at the North Country Fair booth, for letters to the editor of local newspapers and news websites, and for a VOTER article.

EZ Voter Guide:

It was moved / seconded and passed by a unanimous vote that we authorize spending \$100 on EZ Voter Guides. These will be distributed to local libraries and other public information locations.

2025/26 Budget Approval:

It was moved / seconded and passed by a unanimous vote that we approve the 2025/26 LWVHC Budget, with minor revisions as discussed in the meeting.

Community Election Services

It was moved / seconded and passed by a unanimous vote that we approve the Memorandum of Understanding with the Bear River Band of the Rohnerville Rancheria as revised.

Yes! It was a very busy meeting!

Proposition 50 and the League of Women Voters of California: What YOU need to know!

While staffing the LWVHC information booths at both Cal Poly Humboldt and the North Country Fair, LWVHC volunteers were asked a lot of questions about the League's stance on Proposition 50, and about information found on a mailer sent out by the "Protect Voters First" organization. People are confused!

In order to clarify the situation, and to arm LWVHC members with the facts, I am copying the entirety of a message dated August 21, 2025 as well as portions of a message dated August 27, 2025, both from the League of Women Voters of California Board. Both of these messages can be found on the League of Women Voters of California website in the "News" section <https://lwvc.org/news/>

Article #1, dated August 21, 2025: "League of Women Voters of California Not Affiliated with Redistricting Mailer"

"You may have received a mailer from "Protect Voters First" about the redistricting ballot initiative this November. By naming our organization and quoting Gloria Chun Hoo, the mailer wrongly implies that the League of Women Voters of California is part of their coalition and endorses the information contained in the flyer.

This implication is not correct—we are not part of this coalition. The League of Women Voters of California did not authorize this action."

Article #2, dated August 27, 2025: The League of Women Voters of California will not take a position on Proposition 50

"This statement explains our stance, provides context for it, and shifts the focus to empowering California voters.

Early in the process, before the ballot language was written, we, along with several good government groups, issued independent statements opposing mid-cycle redistricting. **This was consistent with the League's longstanding positions at both the state and national level.** Since then, and on the heels of Texas' decision, California Governor Gavin Newsom and the legislature moved forward to do mid-cycle redistricting. Now, the ballot measure language has been finalized. While the process for the redistricting in California differs from what is happening in Texas, the California League recognizes the importance of staying aligned with our national League and with state and local Leagues, such as in Texas, that are, or may be soon, in court challenging unfair maps.

With all these factors in mind, we have decided not to take a position on Proposition 50.

On the proposed maps themselves, our policy is clear: **the people most affected by district maps, especially communities of color who are often underrepresented, should be the ones to decide if these maps are fair.** Many of our partners in Latino, AAPI, and Black communities are still reviewing the California map and forming their positions. We will defer to them to share their conclusions.

The League of Women Voters of California is a nonpartisan organization. **Every day we fight in the courts and in the legislature to protect Californians from President Trump's authoritarian actions that threaten the rights and freedoms of all Americans.** Our record on this is public and clear."

Further in the statement, the authors state:

Proposition 50 and the League of Women Voters of California: What YOU need to know! (continued)

“Now is the time for the voters to decide. Special elections often see low and unrepresentative turnout. The League of Women Voters of California Education Fund will work to ensure that the full diversity of California voters participate in the November 4, 2025 election, and that every voter has access to the non-partisan, in-language, and factual information they need to cast an informed vote.”

Humboldt County Civil Grand Jury System Position Review

For this 2025-2026 League year, we will be examining the Humboldt County Civil Grand Jury System position to decide if we don't need to make any changes, if we only need to make small changes in language, or if we need a new study.

The committee chairperson, **Claire Eyton**, will be joined by **Kay Escarda** and **Byrd Lochtie** as we prepare for the membership meeting scheduled for Thursday, March 26, 2026. We invite any League members who have a special interest in or experience with the Humboldt County Civil Grand Jury to join our committee and/or to direct us to anyone in the community who could bring some perspective to this topic.

Below is the 2016 Civil Grand Jury position that the League members will review:

Position Summary: Support improved understanding of and participation in the Civil Grand Jury system. Strengthen resources and support for the Civil Grand Jury, so that it can carry out its investigative functions.

Position:

1. Increase accurate information to the public about the Civil Grand Jury process and procedures through the Presiding Judge, the Jury Commissioner, community groups, media, and former Grand Jurors.
2. Support the existence of a Civil Grand Jury composed of citizens, willing to serve, selected from a cross section of the community.
3. Improve resources and support to the Civil Grand Jury by providing adequate office and meeting space, childcare, clerical help, and reimbursement for travel.
4. Encourage publication of the Humboldt Civil Grand Jury Final Report and responses to the report by a community-wide newspaper.
5. Encourage the Jury Commissioner to distribute recruitment information to prospective Grand Jurors through all available media outlets.
6. Encourage comprehensive orientation and training for Grand Jurors.
7. Support the use of a standardized format for comprehensive official responses to the Civil Grand Jury Final Report finding and recommendations.

September 16-21 Was a Busy Week for LWVHC Voter Registration!

We all know how things sometimes seem to happen in bursts, right? Well, the week of 9/16-9/21 was like that for LWVHC Voter Service!

On Tuesday, 9/16, we celebrated **National Voter Registration Day** by tabling at Cal Poly Humboldt from 11 am-2 pm in the busy student quad area. **Peggy Syvertson** and **Tess Coffman** gathered the needed supplies from **Jessica Schlachter** (who works at the Cal Poly Humboldt library), transported them to the quad, and set up an enticing display amidst the students. I joined them at 12:30 pm, and Peggy and I closed the table at 2:00 pm.

The next day, **Anne Wasson** and I set up the table again in the quad, this time for **National Constitution Day**. On this day, we were fortunate to be placed between the tables for the Humboldt County Elections Office and the Cal Poly History Club, both of whom offered games and incentives for students. It was FUN! Our tabling events for the two days netted a total of 18 completed voter registration forms, along with lots of questions answered and numerous additional voter registrations cards taken to be completed later. **Thank you so much Peggy, Tess, and Anne W. for working at the table, and to Jessica for making all the arrangements for us at Cal Poly! You all rock!**

Then, on Saturday 9/20 and Sunday 9/21, we staffed a booth at a very busy (aka LOUD) corner on the Arcata Plaza at the North Country Fair. It was lots of fun, and we registered 5 additional voters. We also answered a lot of questions, gathered 19 new signatures for our Humboldt County Support Letter (the text of which is now on the front page of the LWVHC website) and got 124 citizens ages 3-90 (or so) to vote for their favorite potential new LWVHC sticker. And the vote was tied between "Vote Like Your Rights Depend on It" and "Bigfoot Loves Voting With LWV."

Thank you to everyone who came up to say hi and chat with us!
