VOTER INFORMATION

Before you can vote in Iowa, you must be registered. Register online, by mail, or at your polling place. To register to vote in Iowa, you must:

- Be a citizen of the United States
- Be a resident of Iowa
- Be at least 17 years old
- Not have been convicted of a felony (unless your rights have been restored by the Governor)
- Not currently judged to be "incompetent to vote" by a court
- Give up your right to vote in any other place
- Possess a valid photo ID and proof of residence if the ID does not include the current address. IDs accepted are: an Iowa or out-of-state driver's license, an Iowa or out-of-state non-operator ID card, a US passport, a US military or veteran ID, an employer issued ID, a student issued ID from an Iowa high school or college, or a tribal ID card/document.

Bring your accepted ID or voter ID card to your polling site. An ID is required to vote in-person.
