It includes bills within the LWVSC areas of concern; but listing does not imply high priority for LWVSC. The list far exceeds LWVSC advocacy capacity and the LWVSC board will act to determine priorities. Further information on this process is available at https://my.lwv.org/south-carolina/advocacy.

In some cases, the League position is an obvious binary choice (support/oppose). Also, some closely parallel bills filed in the past and we have an established position, and some were filed with the support of coalitions of which the League is a member. In those cases, the right-hand column "S/O" has been filled out. However, many bills are complex, or novel, and require additional analysis before classification. Please do NOT read anything into the absence of a classification in that column. In some cases, the bills will not even be fully evaluated unless there is evidence that they may advance, since the League does not have the capacity to fully evaluate the implications of hundreds of bills.

Natural Resources: UPDATE ON SAVANNAH RIVER SITE (SRS) WASTES

In the 1950s, 300 square miles of farmland along the Savannah River were condemned for a "bomb" plant. In the early years, the emphasis was on rapid weapons materials production. No environmental regulations were in effect at that time, and no thought was given to future cleanup.

Five of the country's dirtiest coal plants operated for decades at SRS, even after clean air regulations were established. Initially, the government position was that commercial coal effluent standards didn't apply to federal facilities; SRS later complied. One operating nuclear plant currently produces energy for the site - no coal plants. Local citizens welcomed the nuclear power plant and its cleaner operations.

SRS past weapons materials productions have been of concern – particularly those operations which released mercury and tritium off site. Columbia is 'downwind' of SRS. Messy operations have ceased, at least for the moment, as the focus is now on SRS cleanup.

Although I personally have respect for the technical leadership and technical staff at SRS, politicians and contractors are a problem. Local citizens have blindly supported jobs proposals as presented by DOE and its contractors. The Chambers of Commerce, mayors, county councils, even United Ways, have turned out in droves of unquestioning support, particularly for this most recent plutonium pits proposal.

DOE prime contractors usually operate at SRS on a cost-plus contract, which encourages their involvement in the habitual practice of the Department of Energy (DOE) to begin construction prematurely, with routine design/build, redesign/rebuild escalations of budgets and extensions of schedules. SRS currently employees about 10,000 people. The proposal to produce plutonium "pits," or cores for nuclear warheads, would reportedly add thousands of new employees.

Pits production at SRS is a totally new mission. I am concerned that this new mission will divert leadership in charge of closing the old tanks of Cold War wastes; new pits wastes will be generated. There is now no clear plan for stabilizing the new pits wastes.

The manufacturing of "plutonium pits" has historically produced pollution, both on site and off site, (including a Superfund site). When the proposal was promoted in SC, the Superfund site wasn't mentioned – only the local park (as an example of how 'clean' the operation had been).

The pits proposal would rededicate the shell of the failed "Mixed Oxide Plant" (MOX) at SRS. The purpose of MOX was to fabricate fuel for commercial reactors from unused weapons materials (fuel that wasn't welcomed by reactor operators). This was unfortunately a semi-typical proposal in that the French had developed a MOX concept with limited success, and sold an old design to DOE. This benefitted the architectural/engineering firms constructing at SRS on that cost-plus contract. Updated design and construction were necessary for many reasons, many times. Schedules and budgets of MOX ballooned. Finally, the MOX proposal was canceled despite the vigorous and insistent support of contractors and our D.C. delegation.

Similarly, the commercial nuclear power plants SCE&G and Santee Cooper proposed for Monticello (and 2 others in Georgia) were subject to "design/build, redesign/rebuild." Westinghouse and the power companies wanted to build a new "passively cooled" commercial nuclear reactor ahead of final design or updated regulations. Costs and schedules at Monticello (and Georgia) swelled. The redesigns had to do with 911-related airplane protections of nuclear plants as well as refined designs of this new passive cooling concept.

SCE&G executives lied about the progress, budget, and schedule when they reported to the SC Public Service Commission and the Securities and Exchange Commission. Hence the current indictments.

Back to Plutonium Pits and the so-called need for more weapons: Please check the chilling review of Daniel Ellsberg's recent book, *The Doomsday Machine: Confessions of a Nuclear War Planner*, <u>https://www.counterpunch.org/2020/12/28/doomsday-ex-machina-daniel-ellsberg-and-the-nuclear-gang/.</u> It explains why we don't need more warheads, and the dangerous considerations of first-use of nuclear weapons in the US by past presidents (including Jimmy Carter). The possibility of international mistakes and/or considerations are sobering in light of this new information. Ellsberg's considerations and recommendations are very much in line with LWV/US non-proliferation policies.

Natural Resources: PLASTICS - FEELING GREEN? NOT SO FAST

Do you feel "green" when you recycle plastic waste with the following symbol? Not so fast....



The petrochemical plastics industry hopes that you do. They hope that environmentally conscious consumers will feel "green" so that they will continue to buy plastic products because it has the **100% RECYCLABLE** label. Although plastic products with the **100% RECYCLABLE** label may "technically" be recyclable, they will not be recycled if recycling is not economically feasible. An internal 1973 plastics manufacturing report cited in the PBS *Frontline Plastic Wars* concludes that "the cost of new plastic is so low that sorting and reprocessing used plastic cannot be justified economically".

This conclusion appears as valid 47 years later. According to *Plastic Wars*, it is estimated that 90% of plastic wastes will never be recycled, including plastics embossed with the **100% RECYCLABLE** symbol.

.James R. Stritzinger, Jr. Founder, President & CEO Revolution D, Inc.

Revolution D is a consulting firm that specializes in geospatial artificial intelligence (GeoAI) - especially the deployment of high-speed Internet in rural communities. Mr. Stritzinger is regarded as a national expert in this area and was selected to speak at the IBM Think 2019 conference and present to the US House Rural Broadband Task Force (2019) by Congressman James E. Clyburn.

Mr. Stritzinger has held roles with public, private, academic, non-profit, and entrepreneurial organizations. During his career, he has worked as an engineer/software developer for IBM, General Electric and held senior leadership roles with Solomon/Great Plains Software, Microsoft, SCRA, IT-oLogy, Connect South Carolina, and the University of South Carolina. His career highlights include launching SC's private equity organization (SC Launch, 2005) and a software company (ClearView Software, 1990) which was acquired in 1998 by Solomon and later became part of Microsoft Business Solutions in 2001.

Mr. Stritzinger was selected to join the inaugural class of SC's prestigious Liberty Fellowship (Class of 2006, part of the Aspen Global Leadership Network), and was inducted to the NC State University (NCSU) Electrical and Computer Engineering Alumni Hall of Fame (2015). He holds a BS Electrical Engineering from NCSU and a Master of Health Information Technology from USC and is a Senior Member of the Institute of Electrical and Electronics Engineers (IEEE).

Ms. Gams earned a BA in English at the University of South Carolina's Honors College and a Master of Arts in Teaching from the University of South Carolina. She partnered with Education First (EF) Tours in 2006 and led nine student tours abroad; she was a keynote speaker for EF in Paris, France. She earned National Board certification in 2007 and re-certified in 2017. Ms. Gams teaches English and serves as department chair at Spring Hill High School in Chapin. She is an adjunct professor for Columbia College. During COVID-19, Ms. Gams advocates for making curriculum and infrastructure decisions through the lens of Trauma Informed Instruction.
