

Tactics for Ensuring Safe Elections During the Pandemic

- We are reaching out to other organizations that may help spread the word among their members and public, to get even more citizen advocacy at work.
- The LWVSC VP for Issues and Action will be working with partner organizations and with legislators and staff to move these efforts forward.
- Local Leagues are being asked to spread the word regarding our campaign and the letter-writing initiative -- and follow up with businesses, non-profits, community, and church groups to encourage their participation.
- Local League leaders are being asked to work closely with their county election officials, supporting them in whatever ways are possible.
- Local League leaders are being asked to write op-eds and LTEs, as will the state LWV leaders, to help energize the public.
- Local Leagues are being asked to seek opportunities to address legislative delegations when they meet before September 12.

TO further engage the public, we ask members to brainstorm ideas in your local Leagues, considering the following:

- Vote411 is our most crucial tool to inform the public about the election, and it must be maintained and promoted.
- Encourage use of on-line voter registration at www.scvotes.gov.
- Ensure that voters eligible for absentee voters (we hope ALL SC voters) know how to vote, including the somewhat complex SC process of applying for an absentee ballot and voting absentee.
- Inform voters that South Carolina will provide prepaid postage for absentee ballots.
- Encourage the public to check the status of their registration and of absentee applications and ballots at www.scvotes.gov in time to correct problems if they occur.
- Encourage the public to “flatten the curve” at election offices and polling places by applying for absentee ballots early and sending in their absentee ballots early, or else voting early in person.
- Because of changes in the administration of the U.S. Postal Service, it is critical that absentee ballots be mailed in at least a full week

before Election Day. This means applying for the ballot well in advance of that.
