Aleta H. Robinson - My League Story

In 1964-65 I lived in Charlottesville, VA, teaching while my husband finished his degree. Driving through town one afternoon I heard on the radio that the League of Women Voters was having a voter registration drive at the shopping center. I decided right then that, when we got settled in our first jobs, I would join that organization! When Ed and I moved to Jonesboro, Arkansas in 1965, the Dean's wife met me on the steps of our new home, and guess what?! DAISY was a member of the LWV of Jonesboro!! We were instant friends and have remained so for 50 years! We remained active in the League - holding offices, babysitting for each other while we conducted annual finance drives in the community, and continuing to support our husbands in their social obligations. I was almost on the LWV-OK Board, but we moved to Clemson about that time.

In 1971 we moved to Clemson and have been here ever since. Being a Furman graduate I never thought I would LIVE here, and it was an interesting adventure. I immediately joined the LWV - Clemson. Ellen Reneke gave the first program on social justice, complete with posters, pictures, and great dialogue.

It has been interesting to "live through" all the changes in publication, communication, programs, and lifestyles among League members: we started with telephones, typewritten letters and information, working with newspapers to get out our work and positions and advocacy. We kept the telephones hot!! We printed and distributed voter service Candidates Questionnaires for every election, called the candidates for the forums and the details, "pounded the pavement" still for finance drives to support our work, and we knew the merchants and citizens of this small college town. I served mainly in finance drives and membership and presented programs, and then I became interested in Criminal Justice and served on the LWV-SC for several years. Slowing down now I try to be faithful in attending meetings and helping with Membership. I have loved my 50 years in League; next to faith and family, LEAGUE has been a very important part of my political, social, and community life.

Thoughts on Defending Personal Information

Principle: If data is available through the internet (phone), it is hackable. Assume that all your data is hackable and

- Minimize the possibilities for problems
- Regularly inspect your data
- Assume that your social security number has been hacked.

Minimize the possibilities for problems

Ask financial institutions about their procedures for withdrawal of money. Some financial institutions require personal contact with a designated representative for withdrawal. Some will transfer funds only to another branch of their institution.

Put a freeze on all three credit agencies. <u>https://www.washingtonpost.com/news/the-switch/wp/2017/09/09/after-the-equifax-breach-heres-how-to-freeze-your-credit-to-protect-your-identity/?utm_term=.8706500c1b09</u>

Do not use ATMs to withdraw money. Do not create any way for an ATM to be used to withdraw money from your account. (I'm not really sure about the protections that you encounter with a debit card because I do not have a debit card for any US bank.)

Invent your mother's maiden name – anything except the real one. Keep a record so that you will know what you used. It might be helpful to use a different mother's maiden name for different accounts.

Regularly inspect financial accounts

Assume that your social security number has been hacked

So many data records have your social security number that some hacker is almost certain to have it. Every doctor you go to, every credit agency/bank you have used, the State Elections Commission, every person who asks you for a picture ID, ..., has your SSN.

The problems we have not even anticipated can still "bite" us

A friend of mine had her account at a financial investment institution hacked. The hacker changed the mailing address before attempting to withdraw money. The hacking was accidently discovered when the hacker called the financial institution to withdraw money and the phone was answered by someone who knew my friend personally and became suspicious.

David Crockett (One Click Wonders, Seneca) encountered problems after his tax information was stolen from South Carolina. The hackers filed for a refund of his tax money. You might talk to David about what happened. My memory is that, since the hackers had already taken a refund when he filed his taxes, processing of his return encountered a considerable delay and other problems.

If you can access data with your phone, it can be stolen and/or changed. (Remember that when you say you want to use your phone to vote!) *submitted by Matt Saltzman*

Concerned about gerrymandering? Don't Miss This Meeting

The non-partisan League of Women Voters of South Carolina (LWVSC) is advocating for an independent redistricting commission to draw General Assembly and Congressional district boundaries after the 2020 census, and for better defined criteria for drawing these boundaries. The League is taking a lead on redistricting because we believe democracy works better when voters choose their legislators rather than legislators choosing their voters!

Because redistricting can be a complicated and tangled subject, LWVSC wants to prepare local Leagues to assist in the effort for better state and congressional redistricting and to work for better redistricting in local county and city elections. We will provide information and tools to assist your efforts and unify our voices. Gerrymandering has a lot of momentum protecting it and so we need a lot of momentum to challenge it. Our goal is for every local League to have trained members prepared to educate others about why this issue matters and energize broad public support for a fair process of redistricting.

Three regional meetings across South Carolina will train local League members to help this effort. The Upstate Leagues (Clemson, Greenville and Spartanburg) are meeting on September 30 Greenville at 10 AM at the Pellham Road Greenville Public Library 1508 Pelham Road. The meeting will last for 2 hours, and we hope each local League will send 3-5 people to participate. The agenda has been designed to send every participant home prepared to lead a local program, teach others and spread the word!

Our local training and outreach is being amplified by a broad network of advocacy support from other nonpartisan organizations including AARP of South Carolina, Conservation Voters of SC, the NAACP of SC, and others. Direct lobbying will build legislative support for independent redistricting bills and tighter criteria.

In Memoriam

Dianne Haselton

1932 – 2017

Dianne was such an enduring presence in the League of Women Voters of the Clemson Area and the Clemson community that when she left us on May 29, it was hard to believe. We will remember her for living life to the fullest. From 1970 to 1974, she was our first president after the provisional period and served the LWV locally and at the state level for almost fifty years. She was



one of the first women elected to the Clemson Zoning Board of Adjustments and Clemson City Council. She went on to serve the Clemson Child Development Center as newsletter editor and in other capacities for many years and was an active member of the Elks Lodge in Pendleton, She retired as a research analyst in the department of agriculture and applied economics at Clemson University. As a freelance typist she produced doctoral dissertations and reports for others at the university. We extend our sympathy to her sons, Bill and Bob, and her three grandsons.
