A Message From the President

Dear Members,

"Trial by fire."

"Survival of the Fittest."

"What doesn't kill you, makes you stronger."

You have heard these phrases used to describe difficult situations. You may have uttered them yourself. Watching the news lately, I have even thought, "This is almost Biblical!" Fires in California. Hurricanes in the Gulf States. Millions infected with Coronavirus. Citizens marching in protests. Recordsetting heat waves. Rising sea levels.

VOTER GUIDE



Invitations to participate in VOTE411 online and print voter guides were sent to 27 candidates on August 25. Candidates have until September 15 to respond to be included in the print voter guide, but late responses will be included in online versions.

VOTER SERVICES, REGISTRATION, EDUCATION

The November election is less than 60 days away. What we do as League members takes on added importance as this election season comes to a close.

The Akron and Hudson Leagues are collaborating with the AkronVotes2020 coalition to plan events for National Voter Registration Day on Sept. 22. The Akron-Summit County Public Library system has joined the effort and will offer drive-through voter registrations at some library locations. We will need volunteers to help out and will let you know when and where you can contribute.



Interest has increased in helping with the postcard campaign targeting registered voters in Akron. Together with partners the NAACP; sororities Alpha Kappa Alpha, Delta Sigma Theta and Sigma Gamma Rho, the Hudson League and the Unitarian-Universalist Women's Association, we will mail out 8,500 postcards

Members are also distributing 150 colorful posters announcing this year's voter registration deadline. Members take the posters to groceries, pharmacies, community bulletin boards and drive-throughs in their neighborhoods throughout the Akron area. ADVOCACY

LWV Ohio Challenges State's Ban on Additional Ballot Drop Boxes for General Election. Drop boxes are an important option for people who vote from home.

On August 26, the League of Women Voters of Ohio filed a lawsuit against Secretary of State LaRose challenging his unconstitutional August 12 order limiting drop boxes to one per county. The League asks the court to rescind this order and adopt a reasonable drop box-to-voter ratio for each county. Joining the League are Ohio A. Philip Randolph Institute, the Ohio State Conference of the NAACP, and seven individual voters.

"Access to the vote depends on safe, reliable options for casting a ballot, and limiting drop

boxes to one per county severely diminishes this access. To do so during a deadly pandemic is negligent and foolhardy," said Jen Miller, executive director of the League of Women Voters of Ohio. "Ohio should emulate other states by allowing multiple, secure drop boxes per county, otherwise communities of color, rural Ohioans, immunocompromised individuals, and income-sensitive voters lacking affordable transportation face unfair barriers to the ballot. As the COVID-19 virus continues to threaten the lives of Ohioans, the State should be focused on expanding safe voting options, not reducing those we do have."

What can you do? Contact the Secretary of State Frank LaRose at **614.466.2655** and let him know Ohio voters need additional drop boxes.

OHIO LEGISLATIVE BRIEFS: What will be on the near-term Ohio Statehouse Agenda this fall? Prepaid postage for returned ballots? State lawmakers have asked for more time to consider Secretary of State Frank LaRose's request to spend up to \$3 million on pre-paid postage for absentee ballot envelopes, Andrew Tobias of Cleveland.com reports. LaRose now plans to send the request to the state Controlling Board on Sept. 14. While LaRose says his office could provide the pre-paid postage despite the tight timeframe, it is unlikely that the Controlling Board will approve.

Repeal of House Bill 6? The State Senate returned to Columbus on September 2, for their first full session since June 30. While a majority of Ohioans expect a swift repeal of HB 6, the \$61 million racketeering scheme behind the original legislation that led to the indictments of former House Speaker Larry Householder and four others, the new House Speaker, Bob Cupp is taking a different approach.

As reported by Statehouse News Bureau's Andy Chow, Cupp is establishing a special committee to hold hearings on the law and its possible repeal. Democrats are decrying this approach as a delaying tactic. Nearly every Ohioan can expect an increase in their electric bill next year if the scandal-ridden legislation isn't repealed.

What can you do? Contact your legislators to demand repeal of HB 6. HB 6 demonstrates the influence of dark money. A number of bills have been introduced to offer greater transparency to the role of undisclosed financial sources in elections. Common Cause is advocating for support of HB 737, others are supporting HB 739 saying it's more comprehensive.

What can you do? Contact your legislators to let them know you demand increased transparency in our elections.

Bipartisan proposals languish. Bob Cupp, the House leader who replaced Larry Householder, is not expecting to advance much legislation during the lame duck session this fall. Meanwhile, as Terra Goodnight of Innovation Ohio reports, the following bills await action and will need to be re-introduced in January if no action is taken.

- The Ohio Fairness Act, to prohibit discrimination in housing, employment and public accommodations on the basis of gender identity and sexual orientation
- Ending Ohio's unsustainable private school voucher program
- Reform of Ohio's property wealth-based formula for funding schools
- Bipartisan gun safety reforms like a red flag law and safe storage requirements
- Nuclear bailout repeal and restoration of renewable energy and efficiency standards
- Ending the experiment with Academic Distress commissions
- Modernizing Ohio's election system including online ballot requests and automatic voter registration
- Drug sentencing reform
- Aisha's Law

As you consider your votes this fall, ask the candidates where they stand on the issues important to you.

NATIONAL BRIEFS:

Rejected ballots. More than 500,00 ballots were rejected in primaries around the country, reports Elise Viebeck of the Washington Post. These rejections illustrate "how missed delivery deadlines, inadvertent mistakes and uneven enforcement of the rules could disenfranchise voters and affect the outcome of the presidential election."

Ohio threw out one in every 100 ballots in the primary election, reports Dan Horn in the Cincinnati Enquirer. Ballots were rejected due to:

- Missed delivery deadlines (which could be alleviated by more drop boxes as advocated by LWVO in its 8/26/20 lawsuit)
- Signature mismatches (the LWVO signature mismatch lawsuit that is still making its way through the legal process)
- Simple errors

In a presidential race that may be decided by a few thousand votes this high rate of ballot rejections could influence the outcome, reports Horn.

Working with Harriet always opened you up to her unique perspective on life and her ability to get things done. Once, we were charged with driving around Ward 4 with a megaphone to encourage people to vote. As serious as the project was, we laughed a lot, especially when she had me climb in and out of the window of the front seat because the door was broken. I happily did so because she would have done the same thing! Working with Harriet was ALWAYS an adventure because in her quest for giving and volunteering, she created an atmosphere of childlike wonder with a piercing view of the truth.

She taught me how to knit her special hats for her Findley Elementary School readers. I always looked forward to seeing Harriet and Harloe at League and other activities throughout Akron. They seemed as committed to Akron as they certainly were to one another. We will miss Harriet and her laugh, seeing her around town with Harloe, her infectious spirit. It was fun and educational knowing Harriet.


