

Spotlight on Redistricting

Marge Easley

League members around the state are keeping a close eye on Oregon's redistricting process, currently in the hands of the Oregon House and Senate Interim Redistricting Committees. Due to census delays related to Covid, the timeline is extremely tight, as shown by the schedule below:

September 7, 5:30 p.m. - deadline to submit maps **September 8-13** – virtual public hearings by congressional district
The hearings for District 5 (Congressman Schrader's district) will be on **September 9**, **1-4:00**

p.m. and **September 13**, **8-11:00** a.m. Residents of any district may weigh in on **September 13**, **1-4:00** p.m. and **5:30-8:30** p.m. More detailed information about the redistricting process and how to watch hearings or submit testimony can be found here. *

September 27 – deadline for the Legislature to enact redistricting plans

The Redistricting Committees must take into account population changes around the state and draw boundaries for both legislative and congressional districts. There are 60 Oregon House districts and 30 Oregon Senate districts, and the task of drawing congressional districts has recently been complicated by the awarding of a 6th congressional district, due to population growth in our state since the 2010 Census. In drawing district lines, the Legislature is tasked with ensuring that each proposed district:

- is contiguous
- utilizes existing geographic or political boundaries
- is of equal population
- does not divide communities of common interest
- is connected by transportation links

Since the stakes are high, and the above criteria is subject to interpretation, the public hearings should be interesting. If the Legislature fails to reach agreement on legislative redistricting by the deadline of September 27, which has happened all but twice since 1911, the task then falls to Secretary of State Shemia Fagan. She has already started accepting applications for a "People's Commission" that will provide nonbinding input on the map-drawing process. If the Legislature fails to draw congressional districts, the final decision will be up to a panel of five retired judges named by the Oregon Supreme Court. February 8, 2022 is the final deadline set for adoption of the legislative and congressional plans.
