Dear Members and Friends,

Vacationing up here is something I've done every year of my life, save two, and I don't find these weeks boring, but rejuvenating! No pressure, except for finishing this message and working up the courage to swim in the frigid waters once again!

This year begins our 94th year making a difference, particularly in Highland Park. All this is to say that we are a vital part of our communities – Highland Park and Highwood. Our League mourns the passing of Margie Weiss on August 5, 2021.

Along with her service to Highland Park, as a Council Member and so much more, she was a League member for decades and President of our League for many years. Through the decades, Margie was instrumental in many of our studies and positions.

Margie's influence on so many aspects of Highland Park and our League is her lasting legacy.

May her memory be for a blessing.



Under Margie's leadership, studies by the League were extremely in-depth with multiple local, state and National study committees going on every year. Our League had a physical office, phone and Margie managed everything professionally and with great aplomb. Some of the areas of impact during Margie's tenure of leadership in the League included her leading the successful City-wide Home Rule campaign (c 1980). Margie ran successfully for City Council, serving for 4 terms. She supported the School Consolidation and was a big proponent of arts and historic preservation. After her City Council terms, she returned to League leadership, serving again as President/Co-President. Long-time League member, Bryna Gamson, describes Margie as "super intelligent, committed to community and a dynamic, proverbial force of nature."

The start of our League's online Newsletter began in 2010 with Margie having a clear vision for what the bulletin should include. She stressed that the order should be bottom-up: Local, County, State and National. We still follow that order today and Margie's guidance and knowledge were invaluable to me as a rookie. She also was a minimalist, not a fan of images and clip art. We laughed, when Margie and I met for recent (pre-pandemic) enjoyable lunches, reflecting that I had forgotten that part of her guidance. STUDIES

At our well-attended Zoom program planning meeting in May 2021, members were enthusiastic about a lot of future work. The group recommended work on three studies—all of which were approved by the Leadership Team and then the membership at the annual meeting—dependent on finding enough people to do the work.

Parks and Recreation Position.

A study of this position was actually approved a year ago, but was postponed until after the municipal election and due the need to recruit volunteers. The original [proposal](#), by now Leadership Team member Jean Sogin, can be found on our website. Jean has recruited a number of members to work on this project and given a lot of thought to how to proceed. See Jean's [article](#) on how she would like to begin in this newsletter. Jean will co-chair the study, but we need a co-chair. [Email our League](#) if you are interested.

Library Position

Our Library Position was written in 1986 and last updated in 2003. [\[long position\]](#). The uses and functions of community libraries have changed a lot since then. We would like to take a fresh look at what materials, services, activities, and policies should be emphasized in our 21st century library.

Lucky for us, another two new members of the Leadership Team, Candice Dalrymple and Sabina Gasper, recently moved to Highland Park, and have agreed to chair this study. Both are experienced Leaguers. [Email our League](#) if you would like to join this group.

Campaign Practices and Procedures Position

This position was written in 2002 and revised in 2003. [\[long position\]](#). Aside from our League's comprehensive voter guide for Highland Park and other governmental entities, we are not aware of any attempt to implement the elements of this position. POSITION ACTIVITY

During 2021-2022, we will monitor activity related to our positions in the following areas:

1. Monitor activity on inclusionary zoning under Housing Position, providing education and possible testimony.
2. Monitor sale of property by School District 112 under Criteria for Local Government Acquisition, Development, Divestiture of Public Property Position.
3. Monitor City Equity Study for information relevant to potential programming, action, or study.
4. Under all relevant Environmental Preservation Positions, including National and State positions, coordinate with Go Green and any other local environmental organizations to monitor and support any effort to increase the City's target for the reduction of greenhouse gases by 2021 and to set a new and stronger target beyond 2023.

Review of current positions:

Climate and Equitable Jobs Legislation in Illinois

Have you been following the progress of the proposed clean energy jobs legislation in the state legislature? Debate has been underway for several years and positions favored by organized labor and environmental and equity groups have sharpened the focus of their priorities over the summer. Action to move legislation forward is urgently needed this month. Some of the principal Issues under debate include:

- The largest source of carbon emissions in Illinois (and 7th largest contributor in the nation) is the Prairie State coal plant near Marissa. Legislation has been proposed that would set a date for *closing Prairie State* within 14 years, with a 10-year extension of a firm closure date if the plant can show an ability to capture 90% of its carbon emission.
- Reactivation of *state funding to support renewable energy* to provide incentives for new solar installations and reinvigorate the solar energy production and installation industry that was booming in Illinois until installation support ran out several months ago.
- Discussion about *closing the state's Byron and Dresden nuclear plants*, which have long been unprofitable, complicates the broader energy discussion in Springfield. If these plants close, 1,000 jobs in carbon-free energy production will be lost, underscoring the need to advance clean energy production and job alternatives to address labor concerns.

Vigorous debate is underway between environment groups (allied as the Illinois Clean Jobs Coalition – ICJC) and a coalition of labor unions (Climate Jobs Illinois – CJI) and the existing energy industry. Both sides appear to have enough legislative support to block passage of legislation backed by their counterpart, even as Gov. Pritzker has stated clear support of comprehensive, clean, equitable, and ethical energy reform.

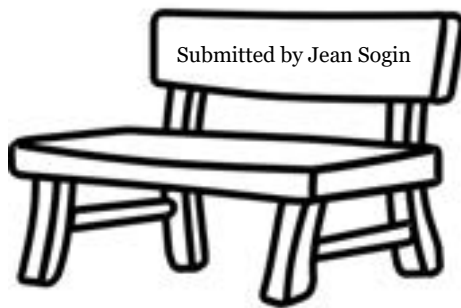
The League of Women Voters at the national, state, and local levels supports climate action legislation that is aimed at dramatically reducing our collective carbon footprint. We can help by contacting our local representatives in both the House and the Senate to express strong support for legislation that advances carbon-free energy generation. Please consider contacting your representatives to pressure Senate President Don Harmon and House Speaker Chris Welch to bring the groups together and craft legislation that enables Illinois to play a leading role in reducing carbon emissions while addressing the priorities of industry and worker populations who will be impacted.

Park District Study

The League of Women Voters of Highland Park and Highwood is embarking on a study of the Park District of Highland Park. An overview of what it will encompass is on the League's website. The study will be done in phases and the first part asks the question "should Highwood be part of the area served by the Park District of Highland Park?" That means Highwood residents would not have to pay non-resident fees for programs, or beach parking and would have equal access to popular camps and programs that typically have no space for non-residents.

How much would property taxes in Highwood increase? Would Highwood residents want to be part of the HP Park District? What is Highwood's population profile? Would the HP Park District need to expand its programming or staff to accommodate Highwood residents? What are the political and administrative steps to change the Park District's boundaries?

Openlands Lakeshore Preserve



Openlands Lakeshore Preserve closed in April due to unexploded ordnance found on the former military Fort Sheridan property.

Openlands is one of a few open green spaces in our area. It is a treasure and it is a big loss to our community that it remains closed.

A latest update on Openlands website "...This week, Openlands learned of the Navy's refusal to complete an onsite investigation despite documented public safety concerns. Until an onsite investigation and any necessary removal is complete, it is imperative that the public stay out of the Preserve. Any entrance is unlawful trespassing and potentially dangerous. "

Our League has asked questions of Congressman Schneider, State Senator Julie Morrison and State Representative Bob Morgan.

The City of Highland Park has also made inquiries. Mayor Rotering has communicated on behalf of the City of Highland Park with the Naval Station Great Lakes, asking for assistance to ensure that the property, previously owned and operated by the military, is safe for public access. While Openlands infers a stalemate, perhaps collaboration is possible.

Watch your emails for suggested messaging that we can send to our Federal representatives: Congressman Schneider, Senator Durbin and Senator Duckworth.

Changes have been made to our Financial Administration Section of our League's Bylaws:

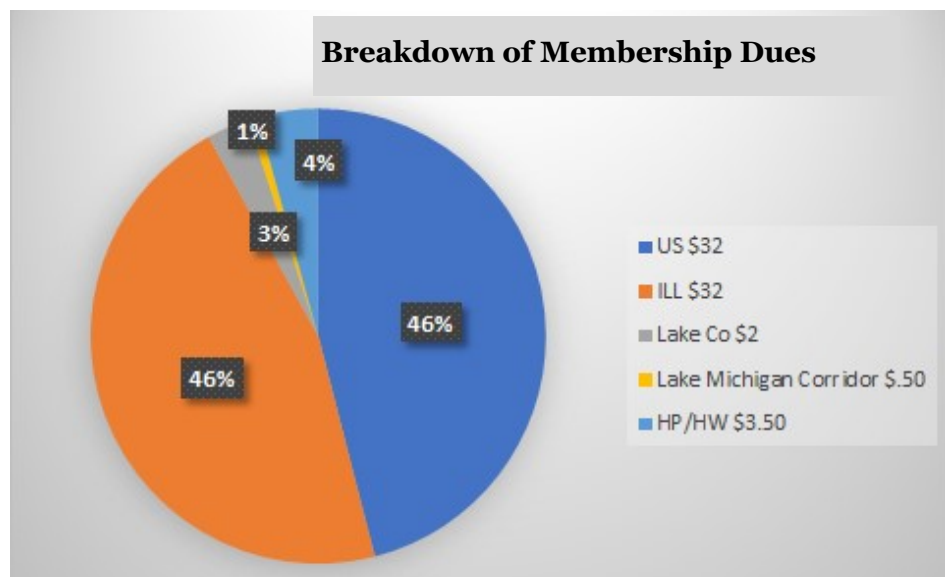
- Dues for **New** members who join after January 31st of each year, shall be applied to the following national membership year.

Spotlight on LWV Highland Park/Highwood Member, **Mary Beth Arzac**



Mary Beth Arzac joined LWV HP/HWD in 2019 after attending a membership meeting where our guest speaker was the LWVIL Executive Director, Audra Wilson.

Early this year, I asked Mary Beth if she would be willing to host our League's virtual (Webinar) Local Candidates Forum in March. She had been hosting other Zoom meetings and responded quickly that she would be honored, especially for one of the most important services our League provides to our communities. Mary Beth soon learned that Webinars are quite different than Meetings, requiring a significant learning curve. Undaunted, she proceeded to view tutorials; connect with the LWVIL Chairs (enabling us to use the State League's Webinar resource); and coordinate with our Voter Services Committee. Mary Beth and I worked closely as a team, and as happens in League, forged an enjoyable new friendship. The Candidates Forum was a big success. Personally, I don't know how she juggled a full-time job and the amount of work this task involved. It was a big "ask" and this is an

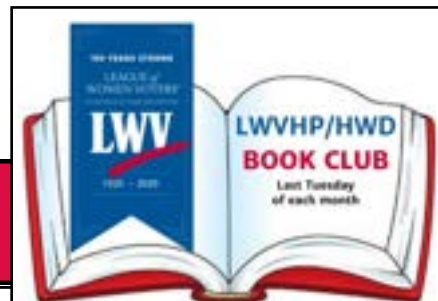


VOTER REGISTRATION NEWS

Lake County has just announced two upcoming Deputy Registrar Training Classes. Any league members who want to become registrars should email [Nancy Goldberg](#).

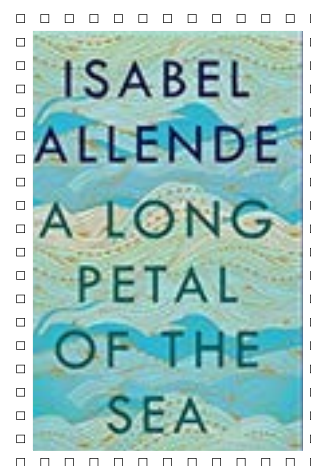
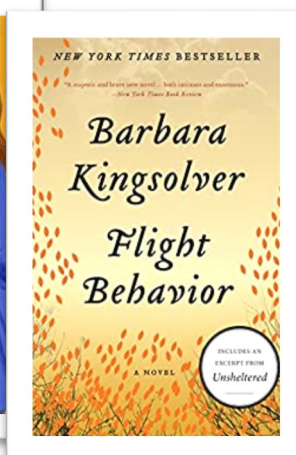
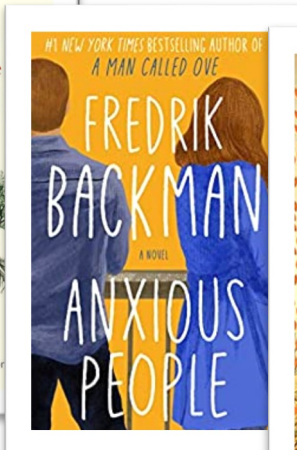


LWVHP/HWD BOOK CLUB

LWV STATE AND NATIONAL ISSUES

In addition to our League's foci this year on our local issues ([See Program for 2021-2022](#)), we continue to keep up with issues at national and state level. All members receive emails from LWV OF ILLINOIS. They can be Action Alerts, LWVIL Member Bulletins or LWVIL News You Can Use. Please make sure to read them. In the most recent Member Bulletin, one can sign up for Observer Training (10 to 11 AM on August 19, virtually), find out how to help protect the great Mississippi River, and join members of the League in honoring suffragist Grace Wilbur Trout with a marker and reception in Oak Park.

The most critical (in my opinion) issue for the Illinois and U.S. League, highlighted in the LWVIL Bulletin, is getting the **"For the People Act" passed by the Senate**. Our democracy depends on every voter having the right to vote, no matter where they live. You can help with your action! Call our senators but also contact your friends out-of-state and ask them to contact their legislators to get their support. I just shared the LWVIL "For the People Act" post on my Facebook page. You can do the same. If you have questions about the provisions of this act, you can find answers on the League websites or the Brennan Center for Justice (<https://www.brennancenter.org/our-work/policy-solutions/annotated-guide-people-act-2021>).

Members should also be receiving letters from LWVUS CEO, Virginia Case Solomon, and monthly Highlights from the League of Women Voters of the US. The most recent email letter described the new four-pronged initiative to protect our democracy, [Women Power Democracy \(https://www.lwv.org/educating-voters/women-power-democracy\)](https://www.lwv.org/educating-voters/women-power-democracy), through advocacy, litigation and organizing. LWVEF will mobilize State and local League to collaborate with partner organizations to repair the damage to our democracy while increasing voter participation during the election cycle in 2022 and the next presidential cycle in 2024.

Since completing LWVIL Criminal and Juvenile Justice Study last spring, the committee remains active. Janet Kittlaus, chair, continues to monitor research studies, legislation and implementations for the committee. Here are some of her latest "finds":
