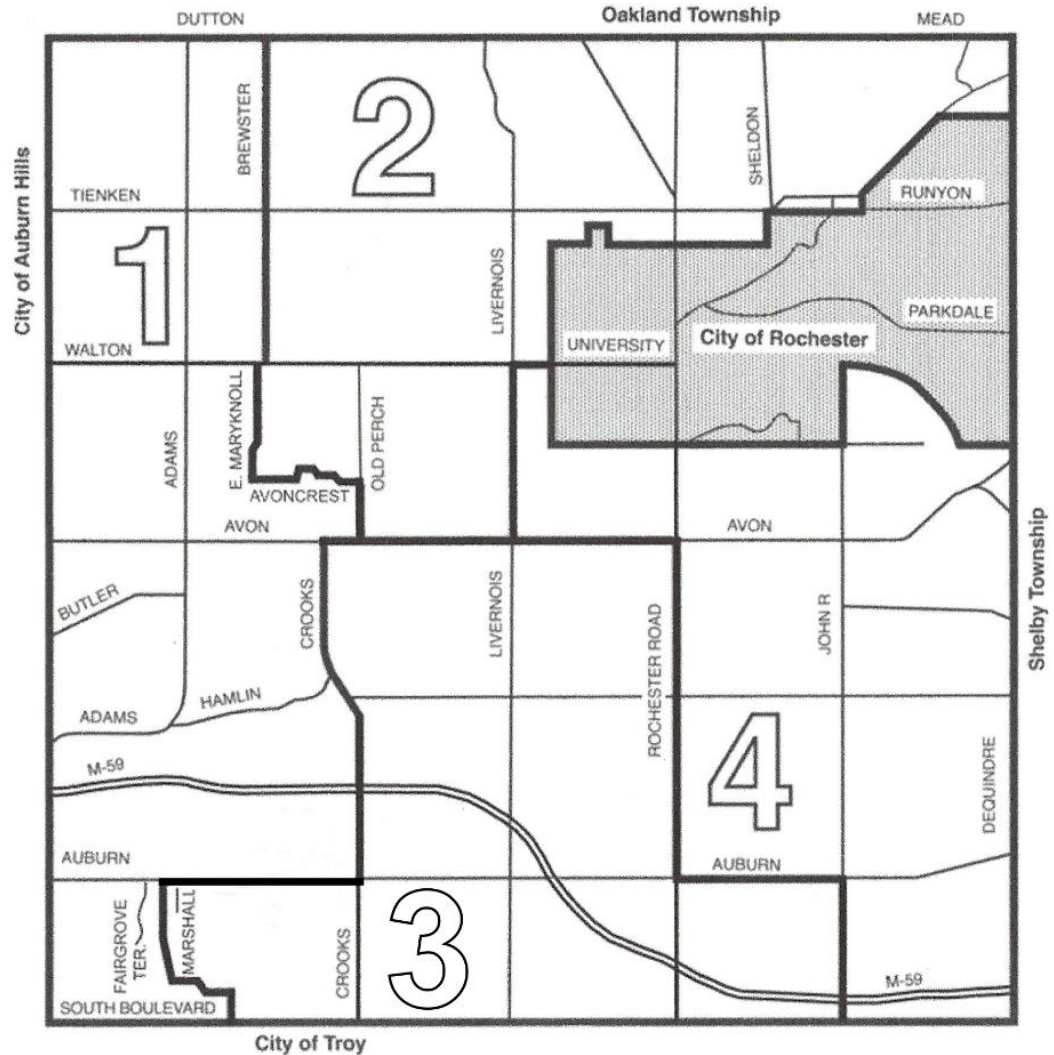

WHERE TO REGISTER TO VOTE:

- At the clerk's office in the community in which you live,
- or at any Secretary of State driver's license office,
- also mail-in registration form up to 2 weeks before election,
- or register in person at your clerk's office up to and including Election Day.

YOU MAY VOTE IF YOU ARE:

- A citizen of the United States, and
- 18 years of age by the date of election, and
- a resident of the community for 30 days, and
- can vote by absentee ballot for any reason,
- if you register on election day, you will vote at your clerk's office.
