O.C. Ethics Czar Addresses Lunch with League

The speaker at our January Lunch with League was Denah Hoard, the Executive Director of Orange County's Campaign Finance and Ethics Commission. As a litigation lawyer, Ms Hoard has an extensive background in resolving questions of ethics, conflicts of interest, issues regarding antitrust law, and police litigation. The Commission was approved by voters in 2016, and its mandate is to provide primarily lobbyists and candidates for county office with guidance on how to comply with Orange County's ordinances regarding campaign finance, the ban on gifts to political



candidates and office holders, lobbyist registration and reporting, and the County Code of Ethics.

Upon assuming her job as the Commission's first Executive Director, Ms Hoard was very conscious of a need to further define her role and the role of the Commission in Orange County politics. Would it be more a matter of uncovering criminal behavior and bringing miscreants to justice, or would it be more a matter of advising people about how to comply with the law. Her presentation at our luncheon was entitled "Whether to be Feared or Respected." She took office prepared for both approaches as needed, and with doubts about whether the Commission had enough independence to carry out its mandate.

After all, she might be called upon to prosecute her own bosses.

The Commission has subpoen power, the power to demand documents and personal appearance before the Commission. It also has access to a database showing all political campaign contributions. With this kind of power and information, the Commission is an independent force that cannot be ignored. Dishonest politicians have good reason to fear it.

At the luncheon Ms Hoard was happy to tell us that so far she has never needed to use the subpoena power because every document the Commission has requested has been promptly provided. She has found that candidates just want to know how to do things right. Her personal aim is be trustworthy, visionary, flexible, and empathetic in her guidance, but firm in demanding ethical behavior in Orange County politics. She has found that county codes and municipal codes can sometimes pose paradoxes that perplex candidates, and she is working with others to resolve contradictory language and provide more clarity. Her office has compiled a campaign manual and sent it to the Orange County Board of Supervisors.

February Lunch With League



Our February speaker is Norberto Santana Jr. Mr. Santana is an award winning investigative reporter with nearly two decades reporting experience, most recently engaging Orange



County government institutions and decision makers as the founding publisher of the nonprofit digital newsroom, **Voice of OC**. As publisher, Santana oversees all newsroom, engagement and fundraising operations and also writes a weekly Opinion column about Orange County government. In 2017 and 2018, the Orange County Press Club recognized Mr. Santana as Orange County's best columnist.

Mr. Santana began his journalistic career in the early 1990s as an apprentice reporter with **Congressional Quarterly** in Washington, DC, covering daily floor action in the U.S. Congress and followed that with a stint covering the territorial Senate for the **US Virgin Islands Daily News**.

Before founding **Voice of OC** in 2009, Mr. Santana was a lead investigative reporter for the **Orange County Register** from 2004-2009, focusing on county government. He has spent nearly two decades just focusing on local government across Southern California, previously as a staff writer with outlets such as the **San Diego Union Tribune** and **San Bernardino County Sun.** In addition to his experience as a journalist, the Southern

California native has a Masters in Latin American Studies, has worked as an elections analyst on National Endowment for Democracy programs across Latin America and was one of the founders of CubaNet.org, a website featuring the work of dissident journalists inside Cuba that has operated since 1995.

Currently there are only four Board of Supervisors: Chair Bartlett, (District 5), Supervisor Do, (District 1) Supervisor Steel, (District 2) and the Nov. 6 newly elected (District 4) Supervisor Doug Chaffee, from Fullerton. Chaffee replaces termed out Shawn Nelson, who was promptly appointed to be the Asst. to the Nov. 6 newly-elected OC District Attorney Todd Spitzer. Spitzer had been District 3's Supervisor but chose to vacate the position to run for DA. His win necessitates an election for a new District 3 Supervisor (portions of Anaheim and Yorba Linda). Candidate filing deadline was Jan. 28. **The election will be held on March 12.** The votes will be counted, and a new supervisor can be sworn in at the March 28 BOS meeting. Yeah, a bit of an upheaval of positions.

The National Guard Comes to the Aid of High School Students by Jan Urban and Jennifer Trafford

There are many alternative educational programs that have been established to meet the needs of our youth. The Sunburst Youth ChaleNGe Academy is one that intervenes and reclaims the lives of 16-18 year old high school dropouts while producing graduates with the values, life skills, education, and self-discipline necessary to succeed as productive citizens.

Our North Orange County League of Women Voters was fortunate to have representatives from the National Guard, who operate this program, speak at our monthly Lunch With League. We were so impressed that League members signed up for a visitation to the Sunburst Academy facility located on the Naval Base in Los Alamitos. Sunburst is a residential program that operates two six-month sessions. The "Cadets" are high school dropouts who are US citizens or legal residents, drug free, and have no police record. These cadets are housed together, and for the first 22 weeks are immersed in a quasi-military environment in which they focus on discipline, academic excellence, team work, physical fitness, leadership, and service to the community.

We visited the dormitories, the classrooms, and the library, and observed the cadets engaged in their strict, no-talking lunch routine. We could feel the intense structure of the program, but we could also feel the support and respect for those students from the staff.

After six months, the students graduate with a GED or return to their neighborhood school to graduate. In addition, cadets receive mentoring and other supportive guidance during a one-year post-residential phase. Their parents are also requested to enroll in parenting classes that show them ways to help their son or daughter reach their education and employment goals.


There are currently 34 ChaleNGe Programs operating in 27 states and Puerto Rico, graduating some 8,200 high school dropouts each year.
