# In Light of the COVID-19 Outbreak, the U.S. Census Bureau is Adjusting 2020 Census Operations APRIL 13, 2020

APRIL 13, 2020 — The 2020 Census is underway and more households across America are responding every day. Over 70 million households have responded to date, representing over 48% of all households in America. In light of the COVID-19 outbreak, the U.S. Census Bureau is <u>adjusting 2020 Census operations</u> in order to:

- 1 Protect the health and safety of the American public and Census Bureau employees.
- 2 Implement guidance from federal, state and local authorities.
- 3 Ensure a complete and accurate count of all communities.

The Census Bureau temporarily suspended 2020 Census field data collection activities in March. Steps are already being taken to reactivate field offices beginning June 1, 2020, in preparation for the resumption of field data collection operations as quickly as possible following June 1.

In-person activities, including all interaction with the public, enumeration, office work and processing activities, will incorporate the most current guidance to promote the health and safety of staff and the public. This will include recommended personal protective equipment (PPE) and social distancing practices.

Once 2020 Census data collection is complete, the Census Bureau begins a lengthy, thorough and scientifically rigorous process to produce the apportionment counts, redistricting information and other statistical data products that help guide hundreds of billions of dollars in public and private sector spending per year.

In order to ensure the completeness and accuracy of the 2020 Census, the Census Bureau is seeking statutory relief from Congress of 120 additional calendar days to deliver final apportionment counts.

Under this plan, the Census Bureau would extend the window for field data collection and self-response to October 31, 2020, which will allow for apportionment counts to be delivered to the President by April 30, 2021, and redistricting data to be delivered to the states no later than July 31, 2021.

## LWV Applauds Election Funding in House Heroes Act

WASHINGTON – Today the League of Women Voters president of the board of directors **Chris Carson** issued the following statement in response to the U.S. House Heroes Act relief package:

"Our democracy depends on an election system that protects voters, poll workers, and the right to vote. The latest House bill does just that.

"Expanding vote-by-mail and ensuring safe and early in-person voting options gives all eligible voters the flexibility to cast their ballots safely this fall. At this unprecedented time, voters should not have to choose between their health and executing their constitutional right to vote.

"By providing \$3.6 billion to state and local election administrators, this bill ensures that our election systems are prepared for changes related to COVID-19. This funding, combined with the \$400 million from the CARES Act, meets the required \$4 billion election experts estimate is needed to safely administer elections this fall.

"We are encouraged by the proposed bill and look forward to working with the Senate and the White House to ensure that this critical election funding is passed and made available to states in time to fund our fall elections."

# LWV Defending Voters Across the Country

The LWV of North Dakota filed a lawsuit asking the US District Court of North Dakota to provide relief for voters from the state's burdensome signature match policy. Currently, North Dakota voters are not notified when their ballot is rejected due to a technical error such as signature mismatch, and there is no method for them to provide verification or cure the mistake to remedy their rejected ballots. The LWV of New Jersey is filing this same case in federal court.

The LWV of North Carolina has filed a motion to intervene in a lawsuit, *Judicial Watch* v. North Carolina, et al, which would remove individuals en masse from voter rolls in Mecklenburg and Guilford counties in the runup to the general election in November. Our Leagues in Michigan and Pennsylvania are experiencing similar challenges, and we will continue to push back in each state.

The LWV of Mississippi and LWVUS have joined as *amicus* in a federal lawsuit brought by three Mississippi voters who allege that their congressional district was gerrymandered to disenfranchise Black voters, violating Section 2 of the Voting Rights Act of 1965.

Our team is battling strict voter photo ID requirements in Missouri and Kentucky, fighting an attempt to add a "proof of citizenship" requirement to California's voter registration process, challenging the administration's repeal of the Deferred Action for Childhood Arrivals (DACA) program, and more.

The good news is that the League knows how to win. But our ability to represent voters in court depends on our donors. *If you would like to help support the League's efforts in these matters, visit www.lwv.org and click the Donate box.*

## Board of Supervisors Report by Wanda Shaffer, ILO / LWVNOC

A long day, a worrisome day! Of course, the two main topics were the budget and COVID-19. There will be budget hearings for the public in June; Sept. 1 for the Public Hearing and Sept. 15 for the final budget decisions.

Not a big agenda, but the meeting was incredibly long! Thirty-one of the 34 city mayors all spoke favorably on the issue of CARES ACT dollars going to the cities. Much discussion ensued on the best method of distributing it to the cities.

The final decision was that Supervisors Steel and Wagner would simply turn over their district dollar amounts to their cities for the cities' decisions and dispersal. CEO Kim reminded them that the federal govt. will ask for a strict accounting. Supervisor Bartlett will urge the small businesses in her district to consider long term loans with a line of credit. Supervisor Do and Chaffee preferred a central administrative plan that defines "small business" and sets up an over-arching plan while working with city managers. The lively discussion made it very clear that each district had different needs! Supervisor Do pointed out that 1/2 of all the Cal-Optima patients are in his District 1.

Understandably, CEO Kim is frustrated, in that most of the planned monies are in a state of flux! There will probably be more COVID dollars, more federal and state directives, more CARES Act money, and there is as yet no FEMA funding. The other reason the meeting was so long is disturbing! First Supervisor Steel introduced a vote on allowing in-person worship in churches as they pleased. She called Sheriff Barnes to the podium and asked if he planned to arrest citizens who went to church. He replied that no, he would not arrest people exercising their constitutional right. Over thirty-five pubic addresses were loud voices demanding "their constitutional rights" to not

> wear a mask, to worship in their holy buildings, etc. Supervisor Steel asked Dr. Chau why he has still not posted the number of recovered virus cases, as she had asked for previously. He stated that there is a wide variety of ways to count the "recovered" and because of that it has no She reiterated that meaning. she wants the numbers published. Some of the speakers spoke very strongly against Dr. Nichole Quick, of the Health Dept. (She was not present at this meeting, Some speakers were literally thankfully.)

screaming with raised fists about "her nerve to make illegal rulings on their lives." Some demanded her immediate firing. Such speech had to be allowed, but it was most disruptive and unfair! It was stated later that picketing citizens were on her front lawn, and that security had to be requested. At the end of the long day, Supervisor Steel said she was sorry for some of the public address statements, and that they were unfair.
