Same-day registration

You may register on Election Day. Go to your polling place. You may also register after October 15 at the Office of Elections. You will be given a provisional ballot. The Electoral Board will decide whether to count the ballot. To be sure that your vote counts, register by October 15.

Voter ID

You will need to present an acceptable form of ID, such as a Virginia driver's license, at the polls. See the full list of acceptable IDs at elections.virginia.gov.

1. Vote early in person.

2. Vote by mail. Apply for a mail ballot at elections.virginia.gov or at the Office of Elections. **Deadline** for applying: Friday, Oct. 25, 5 pm.

Mail your ballot in the postage-paid envelope postmarked by Nov 5, received by Nov 8, noon.

Take your ballot to the Office of Elections during office hours. A Drop Box is available in the Office of Elections.

Take your ballot to your polling place on Election Day by 7 pm.

3. Vote in person on Election Day, Nov 5. 6 am–7 pm

Find your precinct at elections.virginia.gov or on your voter registration notice.

Curbside voting is available during early voting and on Election Day for people with disabilities or health risks.

Constitutional Amendment 2024

Virginia Property Tax Exemption for Veterans and Surviving Spouses

A **"yes"** vote supports amending language in the Virginia Constitution regarding property tax exemptions for veterans and surviving spouses to say *died in the line of duty* rather than *killed in action*.

A **"no"** vote opposes amending language in the Virginia Constitution regarding property tax exemptions for veterans and surviving spouses to say *died in the line of duty*, and would keep the phrase *killed in action*.
