Advocacy Update

The legislature continues to provide plenty of opportunities for action from the advocacy committee. There are a number of sensible bills quietly moving through the system. However, this session has been remarkable for the sheer volume of bills that defy basic principles of sound governance or lack the commitment to the common good that could be taken for granted from any party even a few years ago.

The committee has tracked, researched and either acted on or issued calls to action on a range of issues from a consultancy-led state government redesign to stripping the State Auditor of the ability to conduct audits, to the reinstating the death penalty; as well as education, eminent domain, SNAP benefits, anti-

abortion pregnancy centers, anti-LGBTQ laws, removing gender balance on governmental boards and much more.

While the committee has no power to stop so many and such politically-driven bills, it is nonetheless important to educate League members, legislators, and the broader public of this alarming change. It has gone from an atmosphere of relative bipartisanship and respect for minority party rights to a callously majoritarian one, where the majority party and those who agree with them proceed with little apparent regard for other points of view.

Outside of the day-to-day legislative workings, committee members are also working diligently to create a guide to track legislation; the process by which a bill moves through the legislature is not intuitive. This guide is intended to aid LWVJC members and potentially other Leagues, partner organizations, or the public to easily follow and weigh in on legislation of interest to them. The information has been drafted by a workgroup and will soon be reviewed by the advocacy committee.

If you get a chance go to the museum, look him up. He's such a fine professional. In 2021, we dined along the Mississippi River and visited Eagle Park in Clinton. We learned from our friend Tim Wagner of the Isaac Walton League about soil quality.

This year, the plan is to dine at the Stone Cliff Brewery in Dubuque and drive to the Galena Public Library for a presentation from **Steve Repp** about the History of the Mississippi River on Friday, June 9, just before the annual LWVIA convention. The UMRR-ILO will hold its bimonthly, meeting Monday, April 3. The board meets at 10 a.m. The webinar program on Groundwater in the Driftless area will be held from 1 – 3 p.m. Visit the LWV Upper Mississippi River Region Facebook page LWVVUMRR or the blog and click here to register. Pictures and information about the Driftless Music Garden in Wisconsin are on the website, lwvumrr.org. The speakers will examine how groundwater works and its connections to surface water, and how land use impacts drinking water.

If you're thinking Iowa, think about the Farm Bill. Call your U.S. senators and representatives and ask them to support the bill. LWVIA President **Terese Grant** has signed a letter of support for this important bill. Of course, more money is always needed for projects, but the ask this year includes grants for those living along the Mississippi River to do what they think is necessary to prevent soil

loss (from runoff) and protect habitats to keep the river flowing naturally. Representatives like to hear "for flood control" in your conversation.

You might remember a few years ago, I wrote about PFAS (human-made per- and polyfluoroalkyi substances) and the dangers of this chemical mix. Iowa State University received \$1 million grant to study PFAS. Last year, the Iowa Department of Natural Resources began testing Iowa water for PFAS. Three Iowa rivers have been cited for too much PFAS, according to EPA standards, which is 4 parts per trillion, or 4 nannograms per liter. World Health Organization's, **Dr. Maria Neira**, Director of Public Health and Environment, states any level is dangerous and should be eradicated.

Among other things, PFAS cause cancer. Go to <u>EPA.org</u> and check the links concerning PFAS. There is a hearing scheduled for May 4 in Iowa and you can make comments in writing now.

Promote equal access to voting and ensure all votes are counted. Iowa should adopt automatic voter registration and pass a constitutional amendment allowing Iowans with felony convictions to vote after time served.



TRANSPARENCY

Demand government accountability and transparency by requiring all amendments and bills discussed in committee to be available to the public prior to a vote. Encourage direct citizen participation by continuing virtual committee and subcommittee meetings.



EDUCATION

Keep public money in public schools, fully fund public schools, and continue to expand access to affordable childcare.


