With the Iowa Legislature in full swing, now is the time to raise your voice. Bills are moving fast, and many of the bills will impact the daily lives of Iowans. Share your stories with legislators in person at the forum. Write or call them to tell them how you feel and where you stand on issues.

Leaguers are encouraged to sign up for Advocacy Alerts with talking points and a legislative contact list. To join the Advocacy team send **Shannon Patrick** an email. For a quick look at legislative trends in Iowa and the nation follow <u>Iowa Capitol Dispatch</u> or listen to the *Iowa Public Radio* podcast <u>Under the Golden Dome</u>.

The next LWVJC education program, *Abortion History Matters*, will be held Thursday, March 23, at 6:30 p.m., in the Iowa City Public Library. If you missed *Transparency Matters in Government and the Media* you can view the program on the Iowa City Public Library's YouTube channel.

The final Legislative forum will be held Saturday, March 25, from 9:30 to 11:30 a.m., in the Hills Community Center, 110 Main St., Hills. This forum will focus on environmental stewardship. The forums are a great place to wear your League shirt. You can order League shirts in neutral colors and financially support LWVIA.

On Sunday, March 26, the League will celebrate 150 years of Coralville and Iowa history at the Coralville Public Library, from noon to 3 p.m. We will host a table celebrating Samuel Kirkwood, a Coralville business owner, Iowa governor and senator; Carrie Chapman Catt, founder of the LWV; Amelia Bloomer and other early Iowa suffragists. year. Interested members met Feb. 19 to discuss our many concerns and priorities. The discussion centered on two areas: good governance and public health/safety. While we are all concerned about clean water, school funding, streamlining government, workforce issues, and reproductive rights, we know good governance is at League's core: *Empowering Voters. Defending Democracy*.

We plan to encourage LWVIA to follow up our proposal last year to correct mapping disparities using the Geographic Information System. (Editor's note: additional information about GIS, can be found in the February 2022 Voter.) We will also propose a state study of Transparency in Government. Our League's transparency purchasing study can be used as an example. There's a lot of interest in state government transparency given: the news conference cancelations, the removal of the media from the floor of the Senate, and the slowing and/or denying Freedom of Information requests.

Our League is also interested in exploring local control and Home Rule. If you are interested in studying these subjects, please contact Miriam. (Editor's note: The Home Rule Amendment to the Iowa Constitution was passed by Iowa's electorate in 1968.) Iowa City is one of four cities in Iowa with a Home Rule Charter, though lately, it is apparent that we have less local control as the legislature has legalized the sale of fireworks, tells teachers exactly what they can say, and has pre-emptively prohibited a ban on plastic bags.

Please add the LWVJC Annual Membership & Business Meeting to your calendar. The meeting will be held Tuesday, May 23, at 5:30 p.m. Watch for more details in an upcoming *Voter*.

# **Advocacy Update**

The Advocacy Committee has been reorienting after the blitz of private school voucher bills and determining where we can make the most impact amidst the torrent of new bills. Many of these new bills fall somewhere between appalling and awful, but there are a few good ideas in the stack. Here's a list of issues that we are closely watching as of this writing:

- SNAP and nutritional support: unlike earlier versions, this bill no longer prevents food aid from being used to buy staple foods, but it still imposes impractical and counterproductive requirements for assistance. HF3
- Gender balance requirement for boards and committees: Iowa law has long required an attempt to create gender parity on government boards and commissions. The current law allows a 90-day period to make an effort for balance. There is a bill to repeal that requirement, but it may have stalled out. We are keeping an eye on it. SF136
- Human trafficking: a non-controversial bill passed the House last year would have the state treat trafficked minors as victims instead of offenders. We are encouraging the legislature to take this bill up again this session.
- Voting: a mix of bills have been proposed about voting. We would be delighted to support a bill that restores a 40 or 45-day absentee voting window, and some that would fix the recount issues that were real problems in 2020. We are also watching worse bills, that would in one case require provisional ballots for all votes cast after same-day registration.
- Anti-abortion pregnancy centers: Iowa

should not hand off reproductive care services to faith-based organizations that do not have medically-trained staff. However, this is part of a larger healthcare bill that may contain provisions we would support, so we are educating ourselves and determining how to approach this issue. HSB126 and SSB1123 government reorganization bills

We have a great committee doing excellent work on these issues, and those of you on our larger Advocacy Alert list should expect more updates as the session progresses. If you are not on the Advocacy Alert mailing list but would like to be, please contact me or any member of the committee.

Reproductive rights are under attack. Two speakers will present, Patricia Cline Cohen is professor of history emerita at the University of California Santa Barbara and the co-author of the friend-of -the-court brief submitted to the U.S. Supreme Court in Dobbs v. Jackson Women's Health Organization. She will be joined by **Lina-Maria** Murillo, University of Iowa gender, women's sexuality studies and history professor, who will discuss the history of abortion in Iowa.

The program will be presented in person and live-streamed on the Iowa City Public Library's YouTube channel.

# **LWVIA Public Policy Priorities**



#### VOTING

Promote equal access to voting and ensure all votes are counted. Iowa should adopt automatic voter registration and pass a constitutional amendment allowing Iowans with felony convictions to vote after time served.



#### **TRANSPARENCY**

Demand government accountability and transparency by requiring all amendments and bills discussed in committee to be available to the public prior to a vote. Encourage direct citizen participation by continuing virtual committee and subcommittee meetings.



### **EDUCATION**

Keep public money in public schools, fully fund public schools, and continue to expand access to affordable childcare.

#### REPRODUCTIVE RIGHTS

Guarantee access to the full range of women's reproductive health services, make contraception available without prescription, and ensure Medicaid services are comprehensive and accessible.



#### **HUMAN TRAFFICKING**

Prevent human trafficking in all of its forms, support its victims, and enact "Safe Harbor" legislation to protect human trafficking survivors from criminal prosecution.



#### **ENVIRONMENT**

Increase funding for environment and water quality initiatives, including REAP, and develop state climate change strategies.
