## LWVJC Annual Meeting May 23

Our guest speaker for the LWVJC 2023 Annual Membership Meeting is Chris Jones, Ph.D., who will present *Ethanol Must Die*. He places the production of corn ethanol within the historical contexts of Iowa agriculture and water quality, and details how the demise of ethanol is likely necessary if the environmental condition here in Iowa is to be improved.

Dr. Jones recently retired from the University of Iowa where he worked as a research engineer at the Iowa Institute of Hydraulic Research (IIHR) Hydroscience and Engineering studying water quality in agricultural landscapes. Previously, he worked at the Iowa Soybean Association and the Des Moines Water Works. He has authored or co-authored 50 scientific journal articles, three book chapters, and is the author of a newly-released book, *The Swine Republic*.

Dr. Jones is a frequent guest on Iowa Public Radio and has appeared on NPR's *On Point*. Dr. Jones has a BA in chemistry and biology from Simpson College in Indianola, and a Ph.D. in analytical chemistry from Montana State



University. He lives in Iowa City and DeSoto, Wisconsin.

## Advocacy Update

The flowers are blooming, the trees are developing leaves, and the fields are almost warm enough to plant. That means, in Advocacy terms, the legislative session is coming to a close. And it couldn't happen soon enough.

Not everything is doom and gloom. Our legislature has produced a steady trickle of noncontroversial, bipartisan, boring legislation that keeps the state functioning. For example, we expect a milquetoast amendment to appear on our ballots soon aligning the Iowa Constitution with the federal Constitution setting the voting age at 18. Similarly, Iowa's adoption tax credit went up, teacher licensing became easier for those with advanced degrees, and many other ignorable laws were passed. Further, some bad ideas that we were watching appear to be dead – at least for this year. Those include bills to restore the death penalty, further politicize judicial nominations, eliminate Iowa's requirement that public boards and commissions attempt gender balance and more.

But there's no denying that this session has been a sorrowful one for democracy in Iowa. The press is still banished from the Senate floor. An extremely unorthodox procedure was contrived to avoid deliberative budget processes so the school vouchers bill could pass. Minority party amendments are rejected out of hand. Majority lawmakers neither show up to legislative forums nor, recently, even accept questions from the minority, and a bill to disarm the State Auditor just passed the House. And that doesn't even touch the bills that were

passed or proposed to target minority Iowans. The sky is not falling, but we must not kid ourselves: Iowa's lawmakers are not following or respecting democratic norms, and they are not using democratic processes designed to make good decisions. They may be serving *some* people, but they are not serving *the* people.

In these circumstances, the advocacy committee has focused on opposing or limiting the damage of some of these bills, creating tools to help Iowans follow the legislative process, and considering how we can be effective during the legislative off-season. Members of the committee continued to improve instructions for following legislation. Some bills that we have been watching and acting on include the education "reform" bill, a women's health bill, the public benefits bill (SNAP), a new election bill, and child labor bills. And, finally, when the session ends, we expect to close out the season as usual with a gathering to celebrate and commiserate and move on to discussing public advocacy.

## Voter Registration

Happy May everyone! We are ramping up voter registration activities with our first voter registration event of the year scheduled on April 28 at Kirkwood's Celebration of Civic Engagement event. We are also currently scheduled to visit the Iowa City CommUnity Food Pantry on Monday, May 22, and Wednesday, May 24, from noon – 4 p.m. to register voters there, and on Tuesday, May 30, we will be at the Coralville Community Food Pantry's new facility from 2 – 6 p.m.

Looking ahead, June also looks to be a busy month for voter registration. We will be at the Iowa Arts Festival in downtown Iowa City on Saturday, June 3, (stop by and see us if you are at the festival that day – we will be there until 6 p.m.). We are also trying to coordinate voter registration at the high school graduation rehearsals for Iowa City Liberty, West, and City High on Friday, June 2, at Xtreme Arena. And dates are being set for a second visit to the Coralville Community Food Pantry and the North Liberty Community Pantry.

As the events are finalized, the details and sign-up information will be sent to the Voter Registration Committee members. Not a member and want to help? Just send me an email (my email is on page 1 of this *Voter*) and I can add you to the notification list.

Before I sign off, did you see that over 500,000 Iowans had their voter status changed to "Inactive" last month? What does this mean? Registered voters who did not participate in the 2022 General Election were made *Inactive*. Voters who were inactivated should have received a postcard notice in the mail. Responding to the notice (checking the appropriate box, signing their name, and returning the card) will return these voters to *Active* status. Any voter on Inactive status can also be returned to Active by requesting an absentee ballot for an election, voting in an election, submitting a new voter registration, or updating their voter registration before the end of the 2026 general election cycle. ## Program Planning\*\*

### Vote to approve was taken by LWVJC members in June 2022.

The League believes accurate voting information should be available to all eligible voters. VOTE411 provides important information to register voters online, based on their home address, obtain ballot and candidate information, districts, races, and voting locations. To accurately identify locations and avoid mapping distortion the League's VOTE411 mapping system should be updated using GIS, Geographic Information System, a spacial system that is used to create, manage, analyze and map data and provide reliable mapping to offer voters accurate information. The Google mapping system currently used alters important locations and information. Local 911 Emergency personnel seek a similar localized system to accurately map addresses. Combining efforts may expedite a study process. *The LWVJC membership voted to approve the proposal in June 2022. This proposal will be added to the LWVIA Convention agenda for consideration of a statewide study.*

The League believes that all governments and public entities within Johnson County should adopt and follow sound fiscal policies including procurement functions. Procurement should be transparent and accountable and identify a specific dollar limit that requires consistent bidding practices of purchases for public entities. The practices of four local governments were reviewed and staff interviewed for the communities of Coralville, North Liberty, Tiffin and Johnson County. Purchasing practices and procedures for each entity were investigated and reviewed for adherence and compared to best practices and state law. The League recommends that all governments and public entities review procurement practices to determine transparency and accountability to achieve and ensure a sound fiscal policy is followed. To address accountability, the League supports and recommends undertaking a comprehensive review. The aim of such efforts would ensure transparency and provide residents the confidence that fairness is achieved. *This proposal will be added to the LWVJC Policies and added to the LWVIA Convention agenda for consideration of a statewide study.*
