As your new Vice President for Programs and Action it is my pleasure to welcome new and returning members and other interested folks to the 2018–2019 season of programs by the League of Women Voters of the Clemson Area. Although some meeting arrangements are still tentative, I think we have an interesting collection of topics in the works.

August 21 is the League's annual celebration of Women's Equality Day, celebrating the anniversary of passage of the 19th Amendment to the Constitution on Aug. 26, 1920, giving women the right to vote. We are working hard to finalize the program for that meeting.

Because 2018 is an election year, we have several election-related events planned. The September 18 and October 16 general meetings will be devoted to election issues. In addition, throughout October the League will conduct candidate forums for federal, state, and local offices.

The third Tuesday in November is in Thanksgiving week, so our November meeting will take place on November 13 instead. That will be the first meeting after the election, and we plan to invite our newly elected and re-elected state legislative delegation for an open forum.

December is the time for the annual holiday party, date TBA. Topics under consideration for next winter and spring include the environment, artificial intelligence, immigration, and gun safety. For the annual meeting we plan to include some stories of the impact that the League has had on issues that matter.

## Annual Meeting

### **What is the Role of Ceremonial Vegetables?**

Who would've imagined that "ceremonial vegetables" would be featured in the Annual Meeting of LWVCA? About sixty League members and guests gathered at Occasions at Wedgefield on May 8 to celebrate the accomplishments of the past year, to celebrate our contributions to the past 50 years, to examine whether we are "doing enough", and to lay the groundwork for our upcoming year.

A business session followed a reception and dinner. Among the highlights of the business meeting were the election of new officers and members of the Board of Directors. Those elected were Co-Presidents Ansley Fraser ('18-19) and Fran Rundlett ('18-20), VP Program and Action Matt Saltzman, Secretary Janet Scott, Directors Cheryl Lee, Janet Marsh, Catherine Farris, Cece Parker, Mike Ellison, Ruth Reed. Following her report on behalf of the Nominating Committee, Elizabeth Adams bestowed "ceremonial vegetables" upon the newly elected leaders in recognition of their commitment to help the organization grow.

Other business items of note:

- the creation of the Dianne Haseleton Community Service Award in recognition of Dianne's valuable role as League member and leader. The first winner will be announced at next year's Annual Meeting
- reduction of dues for student members
- adoption of a by-laws amendment increasing the size of the LWVCA Board
- adoption of a proposed study relating to number of seats on the Pickens County Council

The five charter members of LWVCA, Eleanor Hare, Berniece Holt, Ellen Reneke, Ada Lou Steirer and Holley Ulbrich were recognized for their role in creating the League of Women Voters of the Clemson Area fifty years ago. They were given a certificate from the President of LWVUS awarding them life membership in LWV.

The keynote presentation was given by Brookes Brown, PhD, JD, Director of the Law, Liberty and Justice Program at Clemson University. She challenged members to ask themselves "Am I Doing Enough?" as we examine our individual role participating in, and contributing to, the democratic process.

## Reports

### **Reflections on State Council**

On Saturday, June 28, Ansley Fraser, Fran Rundlett, Ashley Levesque, Bill Hare and Eleanor Hare attended LWVSC State Council in Columbia. State Council is a gathering between the convention years to approve the annual budget, hear speakers, get recharged, and share ideas and network with other Leagues. Morning speakers were professor Bob Oldendick of USC, who discussed campaign funding and handicapped the upcoming June primaries. The second speaker was former Senator Joel Lourie, who shared his thoughts on re-districting. Afternoon workshop sessions included voting issues, a local presidents' roundtable, issue-based program ideas, voter service, membership retention and engagement, and nuclear waste issues at the Savannah River Plant. Your new presidents, Fran and Ansley, gathered lots of good ideas as they were preparing to take on their leadership roles.

### **Better Angels: An Initiative to “Heal the Divide” Moves Forward**

*Healing the Divide*, the topic of the April Membership meeting, is drawing interest from a broader segment of the community. Presenting the topic to the League in April was League member Shari Jung. She has spent considerable time researching and engaging in projects intended to reduce political polarization among citizens, or, healing the divide.

The project Shari has suggested developing in this area is “Better Angels,” a bipartisan citizens’ movement launched in 2016 to reduce political polarization in the US. Better Angels is bringing liberals and conservatives together to understand each other beyond stereotypes through a growing number of community-based Better Angels projects across the country.

On June 15, 27 people gathered at OLLI to learn more about Better Angels. This follow-up meeting was encouraged by the positive response from League members in April. Shari, and co-organizers Linda Law and Janet Marsh, were delighted by the interest and level of commitment expressed by many in the group.

A skills training session was held on July 14 for all interested in the skills and commitment we will need to launch a successful project in the Clemson area. If you have questions, comments, want to join or stay informed as the project develops, please contact Shari Jung, 214.780.0220.

## National Convention

### IMPRESSIONS OF MY FIRST LWVUS CONVENTION

Starting on Thursday, June 28, the League of Women Voters of the United States 53rd convention was packed with conversations containing helpful information sessions, political humor, and friendship engagement zones. Included were relevant topics and workshops given by experts in the field. The usual business of the convention was peppered with great speakers and enough time to meet new friends and swap ideas.

Several information sessions gave new ideas on voter service that we will be able to use locally. Also, related to this was an informative conversation on redistricting, organizing and mobilizing voters, raising money for voter service, using social media to inform voters, and other political engagement activities. One of my favorite was “Beyond Youth--Empowering Generation Z.” This session, if put to use, will help our League move beyond just student registration to student engagement for our future voters.

Some programs were directly related to our theme--Creating a More Perfect Democracy. In addition to the aforementioned redistricting/gerrymandering conversations, we received valuable insight on immigration and refugee advocacy, open primaries, ideas on abolishing the Electoral College, climate change, gun safety, working at the United Nations, fostering civility and respect in our divided democracy, lowering the voting age, and healthcare in a democracy. Particular emphasis was placed on the resurgence of the Equal Rights Amendment to the constitution and the National Popular Vote movement.

We heard many great speakers but two come to mind: Rosie Rios, the 43rd Treasurer of the United States, and Elaine Weiss, author of *THE WOMAN'S HOUR: THE GREAT FIGHT TO WIN THE VOTE*. Rios pointed out many inequities she observed as a child--no pictures of females on our money and very few statues of female role models for young girls. She told of her work to right these wrongs. Weiss' book is a history of the women's suffrage movement and she, too, gave a rousing speech that made us want to work harder for a more perfect democracy.

Perhaps you will consider attending this thought-provoking convention in two years in Washington, D.C.
