### LWVC CONVENTION Report - Ann Pentecost, Incoming President

C ate White and I had the privilege of representing our League at the LWVC Annual Convention in Bakersfield May 18 to 20.

We earrived by Amtrak, checked into the hotel and were ready to attend the 3:30 workshop on Friday afternoon. We were on the run continually throughout the weekend. The workshops, caucuses, and plenary sessions were non stop except for the meal breaks. Even so, we found time to visit with League members from around the state and both of us came home with many good ideas we hope to make use of during the coming year. **Our league also came away with an Action Award honorable mention for the Measure K/Transportation Study last year.** 

The speakers were all memorable. Debra Bowen, California Secretary of State was the luncheon speaker on Saturday. She spoke on a number of election and voting issues her office is dealing with and changes she hopes to make. Dolores Huerta was the dinner speaker. She is a very impressive women and gave an impassioned speech. Among other things, she urged us to reach out to under represented voters around the state. At the luncheon on Sunday, Trudy Schafer, LWVC Staff Program Director and Advocate reported on the League's work with the legislature.

f all the impressive speakers, the highlight was definitely the remarks of the incoming President of the LWVC, Janis Hirohama. She is an attorney with expertise in voting rights, criminal law and fairness education. She has been active in her local league, served on the state board as Secretary and served on the LWVUS Board of Directors--two years as a board member and two years as First Vice President. She is the first women of color to serve as the LWVC President and will be an effective and articulate spokesperson for the League.
