Meeting at Mary Lois and Syd Thompson's home on January 15th, 20 LWVSJC members came up with recommendations for local and state programs for the coming year.

At the local level, we will continue educating and advocating for passage of SB810, Single Payer Health Care. Members also want to educate citizens about the effects on San Joaquin County of federal health care reform.

Members also expressed concern about the impact of Governor Brown's proposed government restructuring on delivery and financing of services at the local level. In particular, members mentioned the impact on

- Calworks
- Redevelopment

# Not a pretty picture

In a January press release. LWVC President Janis Hirohama summarized the state League's reaction to Governor Brown's budget proposal: "It's about time that we have a budget that works towards long-term solutions, rather than relying on one-time fixes and accounting *gimmicks.* This budget faces up to the reality of California's structural deficit. California taxpayers want to be dealt with honestly and forthrightly.

"The picture painted by the governor's budget isn't pretty, but it is an honest one."

Echoing our own local concerns, LWVC's statement noted that "Local governments differ in their ability or willingness to approve local taxes for services, which could mean distinct and perhaps inequitable differences in how well local funding would responsibility for providing services.

Many members also expressed support for environmental education and advocacy, including "Emerald Valley" and green jobs initiatives.

LWVSJC sent a recommendation to the state league for an update on the LWVC position on public libraries. We asked LWVC to address the issue of privatizing public library systems.
