Voter Services Expands League Reach Online

As we prepare this issue of The Voter for publication, LWVSJC is heavily involved in a very busy election season.

With eleven initiatives on the November 2012 ballot, many community groups have requested Pros & Cons presentations. In addition to doing these in person for over 500 people, we are for the first time making a Pros & Cons presentation available online by link from our website, in a video produced by LWV Cupertino-Sunnyvale.

In addition, LWVSJC has organized candidate forums for a variety of races. With Cal State University Stanislaus,

With University of the Pacific, the League co-sponsored forums for the 9th Congressional District (McNerney/Gill), the 13th Assembly District (Eggman/Jafri), and several Stockton City Council races, including the race for mayor. Many League members have participated in bringing these voter service events to residents of San Joaquin County. Sylvia Kothe Memorial Scholarship Fund **Established**

The LWVSJC Board of Directors has established a scholarship trust fund in memory of Sylvia Kothe with a scholarship to be administered by the Financial Aid Office at San Joaquin Delta College. Each year, \$200 will be awarded to a Delta College student for use toward the continuation of his or her academic goal.

The student must be a resident of San Joaquin County and must have completed units required to transfer to a four-year institution with a minimum 3.0 GPA. A League scholarship committee will review applications.

Kick-off Meeting Looks at Farm Policy

Kari Hamerschlag of the Environmental Working Group and local Fresh Edibles farmer Bob Whitaker spoke about federal farm policy at this year's kick-off meeting at Delicato Winery.

Currently, the federal Farm Bill heavily favors commodity crops such as cotton, corn, and soybeans, providing them with subsidies and crop insurance and putting farmers who grow fruit and vegetables at a comparative disadvantage. (An interesting aspect of commodity crops is that many use genetically modified organisms, or GMOs – the subject of Proposition 37 on the November ballot, which seeks labeling of GMO products.)

Despite the importance of California agriculture to the state and the nation, only two California representatives serve on the 45-member House Committee on Agriculture, which oversees the Farm Bill. Hamerschlag recommended that regardless of who wins the local congressional seat, he should be encouraged to join this committee.

This cutting-edge update of the League's award-winning service sports a new streamlined look and an array of feature stories that changes every day. The many enhanced features are especially helpful for the quick information needs and small touch screens of smartphone and tablet owners -- but promise to be fun and interesting for desktop and laptop computer users as well. Get together with your friends and compare the appearance of the Next Generation site – its exact layout will depend on the size of the screen and type of device each of you is using.

Announced at last year's state League Convention in Ventura and years in planning, the Next Generation site addresses dramatic changes in the way that the public now accesses and uses information on the Internet. According to national market analyses and surveys, a majority of the computer devices now being purchased are smartphones and tablets rather than desktop or laptop computers, and a rapidly-increasing proportion of voters are relying primarily on such mobile devices to get information on politics and elections.

For this November's election, Smart Voter will be available to California voters in both its traditional format and the new Next Generation design. LWVSJC to begin Initiative and Referendum Study

At the May 2011 LWVC Convention, delegates adopted a study to update the state League's position on the Initiative and Referendum process, last updated in 1999. LWVC supports citizens' right of direct legislation through the initiative and referendum process but will be seeking consensus on possible reforms, including

- Leveling the imbalance of money interests
- Increasing transparency
- Engaging citizens
- Restructuring the process
- Making better use of technology

The LWVSJC study meeting will be held Saturday morning, November 17, at the Central United Methodist Church, 3700 Pacific Avenue in Stockton. Refreshments will be available beginning at 9 a.m.
