Editor's Note:

Last week, during the early voting period in Texas, poll workers arrived to find a candidate's political campaign sign blocking the "Vote Here" sign used to direct voters to the polling place. Someone had zip tied it on during the night. A precinct official asked a volunteer to go out and remove it. The poll worker came back with bloodied fingers. The sign had box cutter blades attached all along the bottom of it, with the obvious intent of injuring anyone attempting to remove it.

While reading about this incident, I scrolled to the bottom of the article to read the comments. Rather than simply condemning the incident for the malicious act it was, people were saying that the *opposing* candidate's supporters had in fact placed the sign to generate bad publicity for *their* candidate.



During this election, the limits of decency have been exceeded. There are words that have been spoken that can't be taken back. Friendships, and even family relationships have been strained. By the time you are reading this, it will be over, and nearly half of the country will have a President that they despise. What happens now? How do we mend those fences?

On October 12th, #RepealThe19th was trending on Twitter. Women responded on Halloween by making Suffragist costumes a popular choice. On Election Day, so many women went to the gravesite of Susan B. Anthony to place their "I Voted!" stickers on her tombstone that the cemetery had to extend its hours.

At a time where there is very little faith in government and political organizations, and also in the media, the League of Women Voters remains one of the most trusted organizations in the nation. The time is ripe to grow our ranks. Our mission of Making Democracy work is now more important than ever.

LWV of Michigan Government Finance Study Consensus Questions

The consensus questions are organized in three sections: state revenue, state expenditures and state/local fiscal relationships.

State Revenue

- 1) Should LWVMI support measures to ensure revenues that are both sufficient and flexible to meet changing needs for state and local government services?
- 2) Should there be provisions in place to relieve the income and property tax burdens on low income citizens?
- 3) Should safeguards (such as Earned Income Tax Credit) be in place to protect against "regressiveness" of sales and use taxes?
- 4) Should the state impose a sales tax on more services?
- 5) Should "nuisance taxes" (liquor, cigarettes, etc.) be regularly adjusted for inflation?
- 6) Should businesses pay their share of the income, sales and property taxes for services and benefits they use?
- 7) Should business tax credits be reviewed on a regular basis to see if they are achieving their purpose?
- 8) Should the state maximize the use of federal funds to increase revenue for state and local programs?
- 9) Should the impact of fees on low-income residents be considered when establishing the amount of the fee?
- 10) Should transportation taxes and fees be used to pay for maintenance and building of roads and mass transit?
- 11) Should transportation taxes and fees on fuel be indexed to inflation?
- 12) Should hybrid and electric vehicle users pay their fair share of transportation funding?

State Expenditures

- 13) Should the legislative and executive branches of government have equal responsibility for allocating the state's resources?
- 14) Should the proposal, adoption and administration of the state budget be transparent and accessible to residents throughout the appropriations process?
- 15) Should the budget process emphasize performance and outcomes and incorporate accountability through annual executive department evaluation?
- 16) Should Michigan's budget process include a budget review committee in the legislature, supported by a legislative staff similar to the federal Congressional Budget Office?
- 17) Should tax expenditures (exemptions and credits) be reviewed periodically by the legislature?
- 18) Should the distribution of revenue ensure adequate, equitable and flexible funding of public programs?

State/Local Fiscal Relationships

- 19) Should Michigan provide the funding when it requires local units to provide specific services?
- 20) Should the authorized amount of state statutory revenue sharing funds be provided by the state?
- 21) Should local units of government have more options for offsetting the loss of property taxes for tax exempt properties?
- 22) Should local units periodically reappraise the impact of property tax exemptions?

Former State Representative and long-time League member Jan Dolan, passed away on November 1, 2016.

Jan served on the Farmington Hills City Council for 14 years, 2 terms as the Mayor of Farmington Hills, and as a State Representative for 8 years including speaker pro-tem in 1993-94. In the House, Jan was known for being able to negotiate across the aisle. She once said, "I'm an optimist that hopes that everyone works for the betterment of their entire state, not just their little jurisdiction."

Jan joined the League of Women Voters more than 40 years ago, serving in a variety of ways, mainly Voter Service. She was a formidable woman with an adventurous spirit who, on her 85th birthday, went skydiving – something she said was on her bucket list. Her community commitment will be missed by all.

A memorial service will be held at 2 p.m. on November 12, at First Presbyterian Church of Farmington, 26165 Farmington Road, Farmington Hills.

REMEMBERING WHY WE DO WHAT WE DO:

The Declaration of Sentiments and Resolutions was drafted by Elizabeth Cady Stanton for the women's rights convention at Seneca Falls, New York in 1848.

“When, in the course of human events, it becomes necessary for one portion of the family of man to assume among the people of the earth a position different from that which they have hitherto occupied, but one to which the laws of nature and of nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes that impel them to such a course.

We hold these truths to be self-evident: that all men and women are created equal; that they are endowed by their Creator with certain inalienable rights; that among these are life, liberty, and the pursuit of happiness; that to secure these rights governments are instituted, deriving their just powers from the consent of the governed. Whenever any form of government becomes destructive of these ends, it is the right of those who suffer from it to refuse allegiance to it, and to insist upon the institution of a new government, laying its foundation on such principles, and organizing its powers in such form, as to them shall seem most likely to effect their safety and happiness.

Prudence, indeed, will dictate that governments long established should not be changed for light and transient causes; and, accordingly, all experience has shown that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they were accustomed. But when a long train of abuses and usurpations, pursuing invariably the same object, evinces a design to reduce them under absolute despotism, it is their duty to throw off such government and to provide new guards for their future security. Such has been the patient sufferance of the women under this government, and such is now the necessity which constrains them to demand the equal station to which they are entitled.”
